On page 3, line 17, after "(1)" insert "The legislative recognizes 7 8 the airport's role as a major economic engine in the Puget Sound 9 region and the state of Washington now and in the future. The 10 legislature also recognizes that the airport's agenda for future 11 growth includes redevelopment of the airport concessions program. The 12 legislature finds that this growth and redevelopment create unique 13 opportunities to preserve and expand employment prospects and improve 14 job security for concessions employees, and also to meet conditions 15 and achieve minority- and women-owned business participation goals of 16 federal aviation administration and other federal programs. The 17 legislature therefore intends to establish labor and employment 18 standards for contractors and subcontractors, consistent with the 19 exclusion for disadvantaged business enterprises in section 1(6) of 20 this act. The legislature will review this exclusion when the 21 percentage of gross sales generated by minority- and women-owned 22 businesses is at least one hundred fifty percent of the 2011-14 of the airport with the federal 23 participation goal aviation 24 administration.

On page 8, after line 23, insert the following:
"(10) Subsections (2) through (9) of this section do not apply to airport concessionaire disadvantaged business enterprises certified by the office of minority and women's business enterprises, or contracts or subcontracts counted toward achieving the minority- and women-owned business participation goals of federal aviation administration and other federal programs."

<u>EFFECT:</u> Adds language: (1) recognizing the airport's role as a major economic engine and that the airport's agenda for future growth includes redevelopment of the airport concessions program; (2) finding that this growth and redevelopment creates opportunities to preserve and expand employment prospects and improve job security for concessions employees, and also to meet conditions and achieve minority- and women-owned business (MWB) participation goals of the Federal Aviation Administration and other federal programs; and (3) expressing legislative intent to establish labor and employment standards, consistent with the airport concessionaire disadvantaged business enterprise (ABCDE) exclusion.

Excludes ACDBEs from the notice, employment, and labor peace agreement requirements in the underlying bill (rather than contractors who employ less than 10 persons). Specifies that these requirements do not apply to contracts or subcontracts counted toward achieving the MWB participation goals of the Federal Aviation Administration and other federal programs. Specifies that the Legislature will review this exclusion when the percentage of gross sales generated by minority- and womenowned businesses is at least 150 percent of the 2011-14 participation goal.
