3 "NEW SECTION. **Sec. 1.** (1) The legislature finds that:

4 (a) The capital budget includes appropriations for the construction
5 and repair of public schools, colleges and universities, prisons and
6 juvenile rehabilitation facilities, state office buildings, housing for
7 low-income and disabled persons, farm workers and others, parks, public
8 infrastructure, and for other capital facilities and programs;

9 (b) The size of the capital budget is determined by the available
10 bond capacity under the constitutional debt limit and by moneys
11 available from dedicated accounts, trust revenue, and other funding
12 sources;

13 (c) Approximately half of the capital budget is financed with
14 state-issued general obligation bonds, which pledge the full faith,
15 credit and taxing power of the state toward payment of debt service;
16 and

17 (d) The capital budget has limited purpose if there is no bond
18 authorization bill to finance appropriations.

19 (2) The legislature therefore intends to increase the transparency
20 and clarity of the uses and sources of the capital budget for the 2011
21 supplemental and 2011-2013 fiscal biennium by combining in one bill the
22 authorization of state general obligation bonds with the appropriations
23 that they support.

24 NEW SECTION. **Sec. 2.** (1) A capital budget is hereby adopted and,
25 subject to the provisions set forth in this act, the several dollar
26 amounts hereinafter specified, or so much thereof as shall be
27 sufficient to accomplish the purposes designated, are hereby
28 appropriated and authorized to be incurred for capital projects during

1 the period beginning with the effective date of this act and ending
2 June 30, 2013, out of the several funds specified in this act.

3 (2) The appropriations in this act are appropriations for capital
4 purposes from proceeds of general obligation and other bonds.
5 Appropriations in this act may not necessarily represent all
6 expenditures authorized for a particular project for the 2011-2013
7 fiscal biennium. For some projects receiving appropriations in this
8 act, additional appropriations from other sources for those projects
9 may also be contained in chapter, Laws of 2011 (House Bill No.
10 1497).

11 (3) The definitions in this subsection apply throughout this act
12 unless the context clearly requires otherwise.

13 (a) "Fiscal year 2012" or "FY 2012" means the period beginning July
14 1, 2011, and ending June 30, 2012.

15 (b) "Fiscal year 2013" or "FY 2013" means the period beginning July
16 1, 2012, and ending June 30, 2013.

17 (c) "Lapse" or "revert" means the amount shall return to an
18 unappropriated status.

19 (d) "Provided solely" means the specified amount may be spent only
20 for the specified purpose.

21 (4) Amounts appropriated for fiscal year 2012 may be expended from
22 July 1, 2011, through June 30, 2013. Amounts appropriated for fiscal
23 year 2013 may only be expended from July 1, 2012, through June 30,
24 2013.

25 (5) Unless otherwise specifically authorized in this act, any
26 portion of an amount provided solely for a specified purpose that is
27 not expended subject to the specified conditions and limitations to
28 fulfill the specified purpose shall lapse.

29 (6) The amounts shown under the headings "Prior Biennia," "Future
30 Biennia," and "Total" in this act are for informational purposes only
31 and do not constitute legislative approval of these amounts. "Prior
32 biennia" typically refers to the immediate prior biennium for
33 reappropriations, but may refer to multiple biennia in the case of
34 specific projects. A "future biennia" amount is an estimate of what
35 may be appropriated for the project or program in the 2011-2013
36 biennium and the following three biennia; an amount of zero does not
37 necessarily constitute legislative intent to not provide funding for
38 the project or program in the future.

1 (7) "Reappropriations" in this act are appropriations and, unless
2 the context clearly provides otherwise, are subject to the relevant
3 conditions and limitations applicable to appropriations.
4 Reappropriations shall be limited to the unexpended balances remaining
5 on June 30, 2011, from the 2009-2011 biennial appropriations for each
6 project.

2 **BOND AUTHORIZATION**

3 NEW SECTION. **Sec. 6001.** For the purpose of providing funds to
4 finance the school construction assistance grant program described and
5 authorized by the legislature in the capital and operating
6 appropriations acts for the 2011-2013 fiscal biennium, and all costs
7 incidental thereto, the state finance committee is authorized to issue
8 general obligation bonds of the state of Washington in the sum of three
9 hundred ninety-three million six hundred twenty-nine thousand dollars,
10 or as much thereof as may be required, to finance these projects and
11 all costs incidental thereto. Bonds authorized in this section may be
12 sold at such price as the state finance committee shall determine. No
13 bonds authorized in this section may be offered for sale without prior
14 legislative appropriation of the net proceeds of the sale of the bonds.

15 NEW SECTION. **Sec. 6002.** (1) The proceeds from the sale of the
16 bonds authorized in section 6001 of this act shall be deposited in the
17 state building construction account created by RCW 43.83.020. The
18 proceeds shall be transferred as follows: Three hundred eighty-nine
19 million seven hundred thirty-one thousand dollars to remain in the

2 **MISCELLANEOUS PROVISIONS**

3 NEW SECTION. **Sec. 7001.** (1) Allotments for appropriations in this
4 act shall be provided in accordance with the capital project review
5 requirements adopted by the office of financial management and in
6 compliance with RCW 43.88.110. Projects that will be employing
7 alternative public works construction procedures under chapter 39.10
8 RCW are subject to the allotment procedures defined in this section and
9 RCW 43.88.110.

10 (2) Each project is defined as proposed in the legislative budget
11 notes or in the governor's budget document.

12 NEW SECTION. **Sec. 7002.** To ensure that major construction
13 projects are carried out in accordance with legislative and executive
14 intent, appropriations in this act in excess of \$5,000,000 shall not be
15 expended or encumbered until the office of financial management has
16 reviewed and approved the agency's predesign. The predesign document
17 shall include but not be limited to program, site, and cost analysis in
18 accordance with the predesign manual adopted by the office of financial
19 management. To improve monitoring of major construction projects,
20 progress reports shall be submitted by the agency administering the
21 project to the office of financial management and to the fiscal
22 committees of the house of representatives and senate. Reports will be
23 submitted on July 1st and December 31st each year in a format to be
24 developed by the office of financial management.

25 NEW SECTION. **Sec. 7003.** (1) To ensure minor works appropriations
26 are carried out in accordance with legislative intent, funds
27 appropriated in this act shall not be allotted until project lists are
28 on file at the office of financial management, the house of
29 representatives capital budget committee, and the senate ways and means
30 committee. All projects must meet the criteria included in subsection
31 (2)(a) of this section. Revisions to the lists must be filed with the
32 office of financial management, the house of representatives capital

1 budget committee, and the senate ways and means committee and include
2 an explanation of variances from the prior lists before funds may be
3 expended on the revisions.

4 (2)(a) Minor works projects are single line appropriations that
5 include multiple projects of a similar nature and that are valued
6 between \$25,000 and \$1,000,000 each, with the exception of higher
7 education minor works projects that may be valued up to \$2,000,000.
8 These projects can generally be completed within two years of the
9 appropriation with the funding provided. Agencies are prohibited from
10 including projects on their minor works lists that are a phase of a
11 larger project, and that if combined over a continuous period of time,
12 would exceed \$1,000,000, or \$2,000,000 for higher education minor works
13 projects. Improvements for accessibility in compliance with the
14 Americans with disabilities act may be included in any of the above
15 minor works categories.

16 (b) Minor works appropriations shall not be used for, among other
17 things: Studies, except for technical or engineering reviews or
18 designs that lead directly to and support a project on the same minor
19 works list; planning; design outside the scope of work on a minor works
20 list; moveable, temporary, and traditionally funded operating equipment
21 not in compliance with the equipment criteria established by the office
22 of financial management; software not dedicated to control of a
23 specialized system; moving expenses; land or facility acquisition; or
24 to supplement funding for projects with funding shortfalls unless
25 expressly authorized elsewhere in this act. The office of financial
26 management may make an exception to the limitations described in this
27 subsection (2)(b) for exigent circumstances after notifying the
28 legislative fiscal committees and waiting ten days for comments by the
29 legislature regarding the proposed exception.

30 (c) Minor works preservation projects may include program
31 improvements of no more than twenty-five percent of the individual
32 minor works preservation project cost.

33 (3) It is generally not the intent of the legislature to make
34 future appropriations for capital expenditures or for maintenance and
35 operating expenses for an acquisition project or a significant
36 expansion project that is initiated through the minor works process and
37 therefore does not receive a policy and fiscal analysis by the

1 legislature. Minor works projects are intended to be one-time
2 expenditures that do not require future state resources to complete.

3 NEW SECTION. **Sec. 7004.** (1) The office of financial management
4 may authorize a transfer of appropriation authority provided for a
5 capital project that is in excess of the amount required for the
6 completion of such project to another capital project for which the
7 appropriation is insufficient. No such transfer may be used to expand
8 the capacity of any facility beyond that intended in making the
9 appropriation. Such transfers may be effected only between capital
10 appropriations to a specific department, commission, agency, or
11 institution of higher education and only between capital projects that
12 are funded from the same fund or account. No transfers may occur
13 between projects to local government agencies except where the grants
14 are provided within a single omnibus appropriation and where such
15 transfers are specifically authorized by the implementing statutes that
16 govern the grants.

17 (2) The office of financial management may find that an amount is
18 in excess of the amount required for the completion of a project only
19 if: (a) The project as defined in the notes to the budget document is
20 substantially complete and there are funds remaining; or (b) bids have
21 been let on a project and it appears to a substantial certainty that
22 the project as defined in the notes to the budget document can be
23 completed within the biennium for less than the amount appropriated in
24 this act.

25 (3) For the purposes of this section, the intent is that each
26 project be defined as proposed to the legislature in the governor's
27 budget document, unless it clearly appears from the legislative history
28 that the legislature intended to define the scope of a project in a
29 different way.

30 (4) The office of financial management shall report any transfer
31 effected under this section to the house of representatives capital
32 budget committee, the senate ways and means committee, and the
33 legislative evaluation and accountability program committee, at least
34 thirty days before the date the transfer is effected. The office of
35 financial management shall report all emergency or smaller transfers
36 within thirty days from the date of transfer. The governor's capital

1 budget request following any transfer shall reflect that transfer in
2 the affected agency.

3 NEW SECTION. **Sec. 7005.** (1) It is expected that projects be ready
4 to proceed in a timely manner depending on the type or phase of the
5 project or program that is the subject of the appropriation in this
6 act. Except for major projects that customarily may take more than two
7 biennia to complete from predesign to the end of construction, or large
8 infrastructure grant or loan programs supporting projects that often
9 take more than two biennia to complete, the legislature generally does
10 not intend to reappropriate funds more than once, particularly for
11 smaller grant programs, local/community projects, and minor works.

12 (2) Agencies shall expedite the expenditure of reappropriations and
13 appropriations in this act in order to: (a) Rehabilitate
14 infrastructure resources; (b) accelerate environmental rehabilitation
15 and restoration projects for the improvement of the state's natural
16 environment; (c) reduce additional costs associated with acquisition
17 and construction inflationary pressures; and (d) provide additional
18 employment opportunities associated with capital expenditures.

19 (3) To the extent feasible, agencies are directed to accelerate
20 expenditure rates at their current level of permanent employees and
21 shall use contracted design and construction services wherever
22 necessary to meet the goals of this section.

23 NEW SECTION. **Sec. 7006.** State agencies, including institutions of
24 higher education, shall allot and report full-time equivalent staff for
25 capital projects in a manner comparable to staff reporting for
26 operating expenditures.

27 NEW SECTION. **Sec. 7007.** Executive Order No. 05-05, archaeological
28 and cultural resources, was issued effective November 10, 2005.
29 Agencies and higher education institutions shall comply with the
30 requirements set forth in this executive order.

31 NEW SECTION. **Sec. 7008. PUGET SOUND PROTECTION AND RESTORATION**
32 Consistent with RCW 90.71.340, when expending appropriations under
33 this act that contribute to Puget Sound protection and recovery,
34 agencies shall consult with the Puget Sound partnership to ensure that

1 projects and expenditures are either in, or consistent with the 2020
2 action agenda. These consultations shall include the exchange of
3 information on specific actions, projects, associated funding,
4 performance measures, and other information necessary to track project
5 implementation and ensure alignment with the action agenda. In
6 situations where the Puget Sound partnership finds that a project is
7 not in, or is not consistent with the action agenda Puget Sound
8 partnership shall document this finding and report back to the governor
9 and legislative fiscal committees.

10 NEW SECTION. **Sec. 7009. FOR THE ARTS COMMISSION--ART WORK**
11 **ALLOWANCE POOLING**

12 (1) One-half of one percent of moneys appropriated in this act for
13 original construction of school plant facilities may be expended for
14 the purposes of RCW 28A.335.210. The Washington state arts commission
15 may combine the proceeds from individual projects in order to fund
16 larger works of art or mobile art displays in consultation with the
17 superintendent of public instruction and representatives of school
18 district boards.

19 (2) One-half of one percent of moneys appropriated in this act for
20 original construction or any major renovation or remodel work exceeding
21 two hundred thousand dollars by colleges or universities may be
22 expended for the purposes of RCW 28B.10.027. The Washington state arts
23 commission may combine the proceeds from individual projects in order
24 to fund larger works of art or mobile art displays in consultation with
25 the board of regents or trustees.

26 (3) One-half of one percent of moneys appropriated in this act for
27 original construction of any public building by a state agency as
28 defined in RCW 43.17.020 may be expended for the purposes of RCW
29 43.17.200. The Washington state arts commission may combine the
30 proceeds from individual projects in order to fund larger works of art
31 or mobile art displays in consultation with the state agency.

32 (4) At least eighty-five percent of the moneys spent by the

19 percent salary reduction effective July 1, 2011, through June 29, 2013,
20 for all employees of the executive, legislative, and judicial branches,
21 including those employees in the Washington management service, and
22 including employees exempt from merit system rules, except for:

23 (a) Elected officials whose salaries are set by the commission on
24 salaries for elected officials;

25 (b) Student employees at state institutions of higher education;

26 (c) Faculty employees at state institutions of higher education:
27 PROVIDED, HOWEVER, That appropriations to higher education institutions
28 are reduced in an amount reflecting a 3.0 percent reduction in faculty
29 salary expenditures;

30 (d) Certificated employees of the state school for the blind and
31 the center for childhood deafness and hearing loss;

32 (e) Commissioned officers of the Washington state patrol
33 represented by the state patrol troopers' association and the
34 Washington state patrol lieutenants' association;

35 (f) Represented ferry workers of the Washington state department of

1 transportation, provided, however, that other reductions are included
2 in section 504 of the 2011-2013 transportation appropriations act;

3 (g) Employees whose salary is less than \$2,500 per month; and

4 (h) Employees as specified in subsection (2) of this section.

5 (2) For employees subject to the 3.0 percent reduction in salary
6 under subsection (1) of this section employees will receive temporary
7 salary reduction leave of up to 5.2 hours per month. The director of
8 personnel shall adopt rules governing the accrual and use of temporary
9 salary reduction leave.

10 (3) The department of retirement systems shall include any forgone
11 salary or lost work hours under subsections (1) and (3) of this section
12 in the final average compensation of employees affected for purposes of
13 calculating retirement benefits, as specified in executive request
14 legislation Z-0211.1/11.

15 (4) The appropriation from dedicated funds and accounts shall be
16 made in the amounts specified and from the dedicated funds and accounts
17 specified in office of financial management document 2011-01, which is
18 hereby incorporated by reference. The office of financial management
19 shall allocate the moneys appropriated in this section in the amounts
20 specified and to the state agencies specified in office of financial
21 management document 2011-01 and adjust appropriation schedules
22 accordingly.

23 NEW SECTION. **Sec. 7013.** If any provision of this act or its
24 application to any person or circumstance is held invalid, the
25 remainder of the act or the application of the provision to other
26 persons or circumstances is not affected.

27 NEW SECTION. **Sec. 7014.** This act is necessary for the immediate
28 preservation of the public peace, health, or safety, or support of the
29 state government and its existing public institutions, and takes effect
30 immediately.
