30 **NEW SECTION. Sec. 6009.** A new section is added to 2011 1st sp.s.
31 c 49 (uncodified) to read as follows:

32 **NONTAXABLE AND TAXABLE BOND PROCEEDS**

33 Portions of the appropriation authority granted by this act from
34 the state building construction account, or any other account receiving
35 bond proceeds, may be transferred to the state taxable building
36 construction account as deemed necessary by the state finance committee

1 to comply with the federal internal revenue service rules and
2 regulations pertaining to the use of nontaxable bond proceeds.
3 Portions of the general obligation bond proceeds authorized in this act
4 for deposit into the state taxable building construction account that
5 are in excess of amounts required to comply with the federal internal
6 revenue service rules and regulations shall be deposited into the state
7 building construction account. The state treasurer shall submit
8 written notification to the director of financial management if it is
9 determined that a shift of appropriation authority between the state
10 building construction account, or any other account receiving bond

15 NEW SECTION. **Sec. 6010.** If any provision of this act or its
16 application to any person or circumstance is held invalid, the
17 remainder of the act or the application of the provision to other
18 persons or circumstances is not affected.

19 NEW SECTION. **Sec. 6011.** This act is necessary for the immediate
20 preservation of the public peace, health, or safety, or support of the
21 state government and its existing public institutions, and takes effect
22 immediately.
