EFFECT: Increases the seriousness levels for crimes of Vehicular Homicide and Vehicular Assault as follows (which makes the bill consistent with the original House bill):

Vehicular Homicide by reckless driving is raised from a level VIII to a level X;

Vehicular Homicide by disregard for the safety of others is raised from a level VII to a level VIII; and

Vehicular Assault while driving under the influence of alcohol or drugs is raised from a level IV to a level  $\ensuremath{\text{V}}$ .
