25 (g) Five representatives of the public, one of whom shall be a
26 student to be appointed by the governor and approved by the senate.
27 Members representing the public shall serve for four-year terms, except
28 for the student member who shall serve for a one-year term"

30 material through "openings." on page 241, line 10 and insert "(1)(a) A
31 joint select legislative task force on higher education is established,
32 with members as provided in this subsection.

33 (i) The president of the senate shall appoint two members from each
34 of the two largest caucuses of the senate.

1 (ii) The speaker of the house of representatives shall appoint two
2 members from each of the two largest caucuses of the house of
3 representatives.

4 (b) The task force shall choose its cochairs from among its
5 membership.

6 (2) The task force shall review coordination, planning, and
7 communication for higher education in the state and establish the
8 purpose and functions of the higher education council. Specifically,
9 the task force shall consider options for the following:

10 (a) Creating an effective and efficient higher education system and
11 coordinating key sectors including K-12;

12 (b) Improving the coordination of higher education institutions and
13 sectors with specific attention to strategic planning, system design,
14 and transfer and articulation; and

15 (c) Improving structures and functions related to administration
16 and regulation of the state's higher education institutions and
17 programs, including but not limited to financial aid, the guaranteed
18 education tuition program, federal grant administration, new degree
19 program approval, authorization to offer degrees in the state,
20 reporting performance data, and minimum admission standards.

21 (3) The task force shall consider input from higher education
22 stakeholders, including but not limited to the governor, the higher
23 education coordinating board, the state board for community and
24 technical colleges, private, nonprofit baccalaureate degree granting
25 institutions, the office of the superintendent of public instruction,
26 the workforce training and education coordinating board, the four-year
27 institutions of higher education, students, faculty, business and labor
28 organizations, and members of the public.

29 (4) Staff support for the task force must be provided by the senate
30 committee services and the house of representatives office of program
31 research.

32 (5) Members of the task force must be reimbursed for travel
33 expenses in accordance with RCW 44.04.120.

34 (6) The expenses of the task force must be paid jointly by the
35 senate and the house of representatives. Task force expenditures are
36 subject to approval by the senate facilities and operation committee
37 and the house of representatives executive rules committee, or their
38 successor committees.

1 (7) The task force shall report its findings and recommendations to
2 the governor and the appropriate committees of the legislature by
3 December 1, 2011.

4 (8) This section expires July 1, 2012."

5 Renumber the remaining sections and part consecutively, correct any
6 internal references accordingly, and correct the title.

7 On page 241, beginning on line 23, strike all of sections 605, 606,
8 and 607

9 Correct the title.

EFFECT: Retains the provisions that create an Office of Student
Financial Assistance and that transfer the current financial aid
program management under the Higher Education Coordinating Board to the
new Office of Student Financial Assistance.

Eliminates the Higher Education Coordinating Board on July 1, 2012,
and establishes a Higher Education Council subject to recommendations
of a Joint Legislative Task Force on Higher Education and legislation
enacted in 2012.

Creates a Joint Legislative Task Force on Higher Education to
establish the purpose and functions of the Higher Education Council.

Retains some provisions that eliminate reporting requirements of
higher education institutions related to gender equity and campus
safety.
