Strike everything after the enacting clause and insert the following:

3 "<u>NEW SECTION.</u> **Sec. 1.** SHORT TITLE. This chapter shall be known 4 and cited as the "Washington state Indian child welfare act."

5 <u>NEW SECTION.</u> Sec. 2. APPLICATION. This chapter shall apply in 6 all child custody proceedings as that term is defined in this chapter. 7 Whenever there is a conflict between chapter 13.32A, 13.34, 13.36, 8 26.10, or 26.33 RCW, the provisions of this chapter shall apply.

9 NEW SECTION. Sec. 3. INTENT. The legislature finds that the state is committed to protecting the essential tribal relations and 10 best interests of Indian children by promoting practices designed to 11 prevent out-of-home placement of Indian children that is inconsistent 12 13 with the rights of the parents, the health, safety, or welfare of the children, or the interests of their tribe. 14 Whenever out-of-home placement of an Indian child is necessary in a proceeding subject to 15 the terms of the federal Indian child welfare act and in this chapter, 16 17 the best interests of the Indian child may be served by placing the Indian child in accordance with the placement priorities expressed in 18 19 this chapter. The legislature further finds that where placement away from the parent or Indian custodian is necessary for the child's 20 safety, the state is committed to a placement that reflects and honors 21 22 the unique values of the child's tribal culture and is best able to assist the Indian child in establishing, developing, and maintaining a 23 24 political, cultural, social, and spiritual relationship with the child's tribe and tribal community. 25

It is the intent of the legislature that this chapter is a step in clarifying existing laws and codifying existing policies and practices. This chapter shall not be construed to reject or eliminate current policies and practices that are not included in its provisions.

The legislature further intends that nothing in this chapter is 1 2 intended to interfere with policies and procedures that are derived from agreements entered into between the department and a tribe or 3 4 tribes, as authorized by section 109 of the federal Indian child welfare act. The legislature finds that this chapter specifies the 5 6 minimum requirements that must be applied in a child custody proceeding 7 and does not prevent the department from providing a higher standard of 8 protection to the right of any Indian child, parent, Indian custodian, 9 or Indian child's tribe.

10 It is also the legislature's intent that the department's policy 11 manual on Indian child welfare, the tribal-state agreement, and 12 relevant local agreements between individual federally recognized 13 tribes and the department should serve as persuasive guides in the 14 interpretation and implementation of the federal Indian child welfare 15 act, this chapter, and other relevant state laws.

16 <u>NEW SECTION.</u> Sec. 4. DEFINITIONS. The definitions in this 17 section apply throughout this chapter unless the context clearly 18 requires otherwise.

19

(1) "Active efforts" means the following:

20 (a) In any foster care placement or termination of parental rights 21 proceeding of an Indian child under chapter 13.34 RCW and this chapter 22 where the department or a supervising agency as defined in RCW 23 74.13.020 has a statutory or contractual duty to provide services to, 24 or procure services for, the parent or parents or Indian custodian, or 25 is providing services to a parent or parents or Indian custodian 26 pursuant to a disposition order entered pursuant to RCW 13.34.130, the 27 department or supervising agency shall make timely and diligent efforts to provide or procure such services, including engaging the parent or 28 29 parents or Indian custodian in reasonably available and culturally appropriate preventive, remedial, or rehabilitative services. 30 This shall include those services offered by tribes and Indian organizations 31 whenever possible. At a minimum "active efforts" shall include: 32

(i) In any dependency proceeding under chapter 13.34 RCW seeking
 out-of-home placement of an Indian child in which the department or
 supervising agency provided voluntary services to the parent, parents,
 or Indian custodian prior to filing the dependency petition, a showing
 to the court that the department or supervising agency social workers

actively worked with the parent, parents, or Indian custodian to engage them in remedial services and rehabilitation programs to prevent the breakup of the family beyond simply providing referrals to such services.

(ii) In any dependency proceeding under chapter 13.34 RCW, in which 5 the petitioner is seeking the continued out-of-home placement of an 6 7 Indian child, the department or supervising agency must show to the 8 court that it has actively worked with the parent, parents, or Indian custodian in accordance with existing court orders and the individual 9 10 service plan to engage them in remedial services and rehabilitative programs to prevent the breakup of the family beyond simply providing 11 12 referrals to such services.

13 (iii) In any termination of parental rights proceeding regarding an 14 Indian child under chapter 13.34 RCW in which the department or supervising agency provided services to the parent, parents, or Indian 15 custodian, a showing to the court that the department or supervising 16 17 agency social workers actively worked with the parent, parents, or 18 Indian custodian to engage them in remedial services and rehabilitation 19 programs ordered by the court or identified in the department or 20 supervising agency's individual service and safety plan beyond simply 21 providing referrals to such services.

(b) In any foster care placement or termination of parental rights proceeding in which the petitioner does not otherwise have a statutory or contractual duty to directly provide services to, or procure services for, the parent or Indian custodian, "active efforts" means a documented, concerted, and good faith effort to facilitate the parent's or Indian custodian's receipt of and engagement in services capable of meeting the criteria set out in (a) of this subsection.

29 (2) "Best interests of the Indian child" means the use of practices 30 in accordance with the federal Indian child welfare act, this chapter, applicable law, that are designed to accomplish the 31 and other 32 following: (a) Protect the safety, well-being, development, and stability of the Indian child; (b) prevent the unnecessary out-of-home 33 placement of the Indian child; (c) acknowledge the right of Indian 34 35 tribes to maintain their existence and integrity which will promote the 36 stability and security of their children and families; (d) recognize 37 the value to the Indian child of establishing, developing, or maintaining a political, cultural, social, and spiritual relationship 38

1 with the Indian child's tribe and tribal community; and (e) in a 2 proceeding under this chapter where out-of-home placement is necessary, 3 to prioritize placement of the Indian child in accordance with the 4 placement preferences of this chapter.

5

(3) "Child custody proceeding" includes:

6 (a) "Foster care placement" which means any action removing an 7 Indian child from his or her parent or Indian custodian for temporary 8 placement in a foster home, institution, or with a relative, guardian, 9 conservator, or suitable other person where the parent or Indian 10 custodian cannot have the child returned upon demand, but where 11 parental rights have not been terminated;

(b) "Termination of parental rights" which means any actionresulting in the termination of the parent-child relationship;

14 (c) "Preadoptive placement" which means the temporary placement of 15 an Indian child in a foster home or institution after the termination 16 of parental rights but before or in lieu of adoptive placement; and

(d) "Adoptive placement" which means the permanent placement of an
Indian child for adoption, including any action resulting in a final
decree of adoption.

These terms shall not include a placement based upon an act which, if committed by an adult, would be deemed a crime or upon an award, in a dissolution proceeding of custody to one of the parents.

(4) "Court of competent jurisdiction" means a federal court, or a state court that entered an order in a child custody proceeding involving an Indian child, as long as the state court had proper subject matter jurisdiction in accordance with this chapter and the laws of that state, or a tribal court that had or has exclusive or concurrent jurisdiction pursuant to 25 U.S.C. Sec. 1911.

(5) "Department" means the department of social and health services and any of its divisions. "Department" also includes supervising agencies as defined in RCW 74.13.020(12) with which the department entered into a contract to provide services, care, placement, case management, contract monitoring, or supervision to children subject to a petition filed under chapter 13.34 or 26.33 RCW.

35 (6) "Indian" means a person who is a member of an Indian tribe, or 36 who is an Alaska native and a member of a regional corporation as 37 defined in 43 U.S.C. Sec. 1606. 1 (7) "Indian child" means an unmarried and unemancipated Indian 2 person who is under eighteen years of age and is either: (a) A member 3 of an Indian tribe; or (b) eligible for membership in an Indian tribe 4 and is the biological child of a member of an Indian tribe.

5 (8) "Indian child's family" or "extended family member" means an 6 individual, defined by the law or custom of the child's tribe, as a 7 relative of the child. If the child's tribe does not identify such 8 individuals by law or custom, the term means an adult who is the Indian 9 child's grandparent, aunt, uncle, brother, sister, brother-in-law, 10 sister-in-law, niece, nephew, first or second cousin, or step-parent, 11 even following termination of the marriage.

(9) "Indian child's tribe" means a tribe in which an Indian childis a member or eligible for membership.

14 (10) "Indian custodian" means an Indian person who under tribal 15 law, tribal custom, or state law, has legal or temporary physical 16 custody of an Indian child, or to whom the parent has transferred 17 temporary care, physical custody, and control of an Indian child.

18 (11) "Indian tribe" or "tribe" means any Indian tribe, band, 19 nation, or other organized group or community of Indians recognized as 20 eligible for the services provided to Indians by the secretary of the 21 interior because of their status as Indians, including any Alaska 22 native village as defined in 43 U.S.C. Sec. 1602(c).

(12) "Member" and "membership" means a determination by an Indian
 tribe that a person is a member or eligible for membership in that
 Indian tribe.

(13) "Parent" means a biological parent or parents of an Indian child or a person who has lawfully adopted an Indian child, including adoptions made under tribal law or custom. "Parent" does not include an unwed father whose paternity has not been acknowledged or established under chapter 26.26 RCW or the applicable laws of other states.

32 (14) "Secretary of the interior" means the secretary of the United33 States department of the interior.

34 (15) "Tribal court" means a court or body vested by an Indian tribe 35 with jurisdiction over child custody proceedings, including but not 36 limited to a federal court of Indian offenses, a court established and 37 operated under the code or custom of an Indian tribe, or an administrative body of an Indian tribe vested with authority over child
 custody proceedings.

3 (16) "Tribal customary adoption" means adoption or other process 4 through the tribal custom, traditions, or laws of an Indian child's 5 tribe by which the Indian child is permanently placed with a nonparent 6 and through which the nonparent is vested with the rights, privileges, 7 and obligations of a legal parent. Termination of the parent-child 8 relationship between the Indian child and the biological parent is not 9 required to effect or recognize a tribal customary adoption.

10 NEW SECTION. Sec. 5. DETERMINATION OF INDIAN STATUS. Any party 11 seeking the foster care placement of, termination of parental rights 12 over, or the adoption of a child must make a good faith effort to determine whether the child is an Indian child. This shall be done by 13 consultation with the child's parent or parents, any person who has 14 custody of the child or with whom the child resides, and any other 15 person that reasonably can be expected to have information regarding 16 the child's possible membership or eligibility for membership in an 17 Indian tribe to determine if the child is an Indian child, and by 18 contacting any Indian tribe in which the child may be a member or may 19 20 be eligible for membership. Preliminary contacts for the purpose of 21 making a good faith effort to determine a child's possible Indian 22 status, do not constitute legal notice as required by section 7 of this 23 act.

24 NEW SECTION. Sec. 6. JURISDICTION. (1) An Indian tribe shall 25 have exclusive jurisdiction over any child custody proceeding involving an Indian child who resides or is domiciled within the reservation of 26 that tribe, unless the tribe has consented to the state's concurrent 27 28 jurisdiction, the tribe has expressly declined to exercise its jurisdiction, exercising 29 exclusive or the state is emergency 30 jurisdiction in strict compliance with section 14 of this act.

31 (2) If an Indian child is already a ward of a tribal court at the 32 start of the child custody proceeding, the Indian tribe may retain 33 exclusive jurisdiction, notwithstanding the residence or domicile of 34 the child.

1 <u>NEW SECTION.</u> Sec. 7. NOTICE. (1) In any involuntary child 2 custody proceeding seeking the foster care placement of, or the termination of parental rights to, a child in which the petitioning 3 party or the court knows, or has reason to know, that the child is or 4 may be an Indian child as defined in this chapter, the petitioning 5 party shall notify the parent or Indian custodian and the Indian б 7 child's tribe or tribes, by certified mail, return receipt requested, 8 and by use of a mandatory Indian child welfare act notice. If the identity or location of the parent or Indian custodian and the tribe 9 10 cannot be determined, such notice shall be given to the secretary of interior by registered mail, return receipt requested, 11 the in 12 accordance with the regulations of the bureau of Indian affairs. The 13 secretary of the interior has fifteen days after receipt to provide the 14 requisite notice to the parent or Indian custodian and the tribe. No foster care placement or termination of parental rights proceeding 15 shall be held until at least ten days after receipt of notice by the 16 17 parent or Indian custodian and the tribe. The parent or Indian custodian or the tribe shall, upon request, be granted up to twenty 18 additional days to prepare for the proceeding. 19

(2) The determination of the Indian status of a child shall be made
as soon as practicable in order to serve the best interests of the
Indian child and protect the interests of the child's tribe.

(3)(a) A written determination by an Indian tribe that a child is a member of or eligible for membership in that tribe, or testimony by the tribe attesting to such status shall be conclusive that the child is an Indian child;

27 (b) A written determination by an Indian tribe that a child is not 28 a member of or eligible for membership in that tribe, or testimony by 29 the tribe attesting to such status shall be conclusive that the child 30 is not a member or eligible for membership in that tribe. Such determinations are presumptively those of the tribe where submitted in 31 the form of a tribal resolution, or signed by or testified to by the 32 person(s) authorized by the tribe's governing body to speak for the 33 tribe, or by the tribe's agent designated to receive notice under the 34 federal Indian child welfare act where such designation is published in 35 36 the federal register;

37 (c) Where a tribe provides no response to notice under section 7 of 38 this act, such nonresponse shall not constitute evidence that the child is not a member or eligible for membership. Provided, however, that under such circumstances the party asserting application of the federal Indian child welfare act, or this chapter, will have the burden of proving by a preponderance of the evidence that the child is an Indian child.

6 (4)(a) Where a child has been determined not to be an Indian child, 7 any party to the proceeding, or an Indian tribe that subsequently 8 determines the child is a member, may, during the pendency of any child 9 custody proceeding to which this chapter or the federal Indian child 10 welfare act applies, move the court for redetermination of the child's 11 Indian status based upon new evidence, redetermination by the child's 12 tribe, or newly conferred federal recognition of the tribe.

(b) This subsection (4) does not affect the rights afforded under25 U.S.C. Sec. 1914.

NEW SECTION. Sec. 8. TRANSFER OF JURISDICTION. (1) In any proceeding for the foster care placement of, or termination of parental rights to, an Indian child who is not domiciled or residing within the reservation of the Indian child's tribe, the court shall, in the absence of good cause to the contrary, transfer the proceeding to the jurisdiction of the Indian child's tribe, upon the motion of any of the following persons:

- 22 (a) Either of the child's parents;
- 23 (b) The child's Indian custodian;
- 24

(c) The child's tribe; or

25 (d) The child, if age twelve or older.

The transfer shall be subject to declination by the tribe. The tribe shall have seventy-five days to affirmatively respond to a motion or order transferring jurisdiction to the tribal court. A failure of the tribe to respond within the seventy-five day period shall be construed as a declination to accept transfer of the case.

31 (2) If the child's tribe has not formally intervened, the moving 32 party shall serve a copy of the motion and all supporting documents on 33 the tribal court to which the moving party seeks transfer.

(3) If either of the Indian child's parents objects to transfer of
 the proceeding to the Indian child's tribe, the court shall not
 transfer the proceeding.

(4) Following entry of an order transferring jurisdiction to the
 Indian child's tribe:

3 (a) Upon receipt of an order from a tribal court accepting 4 jurisdiction, the state court shall dismiss the child custody 5 proceeding without prejudice.

6 (b) Pending receipt of such tribal court order, the state court may conduct additional hearings and enter orders which strictly comply with 7 the requirements of the federal Indian child welfare act and this 8 chapter. The state court shall not enter a final order in any child 9 custody proceeding, except an order dismissing the proceeding and 10 returning the Indian child to the care of the parent or Indian 11 12 custodian from whose care the child was removed, while awaiting receipt 13 of a tribal court order accepting jurisdiction, or in the absence of a tribal court order or other formal written declination of jurisdiction. 14

(c) If the Indian child's tribe declines jurisdiction, the state court shall enter an order vacating the order transferring jurisdiction and proceed with adjudication of the child custody matter in strict compliance with the federal Indian child welfare act, this chapter, and any applicable tribal-state agreement.

20 <u>NEW SECTION.</u> Sec. 9. INTERVENTION. The Indian child, the Indian 21 child's tribe or tribes, and the Indian custodian have the right to 22 intervene at any point in any child custody proceeding involving the 23 Indian child.

24 <u>NEW SECTION.</u> Sec. 10. FULL FAITH AND CREDIT. The state shall 25 give full faith and credit to the public acts, records, judicial 26 proceedings, and judgments of any Indian tribe applicable to Indian 27 child custody proceedings.

NEW SECTION. Sec. 11. RIGHT TO COUNSEL. In any child custody proceeding under this chapter in which the court determines the Indian child's parent or Indian custodian is indigent, the parent or Indian custodian shall have the right to court-appointed counsel. The court may, in its discretion, appoint counsel for the Indian child upon a finding that the appointment is in the best interests of the Indian child. NEW SECTION. Sec. 12. RIGHT TO ACCESS TO EVIDENCE. Each party to a child custody proceeding involving an Indian child shall have the right to examine all reports or other documents filed with the court upon which any decision with respect to the proceeding may be based.

5 <u>NEW SECTION.</u> Sec. 13. EVIDENTIARY REQUIREMENTS. (1) A party 6 seeking to effect an involuntary foster care placement of or the 7 involuntary termination of parental rights to an Indian child shall 8 satisfy the court that active efforts have been made to provide 9 remedial services and rehabilitative programs designed to prevent the 10 breakup of the Indian family and that these efforts have proved 11 unsuccessful.

12 (2) No involuntary foster care placement may be ordered in a child 13 custody proceeding in the absence of a determination, supported by clear and convincing evidence, including testimony of qualified expert 14 witnesses, that the continued custody of the child by the parent or 15 16 Indian custodian is likely to result in serious emotional or physical 17 damage to the child. For purposes of this subsection, any harm that may result from interfering with the bond or attachment between the 18 foster parent and the child shall not be the sole basis or primary 19 20 reason for continuing the child in foster care.

21 (3) No involuntary termination of parental rights may be ordered in 22 a child custody proceeding in the absence of a determination, supported 23 by evidence beyond a reasonable doubt, including testimony of qualified 24 expert witnesses, that the continued custody of the child by the parent 25 or Indian custodian is likely to result in serious emotional or physical damage to the child. For the purposes of this subsection, any 26 27 harm that may result from interfering with the bond or attachment that may have formed between the child and a foster care provider shall not 28 29 be the sole basis or primary reason for termination of parental rights over an Indian child. 30

(4)(a) For purposes of this section, "qualified expert witness" means a person who provides testimony in a proceeding under this chapter to assist a court in the determination of whether the continued custody of the child by, or return of the child to, the parent, parents, or Indian custodian, is likely to result in serious emotional or physical damage to the child. In any proceeding in which the child's Indian tribe has intervened pursuant to section 9 of this act

or, if the department is the petitioner and the Indian child's tribe 1 2 has entered into a local agreement with the department for the 3 provision of child welfare services, the petitioner shall contact the 4 tribe and ask the tribe to identify a tribal member or other person of the tribe's choice who is recognized by the tribe as knowledgeable 5 regarding tribal customs as they pertain to family organization or б 7 child rearing practices. The petitioner shall notify the child's 8 Indian tribe of the need to provide a "qualified expert witness" at least twenty days prior to any evidentiary hearing in which the 9 10 testimony of the witness will be required. If the child's Indian tribe does not identify a "qualified expert witness" for the proceeding on a 11 12 timely basis, the petitioner may proceed to identify such a witness 13 pursuant to (b) of this subsection.

(b) In any proceeding in which the child's Indian tribe has not intervened or entered into a local agreement with the department for the provision of child welfare services, or a child's Indian tribe has not responded to a request to identify a "qualified expert witness" for the proceeding on a timely basis, the petitioner shall provide a "qualified expert witness" who meets one or more of the following requirements in descending order of preference:

(i) A member of the child's Indian tribe or other person of the tribe's choice who is recognized by the tribe as knowledgeable regarding tribal customs as they pertain to family organization or child rearing practices for this purpose;

(ii) Any person having substantial experience in the delivery of child and family services to Indians, and extensive knowledge of prevailing social and cultural standards and child rearing practices within the Indian child's tribe;

(iii) Any person having substantial experience in the delivery of child and family services to Indians, and knowledge of prevailing social and cultural standards and child rearing practices in Indian tribes with cultural similarities to the Indian child's tribe; or

33 (iv) A professional person having substantial education and 34 experience in the area of his or her specialty.

35 (c) When the petitioner is the department or a supervising agency, 36 the currently assigned department or agency caseworker or the 37 caseworker's supervisor may not testify as a "qualified expert witness" 38 for purposes of this section. Nothing in this section shall bar the

assigned department or agency caseworker or the caseworker's supervisor 1 2 from testifying as an expert witness for other purposes in a proceeding under this chapter. Nothing in this section shall bar other department 3 or supervising agency employees with appropriate expert qualifications 4 or experience from testifying as a "qualified expert witness" in a 5 proceeding under this chapter. Nothing in this section shall bar the б 7 petitioner or any other party in a proceeding under this chapter from 8 providing additional witnesses or expert testimony, subject to the approval of the court, on any issue before the court including the 9 10 determination of whether the continued custody of the child by, or return of the child to, the parent, parents, or Indian custodian, is 11 12 likely to result in serious emotional or physical damage to the child.

NEW SECTION. Sec. 14. EMERGENCY REMOVAL OF AN INDIAN CHILD. (1) 13 14 Notwithstanding any other provision of federal or state law, nothing shall be construed to prevent the department or law enforcement from 15 the emergency removal of an Indian child who is a resident of or is 16 domiciled on an Indian reservation, but is temporarily located off the 17 reservation, from his or her parent or Indian custodian or the 18 emergency placement of such child in a foster home, under applicable 19 20 state law, to prevent imminent physical damage or harm to the child.

21 (2) The department or law enforcement agency shall ensure that the 22 emergency removal or placement terminates immediately when such removal 23 or placement is no longer necessary to prevent imminent physical damage 24 or harm to the child and shall expeditiously initiate a child custody 25 proceeding subject to the provisions of the federal Indian child 26 welfare act and this chapter to transfer the child to the jurisdiction of the appropriate Indian tribe or restore the child to the child's 27 parent or Indian custodian, if appropriate. 28

29 (3) When the nature of the emergency allows, the department must notify the child's tribe before the removal has occurred. If prior 30 31 notification is not possible, the department shall notify the child's tribe by the quickest means possible. The notice must contain the 32 basis for the Indian child's removal, the time, date, and place of the 33 initial hearing, and the tribe's right to intervene and participate in 34 35 the proceeding. This notice shall not constitute the notice required 36 under section 7 of this act for purposes of subsequent dependency, termination of parental rights, or adoption proceedings. 37

NEW SECTION. Sec. 15. CONSENT. (1) If an Indian child's parent 1 2 or Indian custodian voluntarily consents to a foster care placement of the child or to termination of parental rights, the consent is not 3 valid unless executed in writing and recorded before a judge of a court 4 5 of competent jurisdiction and accompanied by the judge's certificate that the terms and consequences of the consent were fully explained in б 7 detail and were fully understood by the parent or Indian custodian. 8 The court must also certify that either the parent or Indian custodian fully understood the explanation in English or that it was interpreted 9 10 into a language that the parent or Indian custodian understood. Any consent for release of custody given prior to, or within ten days 11 12 after, the birth of the Indian child shall not be valid.

13 (2) An Indian child's parent or Indian custodian may withdraw 14 consent to a voluntary foster care placement at any time and, upon the 15 withdrawal of consent, the child shall be returned to the parent or 16 Indian custodian.

(3) In a voluntary proceeding for termination of parental rights to, or adoptive placement of, an Indian child, the consent of the parent may be withdrawn for any reason at any time prior to the entry of an order terminating parental rights or a final decree of adoption, and the child shall be returned to the parent.

(4) After the entry of a final decree of adoption of an Indian child, the parent may withdraw consent to the adoption upon the grounds that consent was obtained through fraud or duress. Upon a finding that such consent was obtained through fraud or duress the court shall vacate the decree and return the child to the parent. No adoption which has been effective for at least two years may be invalidated under this section unless otherwise allowed by state law.

29 NEW SECTION. Sec. 16. IMPROPER REMOVAL OF AN INDIAN CHILD. If a petitioner in a child custody proceeding under this chapter has 30 31 improperly removed the child from the custody of the parent or Indian custodian or has improperly retained custody after a visit or other 32 temporary relinquishment of custody, the court 33 shall decline 34 jurisdiction over the petition and shall immediately return the child 35 to the child's parent or Indian custodian unless returning the child to 36 the parent or Indian custodian would subject the child to substantial and immediate danger or threat of such danger. 37

Sec. 17. REMOVAL OF INDIAN CHILD FROM ADOPTIVE OR 1 NEW SECTION. 2 FOSTER CARE PLACEMENT. The fact-finding hearing on the petition shall be held no later than seventy-five days 14 after the filing of the petition, unless exceptional reasons for a 15 continuance are found. The party requesting the continuance shall have 16 17 the burden of proving by a preponderance of the evidence that 18 exceptional circumstances exist. To ensure that the hearing on the petition occurs within the seventy-five day time limit, the court shall 19 schedule and hear the matter on an expedited basis. 20

(2) Every order or decree entered in any proceeding under this 25 26 chapter shall contain a finding that the federal Indian child welfare 27 act or chapter 13. --- RCW (the new chapter created in section 35 of this act) does or does not apply. Where there is a finding that the 28 federal Indian child welfare act or chapter 13.--- RCW (the new chapter 29 30 created in section 35 of this act) does apply, the decree or order must also contain a finding that all notice ((requirements)) and evidentiary 31 32 requirements under the federal Indian child welfare act and chapter 13.--- RCW (the new chapter created in section 35 of this act) have 33 been satisfied. 34

37 (1)(a) Every petition filed in proceedings under this chapter shall

contain a statement alleging whether the child is or may be an Indian child as defined in ((25 U.S.C. Sec. 1903)) section 4 of this act. If the child is an Indian child ((as defined under the Indian child welfare act, the provisions of the act)), chapter 13.--- RCW (the new chapter created in section 35 of this act) shall apply.

12 (1) After the reports required by RCW 26.33.190 and 26.33.200 have been filed, the court shall schedule a hearing on the petition for 13 adoption upon request of the petitioner for adoption. Notice of the 14 date, time, and place of hearing shall be given to the petitioner and 15 16 any person or agency whose consent to adoption is required under RCW 17 26.33.160, unless the person or agency has waived in writing the right to receive notice of the hearing. As used in this section, "out-of-home placement" and "out-of-home care" mean the placement of a child in a foster family home or group care facility licensed under chapter 74.15 RCW.

Whenever the department places a child in out-of-home care under a voluntary placement pursuant to this section, the department shall have the responsibility for the child's placement and care. The department shall develop a permanency plan of care for the child no later than

sixty days from the date that the department assumes responsibility for 1 2 the child's placement and care. Within the first one hundred eighty days of the placement, the department shall obtain a judicial 3 determination pursuant to RCW 13.04.030(1)(j) and 13.34.270 that the 4 placement is in the best interests of the child. Nothing in this section shall prevent the department from filing a dependency petition if there is reason to believe that the child is a dependent child as defined in RCW 13.34.030.

The department shall adopt rules providing for the implementation of chapter 386, Laws of 1997 and the transfer of responsibility for out-of-home placements from the dependency process under chapter 13.34 RCW to the process under this chapter.

21 It is the intent of the legislature that the department undertake 22 voluntary out-of-home placement in cases where the child's 23 developmental disability is such that the parent, guardian, or legal 24 custodian is unable to provide the necessary care for the child, and 25 the parent, guardian, or legal custodian has determined that the child 26 would benefit from placement outside of the home.
