- 26 so long as the community corrections officer was acting at the request
- 27 of the law enforcement officer, unless the act or omission constitutes
- 28 gross negligence.
- 29 (2) A community corrections officer is not liable for civil
- 30 damages arising from an act or omission that occurs when the community
- 31 corrections officer interacts with a third party who is attempting to
- 32 intervene in a situation in which the community corrections officer is
- 33 contacting an offender on community custody or community supervision,
- 34 unless the act or omission constitutes gross negligence."
