1 On page 1, beginning on line 12, strike all of subsection (2) and
2 insert the following:

3 "(2) Has alterations to one or more of the major component parts
4 listed in RCW 46.80.010 that change the appearance or performance of
5 the vehicle from the original manufacturer's design or has a body
6 constructed from nonoriginal materials."

7 On page 1, beginning on line 16, after "(1)" strike "With an
8 application for an original certificate of title for a street rod
9 vehicle" and insert "When applying for a certificate of title for a
10 street rod vehicle for the first time"

11 On page 2, after line 9, strike all of subsection (3) and insert
12 the following:

13 "(3) The presence of modern equipment including, but not limited
14 to, brakes, engines, or seat belts, or the presence of optional
15 equipment referenced in RCW 46.37.518, on a street rod vehicle does not
16 invalidate the year of manufacture on the certificate of title."

17 On page 2, line 19, after "least" strike "twenty-five" and insert
18 "thirty"

19 On page 2, line 20, after "least" strike "twenty-five" and insert
20 "thirty"

21 On page 2, beginning on line 22, strike all of subsection (2) and
22 insert the following:

23 "(2) Has alterations to one or more of the major component parts
24 listed in RCW 46.80.010 that change the appearance or performance of

1 the vehicle from the original manufacturer's design or has a body
2 constructed from nonoriginal materials."

3 On page 2, beginning on line 26, after "(1)" strike "With an
4 application for an original certificate of title for a custom vehicle"
5 and insert "When applying for a certificate of title for a custom
6 vehicle for the first time"

7 On page 3, beginning on line 1, strike all of subsection (3) and
8 insert the following:

9 "(3) The presence of modern equipment including, but not limited
10 to, brakes, engines, or seat belts, or the presence of optional
11 equipment referenced in RCW 46.37.518, on a custom vehicle does not
12 invalidate the year of manufacture on the certificate of title."

13 On page 3, after line 6, insert the following:

14 "NEW SECTION. **Sec. 5.** A new section is added to chapter 46.16A
15 RCW to read as follows:

16 A vehicle registration issued to a street rod or custom vehicle
17 under this chapter need not be an initial vehicle registration for that
18 vehicle."

19 Renumber the remaining sections consecutively and correct any
20 internal references accordingly.

21 On page 7, after line 32, insert the following:

22 "**Sec. 8.** RCW 46.37.518 and 1996 c 225 s 12 are each amended to
23 read as follows:

24 Notwithstanding the requirements of this chapter, hoods and bumpers
25 are optional equipment on street rod(~~s~~) vehicles, custom vehicles,
26 and kit vehicles. Street rod(~~s~~) vehicles, custom vehicles, and kit
27 vehicles must comply with fender requirements under RCW 46.37.500(2)
28 and the windshield requirement of RCW 46.37.410(1)."

29 Renumber the remaining sections consecutively and correct any
30 internal references accordingly.

1 On page 1, line 2 of the title, after "46.16A.060" strike "and
2 46.12.560" and insert ", 46.12.560, and 46.37.518"

3 On page 1, line 3 of the title, after "46.12 RCW;" insert "adding
4 a new section to chapter 46.16A RCW;"

EFFECT: Amends the definition of street rod and custom vehicles to extend to alterations of one or more component parts that change the appearance or performance of the vehicle. Clarifies that titling each vehicle applies to first application of certificate of title rather than "original application." Provides that the presence of modern equipment such as brakes, engines, or seat belts, on either a street rod or custom vehicle or the lack of hoods or bumpers shall not invalidate the year of manufacture on the certificate of title. Changes the definition of custom vehicle from twenty-five years old to thirty. Removes language which exempted equipment on street rods and custom vehicles. Adds "custom vehicles" to those exempt from certain equipment requirements identified in RCW 46.37.518. Provides that registration of a street rod or custom vehicle does not have to be the initial registration.
