## HOUSE BILL 2791

- 1 AN ACT Relating to funding all-day kindergarten; adding a new
- 2 section to chapter 82.32 RCW; creating a new section; repealing RCW
- 3 82.08.0273; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that during difficult
- 6 fiscal times it must prioritize scarce resources so as to provide the
- 7 best outcomes for the citizenry of our state. Furthermore, as the
- 8 recent state supreme court decision in McCleary v. State reiterated,
- 9 the state has fallen short of its paramount duty to fully and amply
- 10 fund our public school system. The legislature also finds that
- 11 legislation initiating comprehensive K-12 education funding reform has
- 12 been enacted in the last several years, which will require additional
- 13 regular and dependable state resources. Therefore, the legislature
- 14 intends to repeal the nonresident sales tax exemption and direct the
- 15 increased resources to K-12 public education to further achieve its
- 16 constitutional and statutory obligations.
- NEW SECTION. Sec. 2. RCW 82.08.0273 (Exemptions--Sales to
- 18 nonresidents of tangible personal property, digital goods, and digital

- 5 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 82.32 RCW 6 to read as follows:
- By May 1, 2013, and by May 1st of every year thereafter, the
- 8 department must annually estimate the increase in state revenue for the
- 9 prior calendar year resulting from the repeal of RCW 82.08.0273 under
- 10 section 2, chapter . . ., Laws of 2012 (section 2 of this act) and
- 11 certify the estimated amount to the state treasurer. By July 1, 2013,
- 12 and by July 1st of every year thereafter, the state treasurer must
- 13 transfer the amount into the all-day kindergarten account hereby
- 14 created in the state treasury. Money in the account may only be used
- 15 to fund all-day kindergarten.
- 16 NEW SECTION. Sec. 4. This act takes effect July 1, 2012.
