1 AN ACT Relating to facilitating voting for service and overseas 2 voters; amending RCW 29A.04.255, 29A.04.311, 29A.04.321, 29A.16.040, 29A.24.040, 29A.24.050, 29A.24.131, 29A.24.141, 29A.24.171, 29A.24.181, 3 29A.24.191, 29A.24.311, 29A.28.041, 29A.40.070, 29A.40.091, 29A.40.110, 4 29A.56.030, 29A.60.190, 29A.60.190, 29A.60.240, 29A.64.011, 29A.64.030, 5 6 29A.68.011, 29A.76.010, and 42.12.070; reenacting and amending RCW 7 29A.04.330, 29A.36.010, and 42.12.040; repealing RCW 29A.04.310, 29A.24.151, 29A.24.161, 29A.24.210, 29A.24.211, 29A.36.011, 8 and 29A.40.150; prescribing penalties; providing effective dates; and 9 providing an expiration date. 10

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

Sec. 1. RCW 29A.04.255 and 2004 c 266 s 5 are each amended to read as follows:

The secretary of state or a county auditor shall accept and file in his or her office electronic ((facsimile)) transmissions of the following documents:

- 17 (1) Declarations of candidacy;
- 18 (2) County canvass reports;
- 19 (3) Voters' pamphlet statements;

(4) Arguments for and against ballot measures that will appear in
 a voters' pamphlet;

(5) Requests for recounts;

4 (6) Certification of candidates and measures by the secretary of 5 state;

6 (7) Direction by the secretary of state for the conduct of a 7 ((mandatory)) recount;

8

(8) Requests for ((absentee)) ballots;

9 (9) Any other election related document authorized by rule adopted 10 by the secretary of state under RCW ((29A.04.610)) 29A.04.611.

11 The acceptance by the secretary of state or the county auditor is 12 conditional upon the document being filed in a timely manner, being 13 legible, and otherwise satisfying the requirements of state law or 14 rules with respect to form and content.

((If the original copy of a document must be signed and a copy of 15 16 the document is filed by facsimile transmission under this section, the 17 original copy must be subsequently filed with the official with whom 18 the facsimile was filed. The original copy must be filed by a deadline established by the secretary by rule.)) The secretary may by rule 19 require that the original of any document, a copy of which is filed by 20 21 ((facsimile)) electronic transmission under this section, also be filed 22 by a deadline established by the secretary by rule.

23 **Sec. 2.** RCW 29A.04.311 and 2006 c 344 s 1 are each amended to read 24 as follows:

((Nominating)) <u>P</u>rimaries for general elections to be held in November, and the election of precinct committee officers, must be held on the ((third)) <u>first</u> Tuesday of the preceding August.

28 Sec. 3. RCW 29A.04.321 and 2009 c 413 s 2 are each amended to read 29 as follows:

(1) All state, county, city, town, and district general elections for the election of federal, state, legislative, judicial, county, city, town, and district officers, and for the submission to the voters of the state, county, city, town, or district of any measure for their adoption and approval or rejection, shall be held on the first Tuesday after the first Monday of November, in the year in which they may be called. A statewide general election shall be held on the first

Tuesday after the first Monday of November of each year. However, the 1 2 statewide general election held in odd-numbered years shall be limited to (a) city, town, and district general elections as provided for in 3 4 RCW 29A.04.330, or as otherwise provided by law; (b) the election of federal officers for the remainder of any unexpired terms in the 5 б membership of either branch of the Congress of the United States; (c) the election of state and county officers for the remainder of any 7 8 unexpired terms of offices created by or whose duties are described in 9 Article II, section 15, Article III, sections 16, 17, 19, 20, 21, 22, and 23, and Article IV, sections 3 and 5 of the state Constitution and 10 RCW 2.06.080; (d) the election of county officers in any county 11 12 governed by a charter containing provisions calling for general county 13 elections at this time; and (e) the approval or rejection of state 14 including proposed constitutional amendments, measures, matters 15 pertaining to any proposed constitutional convention, initiative measures and referendum measures proposed by the electorate, referendum 16 17 bills, and any other matter provided by the legislature for submission 18 to the electorate.

19 (2) A county legislative authority may call a special county 20 election by presenting a resolution to the county auditor prior to the 21 proposed election date. A special election called by the county 22 legislative authority shall be held on one of the following dates as 23 decided by such governing body:

24 (a) The second Tuesday in February;

25

(b) The third Tuesday in April until January 1, 2013;

26 (c) The fourth Tuesday in April on or after January 1, 2013;

27 (((-))) (d) The day of the primary as specified by RCW 29A.04.311; 28 or

(((d))) <u>(e)</u> The first Tuesday after the first Monday in November.

30 (3) A resolution calling for a special election on a date set forth in subsection (2)(a) ((and (b))) through (c) of this section must be 31 32 presented to the county auditor at least ((forty-five)) forty-six days 33 prior to the election date. A resolution calling for a special election on a date set forth in subsection $(2)((\frac{c}{c}) \text{ or}))$ (d) of this 34 35 section must be presented to the county auditor ((at least eighty-four 36 days prior to the election date)) no later than the Friday immediately 37 before the first day of regular candidate filing. A resolution calling 1 for a special election on a date set forth in subsection (2)(e) of this 2 section must be presented to the county auditor no later than the day 3 of the primary.

(4) In addition to the dates set forth in subsection (2)(a) through
(((d))) (e) of this section, a special election to validate an excess
levy or bond issue may be called at any time to meet the needs
resulting from fire, flood, earthquake, or other act of God. Such
county special election shall be noticed and conducted in the manner
provided by law.

10 (5) This section shall supersede the provisions of any and all other statutes, whether general or special in nature, having different 11 12 dates for such city, town, and district elections, the purpose of this 13 section being to establish mandatory dates for holding elections ((except for those elections held pursuant to a home-rule charter 14 adopted under Article XI, section 4 of the state Constitution)). 15 This section shall not be construed as fixing the time for holding primary 16 17 elections, or elections for the recall of any elective public officer.

18 Sec. 4. RCW 29A.04.330 and 2009 c 413 s 4, 2009 c 144 s 3, and 19 2009 c 413 s 3 are each reenacted and amended to read as follows:

(1) All city, town, and district general elections shall be held
 throughout the state of Washington on the first Tuesday following the
 first Monday in November in the odd-numbered years.

23 This section shall not apply to:

(a) Elections for the recall of any elective public officer;

(b) Public utility districts, conservation districts, or district elections at which the ownership of property within those districts is a prerequisite to voting, all of which elections shall be held at the times prescribed in the laws specifically applicable thereto;

(c) Consolidation proposals as provided for in RCW 28A.315.235 and nonhigh capital fund aid proposals as provided for in chapter 28A.540 RCW; and

32 (d) Special flood control districts consisting of three or more 33 counties.

34 (2) The county auditor, as ex officio supervisor of elections, upon
 35 request in the form of a resolution of the governing body of a city,
 36 town, or district, presented to the auditor prior to the proposed
 37 election date, may call a special election in such city, town, or

district, and for the purpose of such special election he or she may combine, unite, or divide precincts. Such a special election shall be held on one of the following dates as decided by the governing body:

4 (a) The second Tuesday in February;

(b) <u>The third Tuesday in April until January 1, 2013;</u>

6 (c) The fourth Tuesday in April on or after January 1, 2013;

7 ((((c))) <u>(d)</u> The day of the primary election as specified by RCW

10 (3) A resolution calling for a special election on a date set forth in subsection (2)(a) ((and (b))) through (c) of this section must be 11 12 presented to the county auditor at least ((forty-five)) forty-six days 13 prior to the election date. A resolution calling for a special election on a date set forth in subsection (2)(((c) or)) (d) of this 14 section must be presented to the county auditor ((at least eighty four 15 days prior to the election date)) no later than the Friday immediately 16 before the first day of regular candidate filing. A resolution calling 17 for a special election on a date set forth in subsection (2)(e) of this 18 19 section must be presented to the county auditor no later than the day 20 of the primary.

21 (4) In addition to subsection (2)(a) through $\left(\left(\frac{d}{d}\right)\right)$ (e) of this 22 section, a special election to validate an excess levy or bond issue 23 may be called at any time to meet the needs resulting from fire, flood, 24 earthquake, or other act of God, except that no special election may be held between the first day for candidates to file for public office and 25 26 the last day to certify the returns of the general election other than 27 as provided in subsection $(2)((\frac{c}{and}))$ (d) and (e) of this section. 28 Such special election shall be conducted and notice thereof given in 29 the manner provided by law.

30 (5) This section shall supersede the provisions of any and all 31 other statutes, whether general or special in nature, having different 32 dates for such city, town, and district elections, the purpose of this 33 section being to establish mandatory dates for holding elections.

34 **Sec. 5.** RCW 29A.16.040 and 2004 c 266 s 10 are each amended to 35 read as follows:

The county legislative authority of each county in the state hereafter formed shall, at their first session, divide their respective 1 counties into election precincts and establish the boundaries of the 2 precincts. The county auditor shall thereupon designate the voting 3 place for each such precinct or whether the precinct is a vote by mail 4 precinct.

5 (1) Precinct boundaries may be altered at any time as long as 6 sufficient time exists prior to a given election for the necessary 7 procedural steps to be honored. Except as permitted under subsection 8 (5) of this section, no precinct ((boundaries)) changes may be 9 ((changed)) made during the period starting ((on the thirtieth)) 10 fourteen days prior to the first day for candidates to file for the 11 primary election and ending with the day of the general election.

12 (2) The county legislative authority may establish by ordinance a 13 limitation on the maximum number of active registered voters in each 14 precinct within its jurisdiction. The limitation may be different for 15 precincts based upon the method of voting used for such precincts and 16 the number may be less than the number established by law, but in no 17 case may the number exceed that authorized by law.

18 (3) Precincts in which voting machines or electronic voting devices 19 are used may contain as many as nine hundred active registered voters. 20 The number of poll-site ballot counting devices at each polling place 21 is at the discretion of the auditor. The number of devices must be 22 adequate to meet the expected voter turnout.

(4) On petition of twenty-five or more voters resident more than
ten miles from any polling site, the county legislative authority shall
establish a separate voting precinct therefor.

26 (5) The county auditor shall temporarily adjust precinct boundaries when a city or town annexes unincorporated territory to the city or 27 28 town, or whenever unincorporated territory is incorporated as a city or 29 The adjustment must be made as soon as possible after the town. 30 approval of the annexation or incorporation. The temporary adjustment must be limited to the minimum changes necessary to accommodate the 31 32 addition of the territory to the city or town, or to establish the eligible voters within the boundaries of the new city or town, and 33 remains in effect only until precinct boundary modifications reflecting 34 35 the annexation or incorporation are adopted by the county legislative 36 authority.

(6) In determining the number of active registered voters for the

purposes of this section, persons who are ongoing absentee voters under RCW 29A.40.040 shall not be counted. Nothing in this subsection may be construed as altering the vote tallying requirements of RCW 29A.60.230.

4 **Sec. 6.** RCW 29A.24.040 and 2006 c 344 s 5 are each amended to read 5 as follows:

A candidate may file his or her declaration of candidacy for an office by electronic means on a system specifically designed and authorized by a filing officer to accept filings.

9 (1) Filings that are received electronically must capture all 10 information specified in RCW 29A.24.031 (1) through (4).

(2) Electronic filing may begin at 9:00 a.m. the first ((Monday in June)) day of the filing period and continue through 4:00 p.m. the ((following Friday)) last day of the filing period.

14 (((3) In case of special filing periods established in this 15 chapter, electronic filings may be accepted beginning at 9:00 a.m. on 16 the first day of the special filing period through 4:00 p.m. the last 17 day of the special filing period.))

18 Sec. 7. RCW 29A.24.050 and 2006 c 344 s 6 are each amended to read 19 as follows:

Except where otherwise provided by this title, declarations of candidacy for the following offices shall be filed during regular business hours with the filing officer ((no earlier than the first Monday in June)) beginning the Monday two weeks before Memorial day and ((no later than)) ending the following Friday in the year in which the office is scheduled to be voted upon:

(1) Offices that are scheduled to be voted upon for full terms or
both full terms and short terms at, or in conjunction with, a state
general election; and

(2) Offices where a vacancy, other than a short term, exists that has not been filled by election and for which an election to fill the vacancy is required in conjunction with the next state general election.

33 This section supersedes all other statutes that provide for a 34 different filing period for these offices. 1 **Sec. 8.** RCW 29A.24.131 and 2004 c 271 s 115 are each amended to 2 read as follows:

A candidate may withdraw his or her declaration of candidacy at any 3 4 time before the close of business on the ((Thursday)) Monday following the last day for candidates to file under RCW 29A.24.050 by filing, 5 6 with the officer with whom the declaration of candidacy was filed, a 7 signed request that his or her name not be printed on the ballot. 8 There shall be no withdrawal period for declarations of candidacy filed during special filing periods held under this title. 9 ((The filing 10 officer may permit the withdrawal of a filing for the office of 11 precinct committee officer at the request of the candidate at any time 12 if no absentee ballots have been issued for that office and the ballots 13 for that precinct have not been printed. The filing officer may permit the withdrawal of a filing for any elected office of a city, town, or 14 special district at the request of the candidate at any time before a 15 primary if the primary ballots for that city, town, or special district 16 17 have not been ordered.)) No filing fee may be refunded to any candidate who withdraws under this section. Notice of the deadline for 18 19 withdrawal of candidacy and that the filing fee is not refundable shall be given to each candidate at the time he or she files. 20

21 Sec. 9. RCW 29A.24.141 and 2004 c 271 s 162 are each amended to 22 read as follows:

A void in candidacy ((for a nonpartisan office)) occurs when an election ((for such office, except for the short term,)) has been scheduled and no valid declaration of candidacy has been filed for the position or all persons filing such valid declarations of candidacy have died or been disqualified.

28 **Sec. 10.** RCW 29A.24.171 and 2006 c 344 s 7 are each amended to 29 read as follows:

30 ((Filings for a nonpartisan office shall be reopened for a period 31 of three normal business days, such three day period to be fixed by the 32 election officer with whom such declarations of candidacy are filed and 33 notice thereof given by notifying press, radio, and television in the 34 county and by such other means as may now or hereafter be provided by 35 law whenever before the eleventh Tuesday prior to a primary: 36 (1) A void in candidacy occurs;

- 1 (2) A vacancy occurs in any nonpartisan office leaving an unexpired
 2 term to be filled by an election for which filings have not been held;
 3 or
- 4 (3) A nominee for judge of the superior court entitled to a
 5 certificate of election pursuant to Article 4, section 29, Amendment 41
 6 of the state Constitution, dies or is disqualified.

7 Candidacies validly filed within said three-day period shall appear 8 on the ballot as if made during the earlier filing period.)) If, prior 9 to the first day of the regular filing period, a vacancy occurs in an office that is not scheduled to appear on the general election ballot, 10 leaving an unexpired term, filings for that office shall be accepted 11 during the regular filing period. The filing officer shall provide 12 notice of the vacancy and filing period to newspapers, radio, and 13 television in the county, and online. The position shall appear on the 14 primary and general election ballots unless no primary is required or 15 16 unless a candidate for superior court judge is entitled to a 17 certificate of election pursuant to Article 4, section 29 of the state Constitution. 18

19 Sec. 11. RCW 29A.24.181 and 2006 c 344 s 8 are each amended to 20 read as follows:

21 ((Filings for a nonpartisan office (other than judge of the supreme 22 court or superintendent of public instruction))) If, prior to the day 23 of the primary, any of the following occur, filings shall be reopened for a period of three normal business days, such three-day period to be 24 25 fixed by the ((election officer with whom such declarations of 26 candidacy are filed and notice thereof given by notifying press, radio, 27 and television in the county and by such other means as may now or hereafter be provided by law, when)) filing officer: 28

(1) A void in candidacy ((for such nonpartisan office)) occurs ((on or after the eleventh Tuesday prior to a primary but prior to the eleventh Tuesday before an election)) following the regular filing period and deadline to withdraw; or

33 (2) ((A nominee for judge of the superior court eligible after a 34 contested primary for a certificate of election by Article 4, section 35 29, Amendment 41 of the state Constitution, dies or is disqualified 36 within the ten-day period immediately following the last day allotted 37 for a candidate to withdraw; or 1 (3) A vacancy occurs in any nonpartisan office on or after the 2 eleventh Tuesday prior to a primary but prior to the eleventh Tuesday 3 before an election leaving an unexpired term to be filled by an 4 election for which filings have not been held.)) <u>A vacancy occurs in an</u> 5 office for which filings have not already been held, leaving an 6 unexpired term.

7 The filing officer shall provide notice of the vacancy and filing 8 period to newspapers, radio, and television in the county, and online. 9 The position shall appear on the general election ballots unless a 10 candidate for superior court judge is entitled to a certificate of 11 election pursuant to Article 4, section 29 of the state Constitution.

12 The candidate receiving a plurality of the votes cast for that 13 office in the general election shall be deemed elected. <u>This section</u> 14 <u>does not apply to voids in candidacy in the office of precinct</u> 15 <u>committee officer, which are filled by appointment pursuant to RCW</u> 16 <u>29A.28.071.</u>

17 Sec. 12. RCW 29A.24.191 and 2006 c 344 s 9 are each amended to 18 read as follows:

A scheduled election shall be lapsed, the office deemed stricken from the ballot, no purported write-in votes counted, and no candidate certified as elected, when((÷

(1) In an election for judge of the supreme court or superintendent of public instruction, a void in candidacy occurs on or after the eleventh Tuesday prior to a primary, public filings and the primary being an indispensable phase of the election process for such offices;

26 (2) Except as otherwise specified in RCW 29A.24.181, a nominee for 27 judge of the superior court entitled to a certificate of election 28 pursuant to Article 4, section 29, Amendment 41 of the state 29 Constitution dies or is disqualified on or after the eleventh Tuesday 30 prior to a primary;

31 (3) In other elections for nonpartisan office)) a void in candidacy 32 occurs ((or a vacancy occurs involving an unexpired term to be filled 33 on or after the eleventh Tuesday prior to an election)) following the 34 special three day filing period required by RCW 29A.24.181.

35 **Sec. 13.** RCW 29A.24.311 and 2004 c 271 s 117 are each amended to 36 read as follows:

Any person who desires to be a write-in candidate and have such 1 2 votes counted at a primary or election may file a declaration of candidacy with the officer designated in RCW 29A.24.070 not later than 3 4 the day ((before the primary or election)) ballots must be mailed according to RCW 29A.40.070. Declarations of candidacy for write-in 5 candidates must be accompanied by a filing fee in the same manner as б 7 required of other candidates filing for the office as provided in RCW 8 29A.24.091.

9 Votes cast for write-in candidates who have filed such declarations 10 of candidacy and write-in votes for persons appointed by major political parties pursuant to RCW 29A.28.021 need only specify the name 11 12 of the candidate in the appropriate location on the ballot in order to 13 be counted. Write-in votes cast for any other candidate, in order to be counted, must designate the office sought and position number or 14 political party, if the manner in which the write-in is done does not 15 make the office or position clear. 16

No person may file as a write-in candidate where:

(1) At a general election, the person attempting to file either filed as a write-in candidate for the same office at the preceding primary or the person's name appeared on the ballot for the same office at the preceding primary;

(2) The person attempting to file as a write-in candidate has already filed a valid write-in declaration for that primary or election, unless one or the other of the two filings is for the office of precinct committeeperson;

26 (3) The name of the person attempting to file already appears on 27 the ballot as a candidate for another office, unless one of the two offices for which he or she is a candidate is precinct committeeperson. 28 29 The declaration of candidacy shall be similar to that required by 30 RCW 29A.24.031. No write-in candidate filing under this section may be included in any voter's pamphlet produced under chapter 29A.32 RCW 31 32 unless that candidate qualifies to have his or her name printed on the general election ballot. The legislative authority of any jurisdiction 33 producing a local voter's pamphlet under chapter 29A.32 RCW may 34 35 provide, by ordinance, for the inclusion of write-in candidates in such 36 pamphlets.

1 Sec. 14. RCW 29A.28.041 and 2006 c 344 s 12 are each amended to 2 read as follows:

3 (1) Whenever a vacancy occurs in the United States house of 4 representatives or the United States senate from this state, the 5 governor shall order a special election to fill the vacancy. Minor 6 political party candidates and independent candidates may be nominated 7 through the convention procedures provided in chapter 29A.20 RCW.

8 (2) Within ten days of such vacancy occurring, he or she shall issue a writ of election fixing a date for the ((special vacancy 9 10 election not less than ninety days after the issuance of the writ, 11 fixing a date for the primary for nominating major political party 12 candidates for the special vacancy election not less than thirty days 13 before the day fixed for holding the special vacancy election, fixing the dates for the special filing period, and designating the term or 14 15 part of the term for which the vacancy exists)) primary at least seventy days after issuance of the writ, and fixing a date for the 16 election at least seventy days after the date of the primary. If the 17 vacancy is in the office of United States representative, the writ of 18 19 election shall specify the congressional district that is vacant.

(3) If the vacancy occurs less than ((six)) eight months before a state general election and before the ((second Friday following the)) close of the filing period for that general election, the special primary, special vacancy election, and minor party and independent candidate nominating conventions must be held in concert with the state primary and state general election in that year.

26 (4) If the vacancy occurs on or after the first day for filing 27 under RCW 29A.24.050 and on or before the ((second Friday following the)) close of the filing period, a special filing period of three 28 normal business days shall be fixed by the governor and notice thereof 29 30 given to all media, including press, radio, and television within the area in which the vacancy election is to be held, to the end that, 31 32 insofar as possible, all interested persons will be aware of such filing period. ((The last day of the filing period shall not be later 33 than the sixth Tuesday before the primary at which major political 34 35 party candidates are to be nominated.)) The names of major political 36 party candidates who have filed valid declarations of candidacy during 37 this three-day period shall appear on the approaching primary ballot.

The requirements of RCW 29A.20.131 do not apply to a minor political
 party or independent candidate convention held under this subsection.

3 (5) If the vacancy occurs later than the ((second Friday following 4 the)) close of the filing period, a special primary((, special)) and 5 vacancy election((, and the minor party and independent candidate 6 conventions)) to fill the position shall be held after the next state 7 general election but, in any event, no later than the ninetieth day 8 following the November election.

9 Sec. 15. RCW 29A.36.010 and 2005 c 2 s 12 are each reenacted and 10 amended to read as follows:

11 ((On or before the day following the last day allowed for 12 candidates to withdraw under RCW 29A.24.130)) Not later than the Tuesday following the regular filing period, the secretary of state 13 shall certify to each county auditor a list of the candidates who have 14 filed declarations of candidacy in his or her office for the primary. 15 16 For each office, the certificate shall include the name of each candidate, his or her address, and his or her party preference or 17 independent designation as shown on filed declarations. 18

19 Sec. 16. RCW 29A.40.070 and 2006 c 344 s 13 are each amended to 20 read as follows:

21 (1) Except where a recount or litigation ((under RCW 29A.68.011)) 22 is pending, the county auditor ((shall have sufficient absentee ballots 23 available for absentee voters of that county, other than overseas 24 voters and service voters, at least twenty days before any primary, 25 general election, or special election. The county auditor)) must mail 26 ((absentee)) ballots to each voter ((for whom the county auditor has received a request nineteen days before the primary or election)) at 27 least eighteen days before ((the)) each primary or election, and as 28 soon as possible for all subsequent registration changes. 29 ((For a 30 request for an absentee ballot received after the nineteenth day before the primary or election, the county auditor shall make every effort to 31 32 mail ballots within one business day, and shall mail the ballots within 33 two business days)).

(2) ((At least thirty days before any primary, general election, or
 special election, the county auditor shall mail ballots to all overseas
 and service voters.)) Except where a recount or litigation is pending,

the county auditor must mail ballots to each service and overseas voter at least thirty days before each special election and at least forty-five days before each primary or general election. A request for a ballot made by an overseas or service voter after that day must be processed immediately.

6 (3) <u>A registered voter may obtain a replacement ballot if the</u> 7 <u>ballot is destroyed, spoiled, lost, or not received by the voter. The</u> 8 <u>voter may obtain the ballot by telephone request, by mail,</u> 9 <u>electronically, or in person. The county auditor shall keep a record</u> 10 <u>of each request for a replacement ballot.</u>

Proceedings of the canvassing board are public under chapter 42.30 RCW. Subject to reasonable and equitable guidelines adopted by the canvassing board, all interested persons may attend and witness a recount.
