AN ACT Relating to a state Indian child welfare act; amending RCW 13.32A.152, 13.34.040, 13.34.070, 13.34.105, 13.34.130, 13.34.132, 13.34.190, 26.10.034, 26.33.040, 26.33.240, and 74.13.350; reenacting and amending RCW 13.34.030, 13.34.065, and 13.34.136; adding a new chapter to Title 13 RCW; and repealing RCW 13.34.250.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 <u>NEW SECTION.</u> Sec. 1. SHORT TITLE. This chapter shall be known 8 and cited as the "Washington state Indian child welfare act."

9 <u>NEW SECTION.</u> Sec. 2. APPLICATION. This chapter shall apply in 10 all child custody proceedings as that term is defined in this chapter. 11 Whenever there is a conflict between chapter 13.32A, 13.34, 13.36, 12 26.10, or 26.33 RCW, the provisions of this chapter shall apply.

13 <u>NEW_SECTION.</u> Sec. 3. INTENT. The legislature finds that the 14 state is committed to protecting the essential tribal relations and 15 best interests of Indian children by promoting practices designed to 16 prevent out-of-home placement of Indian children that is inconsistent 17 with the rights of the parents, the health, safety, or welfare of the

children, or the interests of their tribe. Whenever out-of-home 1 2 placement of an Indian child is necessary in a proceeding subject to the terms of the federal Indian child welfare act and in this chapter, 3 the best interests of the Indian child may be served by placing the 4 5 Indian child in accordance with the placement priorities expressed in this chapter. The legislature further finds that where placement away б 7 from the parent or Indian custodian is necessary for the child's safety, the state is committed to a placement that reflects and honors 8 the unique values of the child's tribal culture and is best able to 9 10 assist the Indian child in establishing, developing, and maintaining a political, cultural, social, and spiritual relationship with the 11 child's tribe and tribal community. 12

13 It is the intent of the legislature that this chapter is a step in 14 clarifying existing laws and codifying existing policies and practices. 15 This chapter shall not be construed to reject or eliminate current 16 policies and practices that are not included in its provisions.

17 The legislature further intends that nothing in this chapter is intended to interfere with policies and procedures that are derived 18 from agreements entered into between the department and a tribe or 19 tribes, as authorized by section 109 of the federal Indian child 20 21 welfare act. The legislature finds that this chapter specifies the 22 minimum requirements that must be applied in a child custody proceeding 23 and does not prevent the department from providing a higher standard of 24 protection to the right of any Indian child, parent, Indian custodian, or Indian child's tribe. 25

It is also the legislature's intent that the department's policy manual on Indian child welfare, the tribal-state agreement, and relevant local agreements between individual federally recognized tribes and the department should serve as persuasive guides in the interpretation and implementation of the federal Indian child welfare act, this chapter, and other relevant state laws.

32 <u>NEW_SECTION.</u> Sec. 4. DEFINITIONS. The definitions in this 33 section apply throughout this chapter unless the context clearly 34 requires otherwise.

35 (1) "Active efforts" means the following:

36 (a) In any foster care placement or termination of parental rights
 37 proceeding of an Indian child under chapter 13.34 RCW and this chapter

where the department or a supervising agency as defined in RCW 1 2 74.13.020 has a statutory or contractual duty to provide services to, or procure services for, the parent or parents or Indian custodian, or 3 is providing services to a parent or parents or Indian custodian 4 pursuant to a disposition order entered pursuant to RCW 13.34.130, the 5 department or supervising agency shall make timely and diligent efforts б 7 to provide or procure such services, including engaging the parent or parents or Indian custodian in reasonably available and culturally 8 appropriate preventive, remedial, or rehabilitative services. 9 This 10 shall include those services offered by tribes and Indian organizations whenever possible. At a minimum "active efforts" shall include: 11

12 (i) In any dependency proceeding under chapter 13.34 RCW seeking 13 out-of-home placement of an Indian child in which the department or 14 supervising agency provided voluntary services to the parent, parents, or Indian custodian prior to filing the dependency petition, a showing 15 16 to the court that the department or supervising agency social workers 17 actively worked with the parent, parents, or Indian custodian to engage them in remedial services and rehabilitation programs to prevent the 18 breakup of the family beyond simply providing referrals to such 19 services. 20

21 (ii) In any dependency proceeding under chapter 13.34 RCW, in which 22 the petitioner is seeking the continued out-of-home placement of an Indian child, the department or supervising agency must show to the 23 24 court that it has actively worked with the parent, parents, or Indian 25 custodian in accordance with existing court orders and the individual service plan to engage them in remedial services and rehabilitative 26 27 programs to prevent the breakup of the family beyond simply providing referrals to such services. 28

(iii) In any termination of parental rights proceeding regarding an 29 Indian child under chapter 13.34 RCW in which the department or 30 supervising agency provided services to the parent, parents, or Indian 31 32 custodian, a showing to the court that the department or supervising agency social workers actively worked with the parent, parents, or 33 Indian custodian to engage them in remedial services and rehabilitation 34 35 programs ordered by the court or identified in the department or 36 supervising agency's individual service and safety plan beyond simply 37 providing referrals to such services.

1 (b) In any foster care placement or termination of parental rights 2 proceeding in which the petitioner does not otherwise have a statutory 3 or contractual duty to directly provide services to, or procure 4 services for, the parent or Indian custodian, "active efforts" means a 5 documented, concerted, and good faith effort to facilitate the parent's 6 or Indian custodian's receipt of and engagement in services capable of 7 meeting the criteria set out in (a) of this subsection.

(2) "Best interests of the Indian child" means the use of practices 8 in accordance with the federal Indian child welfare act, this chapter, 9 and other applicable law, that are designed to accomplish the 10 following: (a) Protect the safety, well-being, development, and 11 stability of the Indian child; (b) prevent the unnecessary out-of-home 12 13 placement of the Indian child; (c) acknowledge the right of Indian 14 tribes to maintain their existence and integrity which will promote the stability and security of their children and families; (d) recognize 15 the value to the Indian child of establishing, developing, 16 or maintaining a political, cultural, social, and spiritual relationship 17 with the Indian child's tribe and tribal community; and (e) in a 18 proceeding under this chapter where out-of-home placement is necessary, 19 to prioritize placement of the Indian child in accordance with the 20 21 placement preferences of this chapter.

22

(3) "Child custody proceeding" includes:

(a) "Foster care placement" which means any action removing an
Indian child from his or her parent or Indian custodian for temporary
placement in a foster home, institution, or with a relative, guardian,
conservator, or suitable other person where the parent or Indian
custodian cannot have the child returned upon demand, but where
parental rights have not been terminated;

(b) "Termination of parental rights" which means any actionresulting in the termination of the parent-child relationship;

31 (c) "Preadoptive placement" which means the temporary placement of 32 an Indian child in a foster home or institution after the termination 33 of parental rights but before or in lieu of adoptive placement; and

(d) "Adoptive placement" which means the permanent placement of an
 Indian child for adoption, including any action resulting in a final
 decree of adoption.

37 These terms shall not include a placement based upon an act which,

if committed by an adult, would be deemed a crime or upon an award, in
 a dissolution proceeding of custody to one of the parents.

3 (4) "Court of competent jurisdiction" means a federal court, or a 4 state court that entered an order in a child custody proceeding 5 involving an Indian child, as long as the state court had proper 6 subject matter jurisdiction in accordance with this chapter and the 7 laws of that state, or a tribal court that had or has exclusive or 8 concurrent jurisdiction pursuant to 25 U.S.C. Sec. 1911.

9 (5) "Department" means the department of social and health services 10 and any of its divisions. "Department" also includes supervising 11 agencies as defined in RCW 74.13.020(12) with which the department 12 entered into a contract to provide services, care, placement, case 13 management, contract monitoring, or supervision to children subject to 14 a petition filed under chapter 13.34 or 26.33 RCW.

15 (6) "Indian" means a person who is a member of an Indian tribe, or 16 who is an Alaska native and a member of a regional corporation as 17 defined in 43 U.S.C. Sec. 1606.

18 (7) "Indian child" means an unmarried and unemancipated Indian 19 person who is under eighteen years of age and is either: (a) A member 20 of an Indian tribe; or (b) eligible for membership in an Indian tribe 21 and is the biological child of a member of an Indian tribe.

(8) "Indian child's family" or "extended family member" means an individual, defined by the law or custom of the child's tribe, as a relative of the child. If the child's tribe does not identify such individuals by law or custom, the term means an adult who is the Indian child's grandparent, aunt, uncle, brother, sister, brother-in-law, sister-in-law, niece, nephew, first or second cousin, or step-parent, even following termination of the marriage.

(9) "Indian child's tribe" means a tribe in which an Indian childis a member or eligible for membership.

(10) "Indian custodian" means an Indian person who under tribal law, tribal custom, or state law, has legal or temporary physical custody of an Indian child, or to whom the parent has transferred temporary care, physical custody, and control of an Indian child.

35 (11) "Indian tribe" or "tribe" means any Indian tribe, band, 36 nation, or other organized group or community of Indians recognized as 37 eligible for the services provided to Indians by the secretary of the

interior because of their status as Indians, including any Alaska
 native village as defined in 43 U.S.C. Sec. 1602(c).

3 (12) "Member" and "membership" means a determination by an Indian
4 tribe that a person is a member or eligible for membership in that
5 Indian tribe.

6 (13) "Parent" means a biological parent or parents of an Indian 7 child or a person who has lawfully adopted an Indian child, including 8 adoptions made under tribal law or custom. "Parent" does not include 9 an unwed father whose paternity has not been acknowledged or 10 established under chapter 26.26 RCW or the applicable laws of other 11 states.

(14) "Secretary of the interior" means the secretary of the UnitedStates department of the interior.

14 (15) "Tribal court" means a court or body vested by an Indian tribe 15 with jurisdiction over child custody proceedings, including but not 16 limited to a federal court of Indian offenses, a court established and 17 operated under the code or custom of an Indian tribe, or an 18 administrative body of an Indian tribe vested with authority over child 19 custody proceedings.

(16) "Tribal customary adoption" means adoption or other process through the tribal custom, traditions, or laws of an Indian child's tribe by which the Indian child is permanently placed with a nonparent and through which the nonparent is vested with the rights, privileges, and obligations of a legal parent. Termination of the parent-child relationship between the Indian child and the biological parent is not required to effect or recognize a tribal customary adoption.

27 <u>NEW SECTION.</u> Sec. 5. DETERMINATION OF INDIAN STATUS. Any party seeking the foster care placement of, termination of parental rights 28 over, or the adoption of a child must make a good faith effort to 29 determine whether the child is an Indian child. This shall be done by 30 31 consultation with the child's parent or parents, any person who has custody of the child or with whom the child resides, and any other 32 person that reasonably can be expected to have information regarding 33 the child's possible membership or eligibility for membership in an 34 Indian tribe to determine if the child is an Indian child, and by 35 36 contacting any Indian tribe in which the child may be a member or may 37 be eligible for membership. Preliminary contacts for the purpose of

р. б

1 making a good faith effort to determine a child's possible Indian 2 status, do not constitute legal notice as required by section 7 of this 3 act.

<u>NEW SECTION.</u> Sec. 6. JURISDICTION. (1) An Indian tribe shall have exclusive jurisdiction over any child custody proceeding involving an Indian child who resides or is domiciled within the reservation of that tribe, unless the tribe has consented to the state's concurrent jurisdiction, the tribe has expressly declined to exercise its exclusive jurisdiction, or the state is exercising emergency jurisdiction in strict compliance with section 14 of this act.

(2) If an Indian child is already a ward of a tribal court at the start of the child custody proceeding, the Indian tribe may retain exclusive jurisdiction, notwithstanding the residence or domicile of the child.

15 <u>NEW</u> <u>SECTION</u>. Sec. 7. NOTICE. (1) In any involuntary child custody proceeding seeking the foster care placement of, or the 16 termination of parental rights to, a child in which the petitioning 17 party or the court knows, or has reason to know, that the child is or 18 19 may be an Indian child as defined in this chapter, the petitioning 20 party shall notify the parent or Indian custodian and the Indian child's tribe or tribes, by certified mail, return receipt requested, 21 22 and by use of a mandatory Indian child welfare act notice. If the 23 identity or location of the parent or Indian custodian and the tribe cannot be determined, such notice shall be given to the secretary of 24 25 the interior by registered mail, return receipt requested, in accordance with the regulations of the bureau of Indian affairs. 26 The secretary of the interior has fifteen days after receipt to provide the 27 requisite notice to the parent or Indian custodian and the tribe. No 28 foster care placement or termination of parental rights proceeding 29 30 shall be held until at least ten days after receipt of notice by the parent or Indian custodian and the tribe. 31 The parent or Indian custodian or the tribe shall, upon request, be granted up to twenty 32 additional days to prepare for the proceeding. 33

34 (2) The determination of the Indian status of a child shall be made
 35 as soon as practicable in order to serve the best interests of the
 36 Indian child and protect the interests of the child's tribe.

1 (3)(a) A written determination by an Indian tribe that a child is 2 a member of or eligible for membership in that tribe, or testimony by 3 the tribe attesting to such status shall be conclusive that the child 4 is an Indian child;

(b) A written determination by an Indian tribe that a child is not 5 a member of or eligible for membership in that tribe, or testimony by 6 7 the tribe attesting to such status shall be conclusive that the child is not a member or eligible for membership in that tribe. 8 Such determinations are presumptively those of the tribe where submitted in 9 the form of a tribal resolution, or signed by or testified to by the 10 person(s) authorized by the tribe's governing body to speak for the 11 tribe, or by the tribe's agent designated to receive notice under the 12 federal Indian child welfare act where such designation is published in 13 the federal register; 14

15 (c) Where a tribe provides no response to notice under section 7 of 16 this act, such nonresponse shall not constitute evidence that the child 17 is not a member or eligible for membership. Provided, however, that 18 under such circumstances the party asserting application of the federal 19 Indian child welfare act, or this chapter, will have the burden of 20 proving by a preponderance of the evidence that the child is an Indian 21 child.

(4)(a) Where a child has been determined not to be an Indian child, any party to the proceeding, or an Indian tribe that subsequently determines the child is a member, may, during the pendency of any child custody proceeding to which this chapter or the federal Indian child welfare act applies, move the court for redetermination of the child's Indian status based upon new evidence, redetermination by the child's tribe, or newly conferred federal recognition of the tribe.

(b) This subsection (4) does not affect the rights afforded under25 U.S.C. Sec. 1914.

31 <u>NEW SECTION.</u> **Sec. 8.** TRANSFER OF JURISDICTION. (1) In any proceeding for the foster care placement of, or termination of parental 32 rights to, an Indian child who is not domiciled or residing within the 33 reservation of the Indian child's tribe, the court shall, in the 34 absence of good cause to the contrary, transfer the proceeding to the 35 36 jurisdiction of the Indian child's tribe, upon the motion of any of the 37 following persons:

- (a) Either of the child's parents; 1
- 2 (b) The child's Indian custodian; (c) The child's tribe; or
- 3

4

(d) The child, if age twelve or older.

5 The transfer shall be subject to declination by the tribe. The tribe shall have seventy-five days to affirmatively respond to a motion or 6 7 order transferring jurisdiction to the tribal court. A failure of the tribe to respond within the seventy-five day period shall be construed 8 as a declination to accept transfer of the case. 9

(2) If the child's tribe has not formally intervened, the moving 10 party shall serve a copy of the motion and all supporting documents on 11 the tribal court to which the moving party seeks transfer. 12

(3) If either of the Indian child's parents objects to transfer of 13 the proceeding to the Indian child's tribe, the court shall not 14 15 transfer the proceeding.

16 (4) Following entry of an order transferring jurisdiction to the 17 Indian child's tribe:

(a) Upon receipt of an order from a tribal court accepting 18 19 jurisdiction, the state court shall dismiss the child custody 20 proceeding without prejudice.

21 (b) Pending receipt of such tribal court order, the state court may 22 conduct additional hearings and enter orders which strictly comply with the requirements of the federal Indian child welfare act and this 23 24 chapter. The state court shall not enter a final order in any child 25 custody proceeding, except an order dismissing the proceeding and returning the Indian child to the care of the parent or Indian 26 27 custodian from whose care the child was removed, while awaiting receipt of a tribal court order accepting jurisdiction, or in the absence of a 28 tribal court order or other formal written declination of jurisdiction. 29

(c) If the Indian child's tribe declines jurisdiction, the state 30 31 court shall enter an order vacating the order transferring jurisdiction 32 and proceed with adjudication of the child custody matter in strict compliance with the federal Indian child welfare act, this chapter, and 33 any applicable tribal-state agreement. 34

NEW SECTION. Sec. 9. INTERVENTION. The Indian child, the Indian 35 36 child's tribe or tribes, and the Indian custodian have the right to

intervene at any point in any child custody proceeding involving the
 Indian child.

3 <u>NEW SECTION.</u> Sec. 10. FULL FAITH AND CREDIT. The state shall 4 give full faith and credit to the public acts, records, judicial 5 proceedings, and judgments of any Indian tribe applicable to Indian 6 child custody proceedings.

7 <u>NEW SECTION.</u> Sec. 11. RIGHT TO COUNSEL. In any child custody 8 proceeding under this chapter in which the court determines the Indian 9 child's parent or Indian custodian is indigent, the parent or Indian 10 custodian shall have the right to court-appointed counsel. The court 11 may, in its discretion, appoint counsel for the Indian child upon a 12 finding that the appointment is in the best interests of the Indian 13 child.

14 <u>NEW SECTION.</u> Sec. 12. RIGHT TO ACCESS TO EVIDENCE. Each party to 15 a child custody proceeding involving an Indian child shall have the 16 right to examine all reports or other documents filed with the court 17 upon which any decision with respect to the proceeding may be based.

NEW SECTION. Sec. 13. EVIDENTIARY REQUIREMENTS. (1) A party seeking to effect an involuntary foster care placement of or the involuntary termination of parental rights to an Indian child shall satisfy the court that active efforts have been made to provide remedial services and rehabilitative programs designed to prevent the breakup of the Indian family and that these efforts have proved unsuccessful.

(2) No involuntary foster care placement may be ordered in a child 25 custody proceeding in the absence of a determination, supported by 26 27 clear and convincing evidence, including testimony of qualified expert 28 witnesses, that the continued custody of the child by the parent or Indian custodian is likely to result in serious emotional or physical 29 damage to the child. For purposes of this subsection, any harm that 30 may result from interfering with the bond or attachment between the 31 32 foster parent and the child shall not be the sole basis or primary 33 reason for continuing the child in foster care.

(3) No involuntary termination of parental rights may be ordered in 1 2 a child custody proceeding in the absence of a determination, supported by evidence beyond a reasonable doubt, including testimony of qualified 3 expert witnesses, that the continued custody of the child by the parent 4 or Indian custodian is likely to result in serious emotional or 5 physical damage to the child. For the purposes of this subsection, any 6 7 harm that may result from interfering with the bond or attachment that may have formed between the child and a foster care provider shall not 8 be the sole basis or primary reason for termination of parental rights 9 10 over an Indian child.

(4)(a) For purposes of this section, "qualified expert witness" 11 means a person who provides testimony in a proceeding under this 12 13 chapter to assist a court in the determination of whether the continued custody of the child by, or return of the child to, the parent, 14 parents, or Indian custodian, is likely to result in serious emotional 15 or physical damage to the child. In any proceeding in which the 16 17 child's Indian tribe has intervened pursuant to section 9 of this act or, if the department is the petitioner and the Indian child's tribe 18 has entered into a local agreement with the department for the 19 provision of child welfare services, the petitioner shall contact the 20 21 tribe and ask the tribe to identify a tribal member or other person of 22 the tribe's choice who is recognized by the tribe as knowledgeable regarding tribal customs as they pertain to family organization or 23 24 child rearing practices. The petitioner shall notify the child's Indian tribe of the need to provide a "qualified expert witness" at 25 least twenty days prior to any evidentiary hearing in which the 26 27 testimony of the witness will be required. If the child's Indian tribe does not identify a "qualified expert witness" for the proceeding on a 28 timely basis, the petitioner may proceed to identify such a witness 29 pursuant to (b) of this subsection. 30

31 (b) In any proceeding in which the child's Indian tribe has not 32 intervened or entered into a local agreement with the department for 33 the provision of child welfare services, or a child's Indian tribe has 34 not responded to a request to identify a "qualified expert witness" for 35 the proceeding on a timely basis, the petitioner shall provide a 36 "qualified expert witness" who meets one or more of the following 37 requirements in descending order of preference:

1 (i) A member of the child's Indian tribe or other person of the 2 tribe's choice who is recognized by the tribe as knowledgeable 3 regarding tribal customs as they pertain to family organization or 4 child rearing practices for this purpose;

5 (ii) Any person having substantial experience in the delivery of 6 child and family services to Indians, and extensive knowledge of 7 prevailing social and cultural standards and child rearing practices 8 within the Indian child's tribe;

9 (iii) Any person having substantial experience in the delivery of 10 child and family services to Indians, and knowledge of prevailing 11 social and cultural standards and child rearing practices in Indian 12 tribes with cultural similarities to the Indian child's tribe; or

13 (iv) A professional person having substantial education and 14 experience in the area of his or her specialty.

(c) When the petitioner is the department or a supervising agency, 15 16 the currently assigned department or agency caseworker or the 17 caseworker's supervisor may not testify as a "qualified expert witness" for purposes of this section. Nothing in this section shall bar the 18 assigned department or agency caseworker or the caseworker's supervisor 19 from testifying as an expert witness for other purposes in a proceeding 20 21 under this chapter. Nothing in this section shall bar other department 22 or supervising agency employees with appropriate expert qualifications or experience from testifying as a "qualified expert witness" in a 23 24 proceeding under this chapter. Nothing in this section shall bar the petitioner or any other party in a proceeding under this chapter from 25 providing additional witnesses or expert testimony, subject to the 26 27 approval of the court, on any issue before the court including the determination of whether the continued custody of the child by, or 28 return of the child to, the parent, parents, or Indian custodian, is 29 likely to result in serious emotional or physical damage to the child. 30

NEW SECTION. Sec. 14. EMERGENCY REMOVAL OF AN INDIAN CHILD. (1) Notwithstanding any other provision of federal or state law, nothing shall be construed to prevent the department or law enforcement from the emergency removal of an Indian child who is a resident of or is domiciled on an Indian reservation, but is temporarily located off the reservation, from his or her parent or Indian custodian or the emergency placement of such child in a foster home, under applicable
 state law, to prevent imminent physical damage or harm to the child.

(2) The department or law enforcement agency shall ensure that the 3 emergency removal or placement terminates immediately when such removal 4 5 or placement is no longer necessary to prevent imminent physical damage or harm to the child and shall expeditiously initiate a child custody 6 7 proceeding subject to the provisions of the federal Indian child welfare act and this chapter to transfer the child to the jurisdiction 8 9 of the appropriate Indian tribe or restore the child to the child's parent or Indian custodian, if appropriate. 10

(3) When the nature of the emergency allows, the department must 11 notify the child's tribe before the removal has occurred. If prior 12 notification is not possible, the department shall notify the child's 13 tribe by the quickest means possible. The notice must contain the 14 basis for the Indian child's removal, the time, date, and place of the 15 16 initial hearing, and the tribe's right to intervene and participate in 17 the proceeding. This notice shall not constitute the notice required under section 7 of this act for purposes of subsequent dependency, 18 termination of parental rights, or adoption proceedings. 19

20 NEW SECTION. Sec. 15. CONSENT. (1) If an Indian child's parent 21 or Indian custodian voluntarily consents to a foster care placement of the child or to termination of parental rights, the consent is not 22 valid unless executed in writing and recorded before a judge of a court 23 24 of competent jurisdiction and accompanied by the judge's certificate that the terms and consequences of the consent were fully explained in 25 26 detail and were fully understood by the parent or Indian custodian. The court must also certify that either the parent or Indian custodian 27 fully understood the explanation in English or that it was interpreted 28 into a language that the parent or Indian custodian understood. 29 Any 30 consent for release of custody given prior to, or within ten days 31 after, the birth of the Indian child shall not be valid.

(2) An Indian child's parent or Indian custodian may withdraw
 consent to a voluntary foster care placement at any time and, upon the
 withdrawal of consent, the child shall be returned to the parent or
 Indian custodian.

36 (3) In a voluntary proceeding for termination of parental rights37 to, or adoptive placement of, an Indian child, the consent of the

parent may be withdrawn for any reason at any time prior to the entry of an order terminating parental rights or a final decree of adoption, and the child shall be returned to the parent.

4 (4) After the entry of a final decree of adoption of an Indian 5 child, the parent may withdraw consent to the adoption upon the grounds 6 that consent was obtained through fraud or duress. Upon a finding that 7 such consent was obtained through fraud or duress the court shall 8 vacate the decree and return the child to the parent. No adoption 9 which has been effective for at least two years may be invalidated 10 under this section unless otherwise allowed by state law.

NEW SECTION. Sec. 16. IMPROPER REMOVAL OF AN INDIAN CHILD. If a 11 petitioner in a child custody proceeding under this chapter has 12 improperly removed the child from the custody of the parent or Indian 13 custodian or has improperly retained custody after a visit or other 14 temporary relinquishment of custody, the court 15 shall decline 16 jurisdiction over the petition and shall immediately return the child 17 to the child's parent or Indian custodian unless returning the child to 18 the parent or Indian custodian would subject the child to substantial 19 and immediate danger or threat of such danger.

<u>NEW SECTION.</u> Sec. 17. REMOVAL OF INDIAN CHILD FROM ADOPTIVE OR 20 21 FOSTER CARE PLACEMENT. (1) If a final decree of adoption of an Indian 22 child has been vacated or set aside or the adoptive parents voluntarily 23 consent to the termination of their parental rights to the child, the biological parent or prior Indian custodian may petition to have the 24 25 child returned to their custody and the court shall grant the request unless there is a showing by clear and convincing evidence that return 26 of custody to the biological parent or prior Indian custodian is not in 27 the best interests of the Indian child. 28

(2) If an Indian child is removed from a foster care placement or a preadoptive or adoptive home for the purpose of further foster care, preadoptive, or adoptive placement, the placement shall be in accordance with this chapter, except when an Indian child is being returned to the parent or Indian custodian from whose custody the child was originally removed.

1 NEW SECTION. Sec. **18.** PLACEMENT PREFERENCES. (1) When an 2 emergency removal, foster care placement, or preadoptive placement of 3 an Indian child is necessary, a good faith effort will be made to place 4 the Indian child: 5 (a) In the least restrictive setting; (b) Which most approximates a family situation; 6 7 (c) Which is in reasonable proximity to the Indian child's home; 8 and (d) In which the Indian child's special needs, if any, will be met. 9 10 (2) In any foster care or preadoptive placement, a preference shall 11 be given, in absence of good cause to the contrary, to the child's placement with one of the following: 12 13 (a) A member of the child's extended family. 14 (b) A foster home licensed, approved, or specified by the child's 15 tribe. 16 (c) An Indian foster home licensed or approved by an authorized 17 non-Indian licensing authority. (d) A child foster care agency approved by an Indian tribe or 18 operated by an Indian organization which has a program suitable to meet 19 20 the Indian child's needs. 21 (e) A non-Indian child foster care agency approved by the child's 22 tribe. 23 (f) A non-Indian family that is committed to: 24 (i) Promoting and allowing appropriate extended family visitation; (ii) Establishing, maintaining, and strengthening the child's 25 26 relationship with his or her tribe or tribes; and 27 (iii) Participating in the cultural and ceremonial events of the 28 child's tribe. (3) In the absence of good cause to the contrary, any adoptive or 29 other permanent placement of an Indian child, preference shall be given 30 31 to a placement with one of the following, in descending priority order: 32 (a) Extended family members; 33 (b) An Indian family of the same tribe as the child; (c) An Indian family that is of a similar culture to the child's 34 35 tribe; (d) Another Indian family; or 36 37 (e) Any other family which can provide a suitable home for an 38 Indian child, such suitability to be determined in consultation with

the Indian child's tribe or, in proceedings under chapter 13.34 RCW where the Indian child is in the custody of the department or a supervising agency and the Indian child's tribe has not intervened or participated, the local Indian child welfare advisory committee.

5 (4) Notwithstanding the placement preferences listed in subsections 6 (2) and (3) of this section, if a different order of placement 7 preference is established by the child's tribe, the court or agency 8 effecting the placement shall follow the order of preference 9 established by the tribe so long as the placement is in the least 10 restrictive setting appropriate to the particular needs of the child.

(5) Where appropriate, the preference of the Indian child or his or her parent shall be considered by the court. Where a consenting parent evidences a desire for anonymity, the court or agency shall give weight to such desire in applying the preferences.

15 (6) The standards to be applied in meeting the preference 16 requirements of this section shall be the prevailing social and 17 cultural standards of the Indian community in which the parent or 18 extended family members of an Indian child reside, or with which the 19 parent or extended family members maintain social and cultural ties.

20 (7) Nothing in this section shall prevent the department or the 21 court from placing the child with a parent to effectuate a permanent 22 plan regardless of the parent's relationship to the child's tribe.

23 NEW SECTION. Sec. **19.** COMPLIANCE. The department, (1) in 24 consultation with Indian tribes, shall establish standards and procedures for the department's review of cases subject to this chapter 25 26 and methods for monitoring the department's compliance with provisions of the federal Indian child welfare act and this chapter. 27 These standards and procedures and the monitoring methods shall also be 28 integrated into the department's child welfare contracting and contract 29 30 monitoring process.

(2) Nothing in this chapter shall affect, impair, or limit rights
 or remedies provided to any party under the federal Indian child
 welfare act, 25 U.S.C. Sec. 1914.

(b) A description of the specific services and activities, for both the parents and child, that are needed in order to prevent serious harm to the child; the reasons why such services and activities are likely to be useful; the availability of any proposed services; and the agency's overall plan for ensuring that the services will be delivered. The description shall identify the services chosen and approved by the parent;

(1)(a) When a child is taken into custody, the court shall hold a shelter care hearing within seventy-two hours, excluding Saturdays, Sundays, and holidays. The primary purpose of the shelter care hearing is to determine whether the child can be immediately and safely returned home while the adjudication of the dependency is pending.

(b) Any parent, guardian, or legal custodian who for good cause is 18 unable to attend the shelter care hearing may request that a subsequent 19 20 shelter care hearing be scheduled. The request shall be made to the 21 clerk of the court where the petition is filed prior to the initial shelter care hearing. Upon the request of the parent, the court shall 22 23 schedule the hearing within seventy-two hours of the request, excluding 24 Saturdays, Sundays, and holidays. (f) Whether it is in the best interest of the child to remain 18 enrolled in the school, developmental program, or child care the child 19 was in prior to placement and what efforts have been made to maintain 20 21 the child in the school, program, or child care if it would be in the 22 best interest of the child to remain in the same school, program, or 23 child care;

(g) Appointment of a guardian ad litem or attorney;

25 (h) Whether the child is or may be an Indian child as defined in ((25 U.S.C. Sec. 1903)) section 4 of this act, whether the provisions 26 27 of the federal Indian child welfare act or chapter 13. --- RCW (the new chapter created in section 35 of this act) apply, and whether there is 28 compliance with the federal Indian child welfare act and chapter 13.---29 RCW (the new chapter created in section 35 of this act), including 30 notice to the child's tribe; 31

32 (i) Whether, as provided in RCW 26.44.063, restraining orders, or orders expelling an allegedly abusive household member from the home of 33 a nonabusive parent, guardian, or legal custodian, will allow the child 34 to safely remain in the home; 35

(j) Whether any orders for examinations, evaluations, or immediate 36 37 services are needed. The court may not order a parent to undergo

examinations, evaluation, or services at the shelter care hearing
 unless the parent agrees to the examination, evaluation, or service;

3 (k) The terms and conditions for parental, sibling, and family4 visitation.

5 (5)(a) The court shall release a child alleged to be dependent to 6 the care, custody, and control of the child's parent, guardian, or 7 legal custodian unless the court finds there is reasonable cause to 8 believe that:

9 (i) After consideration of the specific services that have been 10 provided, reasonable efforts have been made to prevent or eliminate the 11 need for removal of the child from the child's home and to make it 12 possible for the child to return home; and

13 (ii)(A) The child has no parent, guardian, or legal custodian to 14 provide supervision and care for such child; or

(B) The release of such child would present a serious threat of substantial harm to such child, notwithstanding an order entered pursuant to RCW 26.44.063; or

(C) The parent, guardian, or custodian to whom the child could bereleased has been charged with violating RCW 9A.40.060 or 9A.40.070.

(b) If the court does not release the child to his or her parent, 20 21 guardian, or legal custodian, the court shall order placement with a 22 relative or other suitable person as described in RCW 13.34.130(1)(b), unless there is reasonable cause to believe the health, safety, or 23 24 welfare of the child would be jeopardized or that the efforts to 25 reunite the parent and child will be hindered. The court must also determine whether placement with the relative or other suitable person 26 27 is in the child's best interests. The relative or other suitable person must be willing and available to: 28

29 (i) Care for the child and be able to meet any special needs of the 30 child;

31 (ii) Facilitate the child's visitation with siblings, if such 32 visitation is part of the supervising agency's plan or is ordered by 33 the court; and

(6)(a) A shelter care order issued pursuant to this section shall include the requirement for a case conference as provided in RCW 13.34.067. However, if the parent is not present at the shelter care hearing, or does not agree to the case conference, the court shall not include the requirement for the case conference in the shelter care order.

32 (b) If the court orders a case conference, the shelter care order 33 shall include notice to all parties and establish the date, time, and 34 location of the case conference which shall be no later than thirty 35 days before the fact-finding hearing.

When an infant has been abandoned, as defined in RCW 13.34.030, and the abandonment has been proved beyond a reasonable doubt, then RCW 13.34.180(1) (c) and (d) may be waived; or 1 (iii) The allegation under RCW 13.34.180(2) is established beyond 2 a reasonable doubt. In determining whether RCW 13.34.180(1) (e) and 3 (f) are established beyond a reasonable doubt, the court shall consider 4 whether one or more of the aggravated circumstances listed in RCW 5 13.34.132 exist; or

6 (iv) The allegation under RCW 13.34.180(3) is established beyond a 7 reasonable doubt; and

(b) Such an order is in the best interests of the child.

As used in this section, "out-of-home placement" and "out-of-home care" mean the placement of a child in a foster family home or group care facility licensed under chapter 74.15 RCW.

17 Whenever the department places a child in out-of-home care under a voluntary placement pursuant to this section, the department shall have 18 19 the responsibility for the child's placement and care. The department 20 shall develop a permanency plan of care for the child no later than 21 sixty days from the date that the department assumes responsibility for 22 the child's placement and care. 37 The department shall adopt rules providing for the implementation

of chapter 386, Laws of 1997 and the transfer of responsibility for
 out-of-home placements from the dependency process under chapter 13.34
 RCW to the process under this chapter.

It is the intent of the legislature that the department undertake 4 5 voluntary out-of-home placement in cases where the child's developmental disability is such that the parent, guardian, or legal 6 7 custodian is unable to provide the necessary care for the child, and the parent, quardian, or legal custodian has determined that the child 8 would benefit from placement outside of the home. If the department 9 does not accept a voluntary placement agreement signed by the parent, 10 a petition may be filed and an action pursued under chapter 13.34 RCW. 11 The department shall inform the parent, guardian, or legal custodian in 12 13 writing of their right to civil action under chapter 13.34 RCW.
