- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 Sec. 1. RCW 9.94A.631 and 2009 c 390 s 1 are each amended to read 8 as follows:
- 9 (1) If an offender violates any condition or requirement of a 10 sentence, a community corrections officer may arrest or cause the
- 11 arrest of the offender without a warrant, pending a determination by
- 12 the court or ((a department of corrections hearing officer)) by the
- 13 department. If there is reasonable cause to believe that an offender
- 14 has violated a condition or requirement of the sentence, a community
- 15 corrections officer may require an offender to submit to a search and
- 16 seizure of the offender's person, residence, automobile, or other
- 17 personal property.
- 18 (2) For the safety and security of department staff, an offender
- 19 may be required to submit to pat searches, or other limited security

searches, by community corrections officers, correctional officers, and other agency approved staff, without reasonable cause, when in or on department premises, grounds, or facilities, or while preparing to enter department premises, grounds, facilities, or vehicles. Pat searches of offenders shall be conducted only by staff who are the same gender as the offender, except in emergency situations.

(3) A community corrections officer may also arrest an offender for her presence. any crime committed in his or The facts and circumstances of the conduct of the offender shall be reported by the community corrections officer, with recommendations, to the court ((or department of corrections hearing officer)), local law enforcement, or <u>local prosecution for consideration of new charges. The community</u> <u>corrections officer's report shall serve as the notice that the</u> department will hold the offender for not more than three days from the time of such notice for the new crime, except if the offender's underlying offense is a felony offense listed in RCW 9.94A.737(5), in which case the department will hold the offender for thirty days from the time of arrest or until a prosecuting attorney charges the offender with a crime, whichever occurs first. This does not affect the department's authority under RCW 9.94A.737.

If a community corrections officer arrests or causes the arrest of an offender under this section, the offender shall be confined and detained in the county jail of the county in which the offender was taken into custody, and the sheriff of that county shall receive and keep in the county jail, where room is available, all prisoners delivered to the jail by the community corrections officer, and such offenders shall not be released from custody on bail or personal recognizance, except upon approval of the court or authorized department staff, pursuant to a written order.

- 30 **Sec. 2.** RCW 9.94A.633 and 2010 c 258 s 1 and 2010 c 224 s 12 are each reenacted and amended to read as follows:
 - (1)(a) An offender who violates any condition or requirement of a sentence may be sanctioned by the court with up to sixty days' confinement for each violation or by the department with up to thirty days' confinement as provided in RCW 9.94A.737.
- 36 (b) In lieu of confinement, an offender may be sanctioned with work 37 release, home detention with electronic monitoring, work crew,

community restitution, inpatient treatment, daily reporting, curfew, educational or counseling sessions, supervision enhanced through electronic monitoring, or any other <u>community-based</u> sanctions ((available in the community)).

- (2) If an offender was under community custody pursuant to one of the following statutes, the offender may be sanctioned as follows:
- (a) If the offender was transferred to community custody in lieu of earned early release in accordance with RCW 9.94A.728, the offender may be transferred to a more restrictive confinement status to serve up to the remaining portion of the sentence, less credit for any period actually spent in community custody or in detention awaiting disposition of an alleged violation.
- (b) If the offender was sentenced under the drug offender sentencing alternative set out in RCW 9.94A.660, the offender may be sanctioned in accordance with that section.
- (c) If the offender was sentenced under the parenting sentencing alternative set out in RCW 9.94A.655, the offender may be sanctioned in accordance with that section.
- (d) If the offender was sentenced under the special sex offender sentencing alternative set out in RCW 9.94A.670, the suspended sentence may be revoked and the offender committed to serve the original sentence of confinement.
- (e) If the offender was sentenced to a work ethic camp pursuant to RCW 9.94A.690, the offender may be reclassified to serve the unexpired term of his or her sentence in total confinement.
- (f) If a sex offender was sentenced pursuant to RCW 9.94A.507, the offender may be transferred to a more restrictive confinement status to serve up to the remaining portion of the sentence, less credit for any period actually spent in community custody or in detention awaiting disposition of an alleged violation.
- (3) If a probationer is being supervised by the department pursuant to RCW 9.92.060, 9.95.204, or 9.95.210, the probationer may be sanctioned pursuant to subsection (1) of this section. The department shall have authority to issue a warrant for the arrest of an offender who violates a condition of community custody, as provided in RCW 9.94A.716. Any sanctions shall be imposed by the department pursuant to RCW 9.94A.737. ((The-department-shall-provide-a-copy-of-the

- 1 violation hearing report to the sentencing court in a timely manner.))
- 2 Nothing in this subsection is intended to limit the power of the 3 sentencing court to respond to a probationer's violation of conditions.
 - (4) The parole or probation of an offender who is charged with a new felony offense may be suspended and the offender placed in total confinement pending disposition of the new criminal charges if:
 - (a) The offender is on parole pursuant to RCW 9.95.110(1); or
- 8 (b) The offender is being supervised pursuant to RCW 9.94A.745 and 9 is on parole or probation pursuant to the laws of another state.
- 10 **Sec. 3.** RCW 9.94A.704 and 2009 c 375 s 6 are each amended to read 11 as follows:
- 12 (1) Every person who is sentenced to a period of community custody 13 shall report to and be placed under the supervision of the department, 14 subject to RCW 9.94A.501.
 - (2)(a) The department shall assess the offender's risk of reoffense and may establish and modify additional conditions of community custody based upon the risk to community safety.
 - (b) Within the funds available for community custody, the department shall determine conditions on the basis of risk to community safety, and shall supervise offenders during community custody on the basis of risk to community safety and conditions imposed by the court. The secretary shall adopt rules to implement the provisions of this subsection (2)(b).
 - (3) If the offender is supervised by the department, the department shall at a minimum instruct the offender to:

the resources made available by the department for this purpose, the department shall carry out any electronic monitoring using the most appropriate technology given the individual circumstances of the offender. As used in this section, "electronic monitoring" means the monitoring of an offender using an electronic offender tracking system including, but not limited to, a system using radio frequency or active or passive global positioning system technology.

- (6) The department may not impose conditions that are contrary to those ordered by the court and may not contravene or decrease courtimposed conditions.
- (7)(a) The department shall notify the offender in writing of any additional conditions or modifications.
- (b) By the close of the next business day after receiving notice of a condition imposed or modified by the department, an offender may request an administrative review under rules adopted by the department. The condition shall remain in effect unless the reviewing officer finds that it is not reasonably related to the crime of conviction, the offender's risk of reoffending, or the safety of the community.
- (8) The department shall notify the offender in writing upon community custody intake of the department's violation process.
- (9) The department may require offenders to pay for special services rendered including electronic monitoring, day reporting, and telephone reporting, dependent on the offender's ability to pay. The department may pay for these services for offenders who are not able to pay.
- $((\frac{(9)}{)})$ (10)(a) When a sex offender has been sentenced pursuant to RCW 9.94A.507, the department shall assess the offender's risk of recidivism and shall recommend to the board any additional or modified conditions based upon the offender's risk to community safety and may recommend affirmative conduct or electronic monitoring consistent with subsections (4) through (6) of this section.
- (b) The board may impose conditions in addition to court-ordered conditions. The board must consider and may impose department-recommended conditions.
- (c) By the close of the next business day, after receiving notice of a condition imposed by the board or the department, an offender may request an administrative hearing under rules adopted by the board.

- The condition shall remain in effect unless the hearing examiner finds that it is not reasonably related to any of the following:
 - (i) The crime of conviction;
 - (ii) The offender's risk of reoffending;
- 5 (iii) The safety of the community.

- (d) If the department finds that an emergency exists requiring the 6 7 immediate imposition of additional conditions in order to prevent the offender from committing a crime, the department may impose such 8 9 conditions. The department may not impose conditions that are contrary to those set by the board or the court and may not contravene or 10 decrease court-imposed or board-imposed conditions. Conditions imposed 11 under this subsection shall take effect immediately after notice to the 12 offender by personal service, but shall not remain in effect longer 13 than seven working days unless approved by the board. 14
- $((\frac{10}{10}))$ (11) In setting, modifying, and enforcing conditions of community custody, the department shall be deemed to be performing a quasi-judicial function.
- 18 **Sec. 4.** RCW 9.94A.706 and 2008 c 231 s 11 are each amended to read 19 as follows:
 - (1) No offender sentenced to a term of community custody under the supervision of the department may own, use, or possess firearms ((or)), ammunition, or explosives. ((Offenders who own, use, or are found to be—in)) An offender's actual or constructive possession of firearms ((or)), ammunition, or explosives shall be ((subject to the violation process and)) reported to local law enforcement or local prosecution for consideration of new charges and subject to sanctions under RCW 9.94A.633((, 9.94A.716, and)) or 9.94A.737.
 - (2) For the purposes of this section:
- 29 <u>(a)</u> "Constructive possession" ((as used in this section)) means the 30 power and intent to control the firearm ((or)), ammunition, or 31 explosives.
- 32 (b) "Explosives" has the same definition as in RCW 46.04.170.
- 33 <u>(c)</u> "Firearm" ((as used in this section)) has the same definition as in RCW 9.41.010.
- 35 **Sec. 5.** RCW 9.94A.714 and 2008 c 231 s 16 are each amended to read as follows:

(1) ((Iff an offender has not completed his or her maximum term of total confinement and is subject to a third violation hearing pursuant to RCW 9.94A.737 for any violation of community custody and is found to have committed the violation, the department shall return the offender to total confinement in a state correctional facility to serve up to the remaining portion of his or her sentence, unless it is determined that returning the offender to a state correctional facility would substantially interfere with the offender's ability to maintain necessary community supports or to participate in necessary treatment or programming and would substantially increase the offender's likelihood of reoffending.

- (2))) The department may work with the Washington association of sheriffs and police chiefs to establish and operate an electronic monitoring program for ((low-risk)) offenders who violate the terms of their community custody.
- $((\frac{3}{2}))$ (2) Local governments, their subdivisions and employees, the department and its employees, and the Washington association of sheriffs and police chiefs and its employees are immune from civil liability for damages arising from incidents involving $((\frac{1}{2}))$ offenders who are placed on electronic monitoring unless it is shown that an employee acted with gross negligence or bad faith.
- **Sec. 6.** RCW 9.94A.716 and 2008 c 231 s 21 are each amended to read 23 as follows:
 - (1) The secretary may issue warrants for the arrest of any offender who violates a condition of community custody. The arrest warrants shall authorize any law enforcement or peace officer or community corrections officer of this state or any other state where such offender may be located, to arrest the offender and place him or her in total confinement pending disposition of the alleged violation <u>pursuant to RCW 9.94A.633</u>.
 - (2) A community corrections officer, if he or she has reasonable cause to believe an offender has violated a condition of community custody, may suspend the person's community custody status and arrest or cause the arrest and detention in total confinement of the offender, pending the determination of the secretary as to whether the violation has occurred.  12 the offender may present a current and ongoing foreseeable risk and
 13 which therefore, elevate an offender's behavior to a high level

- (ii) The state and its officers, agents, and employees may not be held criminally or civilly liable for a decision to elevate or not to elevate an offender's behavior to a high level violation process under this subsection unless the state or its officers, agents, and employees acted with reckless disregard.

 - (b)) The department shall provide the offender with written notice of the <u>alleged</u> violation(($_{7}$)) <u>and</u> the evidence (($_{1}$ reasons—the—particular—sanction—was—imposed)) <u>supporting_it</u>. The notice (($_{1}$ shall)) <u>must</u> include a statement of the rights specified in this subsection, and the offender's right to file a personal restraint petition under court rules after the final decision (($_{1}$ -the department));
 - (((c)-The-hearing-shall-be-held)) (b) Unless ((waived-by)) the offender waives the right to a hearing, the department shall hold a hearing, and shall ((be)) record it electronically ((recorded)). For offenders not in total confinement, the department shall hold a hearing ((shall-be-held)) within fifteen ((working)) business days, but not less than twenty-four hours, after written notice of the alleged violation. For offenders in total confinement, the department shall hold a hearing ((shall be held)) within five ((working)) business days, but not less than twenty-four hours, after written notice of the alleged violation;
 - ((\(\frac{(d)}{(d)}\)) (c) The offender shall have the right to: (i) Be present at the hearing; (ii) have the assistance of a person qualified to assist the offender in the hearing, appointed by the hearing officer if the offender has a language or communications barrier; (iii) testify or remain silent; (iv) call witnesses and present documentary evidence; ((\(\frac{and}{and}\))) (v) question witnesses who appear and testify; \(\frac{and}{and}\) (vi) receive a written summary of the reasons for the hearing officer's decision; and

- $((\frac{(e)}{(e)}))$ (d) The sanction shall take effect if affirmed by the 1 hearing officer. ((Within-seven-days-after-the-hearing-officer's 2 decision, -the -offender -may -appeal -the -decision)) The offender may 3 appeal the sanction to a panel of three reviewing officers designated 4 5 by the secretary or by the secretary's designee. The offender's appeal must be in writing and hand-delivered to department staff, or 6 7 postmarked, within seven days after the sanction was imposed. - 32 (3) For confinement sanctions imposed by the department under RCW 33 9.94A.670, the local correctional facility shall be financially responsible.
- 35 (4) The department, in consultation with the Washington association 36 of sheriffs and police chiefs and those counties in which the sheriff 37 does not operate a correctional facility, shall establish a methodology

(5) Except as provided in subsections (1) and (2) of this section, the local correctional facility shall continue to be financially responsible to the extent of the calendar year 1998 bed utilization rate for confinement sanctions imposed by the department pursuant to RCW 9.94A.737. If the department's use of bed space in local correctional facilities of any county for such confinement sanctions exceeds the 1998 bed utilization rate for the county, the department shall compensate the county for the excess use at the per diem rate equal to the lowest rate charged by the county under its contract with a municipal government during the year in which the use occurs.

14 Sec. 9. RCW 9.95.210 and 2011 1st sp.s. c 40 s 7 are each amended to read as follows:

 - <u>NEW_SECTION.</u> **Sec. 11.** (1)(a) Research shows that traditional mechanisms of surveillance-based supervision and sanctioning are ineffective in reducing recidivism or improving public safety. The legislature is persuaded by recent studies showing that swift and certain sanctions, in combination with treatment-based interventions that address chemical dependency and criminogenic behaviors, are a more effective and efficient use of public resources to affect future crime.
 - (b) Notwithstanding, this is a new approach for Washington. It is imperative to the success of the state's system of offender supervision that the department of corrections be vigilant in:
 - (i) Monitoring the quality and consistency of applying swift and certain sanctions across the state;
 - (ii) Ensuring that sanctions are commensurate with identified behaviors and, to the extent possible, produce satisfactory results;
 - (iii) Applying evidence-based treatment and evaluation principles

- to address offenders' criminogenic and chemical dependency needs and therefore pairing the offender with the appropriate treatment; and
- (iv) Maintaining good relations and open communication with law enforcement to assist in identifying offenders that pose the greatest risk to public safety.

- (a) Form stakeholder groups, that may include but are not limited to local community corrections officers, law enforcement, prosecuting attorneys, superior court judges, chemical dependency treatment and other community providers, and victim advocates;
- (b) Within available resources, provide inpatient or outpatient chemical dependency treatment to offenders initially assessed as in need of treatment based on an evaluation of the offender's needs by a certified staff or chemical dependency provider utilizing evidence-based tools for evaluation;

 - (3) The department shall report to the governor, appropriate committees of the legislature, and the stakeholder groups as identified in subsection (2)(a) of this section on its progress and activities in implementing this act, steps taken to improve the efficacy of chemical dependency treatment, evidence of outcomes achieved as reported by providers through submission of performance measure data, and including any recommended changes in legislation, no later than December 1, 2012, and December 1, 2013.

- NEW SECTION. Sec. 17. Section 10 of this act takes effect August 16 1, 2012.
