- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 43.24.130 and 1979 c 158 s 103 are each amended to read as follows:
- 7 (1) Notwithstanding any provision of law to the contrary, the
- 8 license of any person licensed by the director of licensing, or the
- 9 <u>boards_and_commissions_listed_in_chapter_18.235_RCW,</u> to practice a
- 10 profession or engage in an occupation, if valid and in force and effect
- 11 at the time the licensee entered service in the armed forces<u>, the</u>
- 12 <u>United States public health service commissioned corps</u>, or the merchant
- 13 marine of the United States, shall continue in full force and effect so
- 14 long as such service continues, unless sooner suspended, canceled, or
- 15 revoked for cause as provided by law. The director, <u>board</u>, <u>or</u>
- 16 <u>commission</u> shall renew the license of every such person who applies for
- 17 renewal thereof within six months after being honorably discharged from
- 18 service upon payment of the renewal fee applicable to the then current

- (2) If requested by the licensee, the license of a spouse or 1 registered domestic partner of a servicemember in the United States 2 armed forces, including the United States public health service 3 commissioned corps, if valid and in force and effect at the time the 4 servicemember is deployed or stationed in a location outside Washington 5 state, must be placed in inactive military spouse or registered 6 7 domestic partner status so long as such service continues, unless sooner suspended, canceled, or revoked for cause as provided by law. 8 The director, board, or commission shall return to active status the 9 license of every such person who applies for activation within six 10 months after returning to Washington state, upon payment of the current 11 renewal fee and meeting the current renewal conditions of the 12 13 respective license.
- 14 <u>(3) The director, board, or commission may adopt any rules</u> 15 necessary to implement this section.
- 16 **Sec. 2.** RCW 43.70.270 and 1989 1st ex.s. c 9 s 321 are each 17 amended to read as follows:
 - (1) Notwithstanding any provision of law to the contrary, the license of any person licensed by the secretary of health to practice a profession or engage in an occupation, if valid and in force and effect at the time the licensee entered service in the armed forces, the United States public health service commissioned corps, or the merchant marine of the United States, shall continue in full force and effect so long as such service continues, unless sooner suspended, canceled, or revoked for cause as provided by law. The secretary shall renew the license of every such person who applies for renewal thereof within six months after being honorably discharged from service upon payment of the renewal fee applicable to the then current year or other license period.
- 30 (2) If requested by the licensee, the license of a spouse or registered domestic partner of a servicemember in the United States 31 <u>armed forces, including the United States public health service</u> 32 commissioned corps, if valid and in force and effect at the time the 33 34 servicemember is deployed or stationed in a location outside Washington 35 state, must be placed in inactive military spouse or registered domestic partner status so long as such service continues, unless 36 sooner suspended, canceled, or revoked for cause as provided by law. 37

- The secretary shall return to active status the license of every such person who applies for renewal thereof within six months after the servicemember is honorably discharged from service, or sooner if requested by the licensee, upon payment of the renewal fee applicable to the then current year or other license period.
