- EFFECT: (1) Restores existing statutory language to clarify that the court will postpone, for 6 months, closing a dependency proceeding of a youth who turns 18 years old while in foster care to allow an eligible youth to request extended foster care services.
- (2) Restores existing statutory language that provides that the Department of Social and Health Services is relieved of any supervisory responsibility for a foster youth who has turned 18 until he or she requests extended foster care services.
- (3) Clarifies that only nonminor dependents who have an open dependency matter when they turn 18 years old and who have requested extended foster care services before turning 18 years and 6 months old, as well participating in one of the required activities, are eligible to receive extended foster care services.
