(4) "Evidence-based" means a program or practice that has been 10 11 tested in heterogeneous or intended populations with multiple 12 randomized, or statistically controlled evaluations, or both; or one site randomized, or statistically 13 large multiple controlled 14 evaluation, or both, where the weight of the evidence from a systemic 15 review demonstrates sustained improvements in at least one outcome. 16 "Evidence-based" also means a program or practice that can be 17 implemented with a set of procedures to allow successful replication 18 in Washington and, when possible, is determined to be cost-beneficial. 19 (5) "Research-based" means a program or practice that has been 20 tested with a single randomized, or statistically controlled

21 evaluation, or both, demonstrating sustained desirable outcomes; or 22 where the weight of the evidence from a systemic review supports 23 sustained outcomes as described in this subsection but does not meet 24 the full criteria for evidence-based.

25 (6) "Service coordination organization" or "service contracting 26 entity" means the authority and department, or an entity that may 27 contract with the state to provide, directly or through subcontracts,

Expands the definition of "evidence-based" to include EFFECT: one large multiple site randomized or statistically controlled evaluation where the evidence demonstrates sustained improvements in an outcome. Specifies that the term "research-based" means a practice that has been tested with a single randomized or controlled evaluation statistically demonstrating sustained desirable outcomes or where the evidence from a systematic review supports sustained outcomes but does not meet the standard of "evidence-based." Adds a definition of "emerging best practices" and "promising practices" to refer to practices that may become evidence-based or research-based based on statistical analysis or a well-established theory rather than preliminary information.

Requires work groups to be established according to areas of outcome and performance measures, rather than by programs.

Specifies that priority is to be given to evidence-based practices, then to research-based practices, and then to promising practices. Requires strategies identify programs that are effective with ethnically diverse clients. Requires that public reporting of outcome and performance data be phased in and that it allow for comparisons between geographic regions.

Removes the Washington State Institute for Public Policy from advising and providing consultation to the work groups.

Changes references to "service coordination organizations" to "service contracting entities."
