14 (1) The ignition interlock device revolving account program is 15 created within the department to assist in covering the monetary costs 16 of installing, removing, and leasing an ignition interlock device, and 17 applicable licensing, for indigent persons who are required under RCW 18 46.20.385, 46.20.720, and 46.61.5055 to install an ignition interlock 19 device in all vehicles owned or operated by the person. For purposes 20 of this subsection, "indigent" has the same meaning as in RCW 21 10.101.010, as determined by the department. <u>During the 2013-2015</u> 22 <u>fiscal biennium, the ignition interlock device revolving account</u> 23 <u>program also includes ignition interlock enforcement work conducted by</u> 24 <u>the Washington state patrol.</u>

25 (2) A pilot program is created within the ignition interlock 26 device revolving account program for the purpose of monitoring 27 compliance by persons required to use ignition interlock devices and 28 by ignition interlock companies and vendors.

(3) The department, the state patrol, and the Washington traffic 30 safety commission shall coordinate to establish a compliance pilot 31 program that will target at least one county from eastern Washington 32 and one county from western Washington, as determined by the 33 department, state patrol, and Washington traffic safety commission.

(a) Review the number of ignition interlock devices that are 1 2 required to be installed in the targeted county and the number of 3 ignition interlock devices actually installed; 4 (b) Work to identify those persons who are not complying with 5 ignition interlock requirements or are repeatedly violating ignition 6 interlock requirements; and 7 (c) Identify ways to track compliance and reduce noncompliance. EFFECT:

Department of Transportation--Local Programs--Program Z--Capital: Corrects the amounts provided to the Freight Mobility Stategic Investment Board under Department of Transportation Local Programs. Fiscal Impact: Increases Freight Mobility Multimodal Account--State by \$500,000. Decreases Motor Vehicle Account--State by \$500,000.

State Patrol: Corrects certificate of participation (COP) authorization levels for the Washington state patrol to include amounts provided for the installation of mobile office platforms in sergeant pursuit vehicles, consistent with appropriated amounts. Fiscal Impact:

No change to appropriated levels. COP authorization levels are increased by \$813,000.

Transfers: Transfers monies from the Multimodal Transportation Account--State to the State Patrol Highway Account--State to remedy a projected deficit in the account resulting from the technical amendment adopted in committee. <u>Fiscal Impact:</u> Increases amounts in the State Patrol Highway Account by \$5,000,000; decreases amounts in the Multimodal Transportation Account by \$5,000,000.

Implementing Provisions: Adds language that was mistakenly omitted
allowing bond proceeds to be assigned to expenditures that occur
prior to the issue date of the bonds.
Fiscal Impact:
No change to appropriated levels.

Miscellaneous 2013-2015 Fiscal Biennium: Adds language allowing ignition interlock enforcement work conducted by the Washington state patrol to be funded through the ignition interlock device revolving account program. Fiscal Impact: No change to appropriated levels.

Department of Transportation--Public Transportation--Program V--2011-13 Operating: Corrects proviso amounts to reflect the reappropriation of unspent funds from the 2011-2013 fiscal biennium to the 2013-2015 fiscal biennium. Fiscal Impact: No change to appropriated levels.

2011-13 Transfers: Corrects the transfer from the Capital Vessel Replacement Account to the Nickel Account based on the March 2013 Transportation Revenue Forecast. Fiscal Impact:

Increases amounts in the Nickel Account by \$68,000; decreases amounts in the Capital Vessel Replacement Account by \$68,000.

FISCAL IMPACT: No net change to appropriated levels.
