- 16 (b) "State agency" means an agency in which this section 968 is
- 17 specifically referenced in the section authorizing their
- 18 appropriations for the 2013-15 biennium.
- 19 (b) "Unmanned aircraft" means an aircraft that is operated without
- 20 the possibility of human intervention from within or on the aircraft.
- 21 (2) Except as specifically authorized in this section, state
- 22 agencies shall not operate a public unmanned aircraft system or
- 23 disclose personal information about any person acquired through the
- 24 operation of a public unmanned aircraft system.
- 25 (3) No state agency shall procure a public unmanned aircraft
- 26 system without the explicit approval of the legislature, given for
- 27 that specific public unmanned aircraft system to be used for a
- 28 specific purpose.
- 29 (4) All operations of a public unmanned aircraft system or
- 30 disclosure of personal information about any person acquired through

- 1 (5) A public unmanned aircraft system may be operated and
- 2 personal information from such operation disclosed in order to

- 4 (a) Pursuant to a criminal search warrant issued by a court of
- 5 competent jurisdiction;
- 6 (b) If a law enforcement officer or public official reasonably
- 7 determines that an emergency situation exists that presents
- 8 immediate danger of death or serious physical injury to any person;
- 9 the situation requires operation of a public unmanned aircraft
- 10 system; and, if criminal activity is involved, there are grounds
- 11 upon which such a warrant could be entered to authorize such
- 12 operation and an application for a warrant providing such operation
- 13 is made within forty-eight hours after the operation has occurred or
- 14 begins to occur;
- 15 (c) If a law enforcement officer or public official reasonably
- 16 determines that the operation does not intend to collect personal
- 17 information and is unlikely to accidentally collect personal
- 18 information, and such operation is not for purposes of regulatory
- 19 enforcement;
- 20 (d) If the operation is part of a training exercise conducted
- 21 on a military base and the public unmanned aircraft system does not
- 22 collect personal information on persons located outside the military
- 23 base; or
- (e) if the operations is for training or testing purposes by an
- 25 agency and does not collect personal information.
- 26 (6) Whenever any personal information from a public unmanned
- 27 aircraft system has been acquired, no part of such personal
- 28 information and no evidence derived therefrom may be received in
- 29 evidence in any trial, hearing, or other proceeding in or before any
- 30 court, grand jury, department, officer, agency, regulatory body,
- 31 legislative committee, or other authority of the state or a political
- 32 subdivision thereof if the collection or disclosure of that personal
- 33 information would be in violation of this section.

- (7) Personal information collected during the operation of a 1 2 public unmanned aircraft system authorized by and consistent with this 3 chapter may not be used, copied, or disclosed for any purpose after 4 conclusion of the operation, unless there is probable cause that the 5 personal information is evidence of criminal activity. 6 information shall be deleted as soon as possible after there is no 7 longer probable cause that the personal information is evidence of 8 criminal activity; this must be within thirty days if the personal 9 information was collected on the target of a warrant authorizing the 10 operation of the public unmanned aircraft system, and within ten days 11 for other personal information collected incidentally to the operation 12 of a public unmanned aircraft system otherwise authorized by and 13 consistent with this chapter. There shall be a presumption that 14 personal information is not evidence of criminal activity if that 15 personal information is not used in a criminal prosecution within one 16 year of collection.
- 17 (8) (a) By July 1 of each year, any state agency which has 18 utilized a public unmanned aircraft system in the preceding calendar 19 year must report to the chief of the Washington state patrol or his or 20 her designee each use of a public unmanned aircraft system, including 21 the date, time, location of use, target of data collection, type of 22 data collected, the justification for the use, the operator of the 23 public unmanned aircraft system, and the person who authorized the 24 use.
- 25 (b) By December 1 of each year, the chief of the Washington State 26 Patrol or his or her designee shall transmit to the legislature a full 27 and complete report containing a summary and analysis of all the data 28 described in subsection (9)(a) of this section.
- (9) A person who has been damaged by a violation of this section 30 may seek any remedy provided by law, including commencing any legal 31 action.
- 32 (10) Nothing in this section shall be construed to limit the 33 state's ability to establish and operated a test range for the 34 integration of unmanned aviation vehicles into the national airspace."

EFFECT: Specified state agencies must comply with requirements 3 related to unmanned aircraft. The state agency must receive 4 explicit legislative approval before procuring a drone. A state agency may operate a drone: (a) pursuant to a criminal search warrant; (b) if necessary to prevent immediate death or serious 6 injury; (c) if the operation won't collect personal information and $_{7}$ isn't for regulatory enforcement; (d) if the operation is part of a military training exercise on a military base; or (e) if the operation is for training and testing purposes by an agency and does not collect personal information. Information collected in violation of the requirements can't be used in trial.

 $_{11}$ If there is no probable cause that personal information collected is evidence of criminal activity, the information may not be used for 12 any purpose and must be deleted: (a) within 10 days if on a person besides the target of a search warrant; or (b) within 30 days if on the target of the warrant. Any state agency that uses a drone must 14 report by July 1 to the State Patrol on any operations and the State Patrol must provide a summary of the reports to the legislature by Dec. 1 of each year. A person damaged by a violation of the section 16 may seek any legal remedy available, including civil action.

The applicable agencies are the Governor's office, the Attorney 18 General, The Department of Revenue, the Insurance Commissioner, the Liquor Control Board, the UTC, the Military Department, the Department of Enterprise Services, the Department of Social and Health Services, 20 the Department of Labor and Industries, the Department of Health, the Department of Corrections, the Employment Security Department, the 21 Department of Ecology, the Parks and Recreation Commission, the 22 Columbia River Gorge Commission, the Recreation and Conservation Funding Board, the conservation Commission, the Department of Fish and Wildlife, the Department of Natural Resources, the Department of 24 Agriculture, the Puget Sound Partnership, the Department of Licensing, and the State Patrol.
