"NEW SECTION. Sec. 5. If specific funding for purposes of 12 section 3 of this act, referencing section 3 of this act by bill or 13 chapter and section number, is not provided by June 30, 2013, in the 14 omnibus operating appropriations act, section 3 of this act is null 15 and void."

17 Correct the title.

EFFECT: Makes the following changes to the underlying bill:

- Asserts that more districts are offering innovative advanced courses in addition to dual credit courses, and that the intent of the bill is to reduce barriers for students to enroll in rigorous advanced courses.
- Encourages, rather than requires, school districts to adopt an Academic Acceleration Policy as specified in the bill.
- Removes the Incentive Program that provides grants based on the lowest 25 percent of high schools in terms of dual credit enrollment and provides awards based on the top 10 percent of high schools in terms of growth in dual credit enrollment(including in Running Start).
- Instead, provides grants through the Incentive Program on a competitive basis to expand availability of dual credit courses to high schools that have adopted the Academic Acceleration Policy, with a priority for low-income schools and schools seeking to develop new capacity.
- Also provides awards through the Incentive Program to high schools based on overall dual credit enrollment (not including Running Start).
- Adds a null & void clause to the Incentive Program.
