- (c) Whether a marijuana producer or marijuana processor endorsement should be established to permit a producer or processor to sell directly to qualifying patients and designated providers and whether these licensees are producing marijuana concentrates, useable marijuana, and marijuana-infused products that are meeting the needs of medical marijuana patients;
- 32 (d) Whether posttraumatic stress disorder should be added to 33 terminal or debilitating medical conditions that qualify a person for 34 the medical use of marijuana;

- 1 (e) Whether a different method of taxation should be established
- 2 for those products designated by the liquor control board as being
- 3 beneficial for qualifying patients and designated providers. This
- 4 includes whether these products should be taxed at a different rate
- 5 than products intended for nonmedical use or whether they should be

- 1 (6) Staff support for the committee must be provided by senate 2 committee services, the house of representatives office of program 3 research, and the represented state agencies.
- 4 (7) Legislative members of the committee must serve without 5 additional compensation, but must be reimbursed for travel expenses in 6 accordance with RCW 44.04.120. Nonlegislative members, except those 7 representing an employer or organization, are entitled to be 8 reimbursed for travel expenses in accordance with RCW 43.03.050 and 9 43.03.060.
- 10 (8) The expenses of the committee must be paid jointly by the 11 senate and the house of representatives. Committee expenditures are 12 subject to approval by the senate facilities and operations committee 13 and the house of representatives executive rules committee, or their 14 successor committees.
- 15 (9) Meetings of the committee are subject to the open public 16 meetings act, chapter 42.30 RCW.
- 17 (10) This section expires January 31, 2016."

EFFECT: Establishes the State Cannabis Industry Coordinating Committee (Committee) which includes legislators, Executive Branch representatives, medical marijuana patient representatives, local government representatives, and industry stakeholders. Directs the Committee to make recommendations for a state plan for coordinating the cannabis industry, creating a financial system for the marijuana marketplace, monitoring economic returns, monitoring federal law, creating a cannabis industry coordinator, distributing tax revenue, and considering other options for medical marijuana.

Directs the Committee to appoint a medical marijuana subcommittee to study issues related to marijuana retailers, producers, and processors; the addition of posttraumatic stress disorder as a recognized condition; taxation; and funding of the medical marijuana registry.

Requires the Committee to report to the Legislature by December 15, 2014 and January 10, 2016.
