EFFECT: Removes a limitation that school districts must only grant academic credit for a career and technical education (CTE) course from the state-developed course equivalent list if the course is offered. Adds a requirement that, beginning in 2015-16, school districts must provide high school students with the opportunity to access at least one CTE course equivalent in mathematics or in science from the state list. Lists options for providing this access. Allows a school district with fewer than 2,000 students to seek a waiver of this requirement from the State Board of Education (SBE), and authorizes the SBE to grant such waivers.
