2 NEW SECTION. Sec. 1. (1) A budget is hereby adopted and, subject to the provisions set forth in the following sections, the several 3 4 amounts specified in parts I through IX of this act, or so much thereof as shall be sufficient to accomplish the purposes designated, are 5 hereby appropriated and authorized to be incurred for salaries, wages, 6 7 and other expenses of the agencies and offices of the state and for other specified purposes for the fiscal biennium beginning July 1, 8 2013, and ending June 30, 2015, except as otherwise provided, out of 9 the several funds of the state hereinafter named. 10

(2) Unless the context clearly requires otherwise, the definitionsin this section apply throughout this act.

(a) "Fiscal year 2014" or "FY 2014" means the fiscal year endingJune 30, 2014.

(b) "Fiscal year 2015" or "FY 2015" means the fiscal year ending June 30, 2015.

(c) "FTE" means full time equivalent.

18 (d) "Lapse" or "revert" means the amount shall return to an 19 unappropriated status.

(e) "Provided solely" means the specified amount may be spent only for the specified purpose. Unless otherwise specifically authorized in this act, any portion of an amount provided solely for a specified purpose which is not expended subject to the specified conditions and limitations to fulfill the specified purpose shall lapse.

9 (b) Obtain the university's definition of auxiliary enterprises and 10 determine the number of auxiliary enterprises, including the University of Washington medical center, the University of Washington internal 11 12 lending program, the W fund, and the center for commercialization, that 13 exist in the university system, the methods the university uses to track revenue and expenditures of auxiliary enterprises, and the 14 policies and practices the university has in place to ensure that state 15 funding is not used to supplement or guarantee projects or programs 16 authorized by auxiliary enterprises; 17

18 (c) Identify how much money is being spent on undergraduate 19 education and to what extent undergraduate education is subsidizing 20 graduate education; and

(d) Determine how tuition funds are being used and to what extent they are being used to fund the University of Washington medical center, the University of Washington internal lending program, the W fund, and the center for commercialization and to back bonds authorized by the university.

(3) \$332,000 of the medical aid account--state appropriation and
\$332,000 of the accident account--state appropriation are provided for
the purposes of chapter 37, Laws of 2011 (workers' compensation).

(4) \$323,000 of the performance audits of government account--state
 appropriation is provided for consultant and staff costs related to the
 economic analysis of tax preferences as directed by chapter 43.136 RCW.

32 (5) The committee shall analyze the incidence and level of taxation 33 and business incentives available to the financial services industry in 34 Washington State, and identify the relative differences in taxes and 35 business incentives compared to California. A report shall be provided 36 to the appropriate committees of the legislature by December 1, 2014.

37 (6) By June 30, 2014, the committee shall conduct a study of the

(c) The nonprofit organization shall prepare an annual independent audit, an annual financial statement, and an annual report, including benchmarks that measure the success of the nonprofit organization in meeting the intent of the program.

(d) No portion of any amounts disbursed pursuant to this subsectionmay be used, directly or indirectly, for any of the following purposes:

(i) Attempting to influence the passage or defeat of any legislation by the legislature of the state of Washington, by any county, city, town, or other political subdivision of the state of Washington, or by the congress, or the adoption or rejection of any rule, standard, rate, or other legislative enactment of any state agency;

(ii) Making contributions reportable under chapter 42.17 RCW; or

(iii) Providing any: (A) Gift; (B) honoraria; or (C) travel,
lodging, meals, or entertainment to a public officer or employee.

(2) \$668,000 of the general fund--state appropriation for fiscal 6 7 year 2014 and \$668,000 of the general fund--state appropriation for 8 fiscal year 2015 are provided solely to contract for the operation of 9 one pediatric interim care center. The center shall provide residential care for up to thirteen children through two years of age. 10 Seventy-five percent of the children served by the center must be in 11 12 need of special care as a result of substance abuse by their mothers. 13 The center shall also provide on-site training to biological, adoptive, 14 or foster parents. The center shall provide at least three months of consultation and support to the parents accepting placement of children 15 The center may recruit new and current foster and 16 from the center. adoptive parents for infants served by the center. 17 The department 18 shall not require case management as a condition of the contract.

19 (3) \$538,500 of the general fund--state appropriation for fiscal year 2014, \$539,500 of the general fund--state appropriation for fiscal 20 21 year 2015, \$656,000 of the general fund--private/local appropriation, 22 and \$253,000 of the general fund--federal appropriation are provided 23 solely for children's administration to contract with an educational advocacy provider with expertise in foster care educational outreach. 24 25 The amounts in this subsection are provided solely for contracted 26 education coordinators to assist foster children in succeeding in K-12 27 and higher education systems and to assure a focus on education during 28 the transition to performance based contracts. (9) \$579,000 of the general fund--state appropriation for fiscal

provided solely for a receiving care center east of the Cascade
mountains.

9 (10)(a) \$446,000 of the general fund--state appropriation for 10 fiscal year 2014 and \$446,000 of the general fund--state appropriation 11 for fiscal year 2015 are provided solely for a contract with a 12 nongovernmental entity or entities to establish one demonstration site 13 in a school district or group of school districts in western 14 Washington.

(b) The children's administration and the nongovernmental entity or entities shall collaboratively select the demonstration site. The demonstration site should be a school district or group of school districts with a significant number of students who are dependent pursuant to chapter 13.34 RCW.

29 (12) \$670,000 of the general fund--state appropriation for fiscal year 2014 and \$670,000 of the general fund--state appropriation for 30 fiscal year 2015 are provided solely for services provided through 31 32 children's advocacy centers.

(a) \$105,265,000 of the general fund--state appropriation for 5 б fiscal and \$85,895,000 of the general year 2014 fund--state appropriation for fiscal year 2015 are provided solely for persons and 7 services not covered by the medicaid program. To the extent possible, 8 9 levels of regional support network spending shall be maintained in the 10 following priority order: Crisis and commitment services; community inpatient services; and residential care services, including personal 11 12 care and emergency housing assistance. Agencies participating in this authorization 9 10 may offer voluntary retirement and/or separation incentives and options 11 according to procedures and guidelines established by the office of 12 financial management, in consultation with the office of the state 13 human resources director and the department of retirement systems. The 14 options may include, but are not limited to, financial incentives for voluntary separation or retirement. An employee does not have a 15 contractual right to a financial incentive offered under this section. 16 17 Offers shall be reviewed and monitored jointly by the office of the 18 state human resources director and the department of retirement 19 systems. Agencies are required to submit a report by July 30, 2015, to the legislature and the office of financial management on the outcome 20 21 of their approved incentive program. The report should include 22 information on the details of the program including the incentive 23 payment amount for each participant, the total cost to the state, and 24 the projected or actual net dollar savings over the two year period.

The department of retirement systems may collect from employers the actuarial cost of any incentive provided under this program, or any other incentive to retire provided by employers to members of the state's pension systems, for deposit in the appropriate pension account.

30 <u>NEW SECTION.</u> Sec. 906. COLLECTIVE BARGAINING AGREEMENTS NOT 31 IMPAIRED

Nothing in this act prohibits the expenditure of any funds by an agency or institution of the state for benefits guaranteed by any collective bargaining agreement in effect on the effective date of this section. 1

Such receipts shall not be used for administrative expenditures.

(2) The health care authority, subject to the approval of the public employees' benefits board, shall provide subsidies for health benefit premiums to eligible retired or disabled public employees and school district employees who are eligible for medicare, pursuant to RCW 41.05.085. For calendar years 2014 and 2015, the subsidy shall be up to \$150.00 per month.

The treasurer shall make disbursements to: The state toxicology laboratory, counties for the 14 cost of autopsies, the state patrol for providing partial funding for 15 16 the state dental identification system, the criminal justice training commission for training county coroners, medical examiners and their 17 staff, and the state forensic investigations council. ((Funds from the 18 19 death investigations account may be appropriated during the 1997-99 20 biennium for the purposes of statewide child mortality reviews 21 administered by the department of health.)) Funds from the death 22 investigations account may be appropriated during the 2013-2015 fiscal 23 biennium for the activities of the state crime laboratory within the Washington state patrol. 24

(1) Moneys received by the state of Washington in accordance with the settlement of the state's legal action against tobacco product manufacturers, exclusive of costs and attorneys' fees, shall be deposited in the tobacco settlement account created in this section except as these moneys are sold or assigned under chapter 43.340 RCW.

32 (2) The tobacco settlement account is created in the state 33 treasury. Moneys in the tobacco settlement account may only be 34 transferred to the state general fund, and to the tobacco prevention 35 and control account for purposes set forth in this section. Long-term cost benefit must be considered.
