- AN ACT Relating to vehicle license plate and registration fraud;
- 2 reenacting and amending RCW 46.63.020; adding a new section to chapter
- 3 46.37 RCW; and prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.37 RCW to read as follows:
- 7 It is unlawful for a person to display a license plate on a vehicle
- 8 that does not match or correspond with the registration of the vehicle
- 9 unless the vehicle is inventory for a properly licensed vehicle dealer.
- 10 A person who switches or flips license plates on a vehicle or falsifies
- 11 a vehicle registration in violation of this section, in addition to any
- 12 traffic infraction, is guilty of a gross misdemeanor punishable by
- 13 confinement of up to three hundred sixty-four days in the county jail
- 14 and a fine of five thousand dollars, which may not be suspended,
- 15 deferred, or reduced. A vehicle that is found with an installed
- 16 license plate flipping device may be impounded by a law enforcement
- 17 officer as evidence.

Failure to perform any act required or the performance of any act prohibited by this title or an equivalent administrative regulation or local law, ordinance, regulation, or resolution relating to traffic including parking, standing, stopping, and pedestrian offenses, is designated as a traffic infraction and may not be classified as a criminal offense, except for an offense contained in the following provisions of this title or a violation of an equivalent administrative regulation or local law, ordinance, regulation, or resolution:

- (1) RCW 46.09.470(2) relating to the operation of a nonhighway vehicle while under the influence of intoxicating liquor or a controlled substance;
 - (2) RCW 46.09.480 relating to operation of nonhighway vehicles;
