- 7 (1) The district manager for district two as defined in WAC 16-390-
- 8 010 is authorized to transfer one hundred fifty thousand dollars from
- 9 the fruit and vegetable district fund to the plant pest account within
- 10 the agricultural local fund. The amount transferred is to be derived
- 11 from fees collected for state inspections of tree fruits and is to be
- 12 used solely for activities related to the control of Rhagoletis
- 13 pomonella in district two. The transfer of money must occur by
- 14 September 1, 2009. ((On June 30, 2013, any unexpended portion of the

- 6 (3) This section expires July 1, ((2013)) 2020.
- 7 <u>NEW SECTION.</u> **Sec. 2.** Section 1 of this act is necessary for the
- 8 immediate preservation of the public peace, health, or safety, or
- 9 support of the state government and its existing public institutions,
- 10 and takes effect June 30, 2013.
