12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

13 Sec. 1. RCW 29A.04.008 and 2011 c 10 s 1 are each amended to read 14 as follows:

15 As used in this title:

16 (1) "Ballot" means, as the context implies, either:

17 (a) The issues and offices to be voted upon in a jurisdiction or 18 portion of a jurisdiction at a particular primary, general election, or 19 special election;

(b) A facsimile of the contents of a particular ballot whether printed on a paper ballot or ballot card or as part of a voting machine or voting device;

(c) A physical or electronic record of the choices of an individual voter in a particular primary, general election, or special election; or

26 (d) The physical document on which the voter's choices are to be 27 recorded;

(2) "Paper ballot" means a piece of paper on which the ballot for
 a particular election or primary has been printed, on which a voter may
 record his or her choices for any candidate or for or against any
 measure, and that is to be tabulated manually;

32 (3) "Ballot card" means any type of card or piece of paper of any 33 size on which a voter may record his or her choices for any candidate 34 and for or against any measure and that is to be tabulated on a vote 35 tallying system;

1 (4) "Sample ballot" means a printed facsimile of all the issues and 2 offices on the ballot in a jurisdiction and is intended to give voters 3 notice of the issues, offices, and candidates that are to be voted on 4 at a particular primary, general election, or special election;

5 (5) "Provisional ballot" means a ballot issued to a voter who would 6 otherwise be denied an opportunity to vote a regular ballot, for any 7 reason authorized by the Help America Vote Act, including but not 8 limited to the following:

9 (a) The voter's name does not appear in the list of registered 10 voters for the county;

(b) There is an indication in the voter registration system that the voter has already voted in that primary, special election, or general election, but the voter wishes to vote again;

14 (c) There is a question on the part of the voter concerning the 15 issues or candidates on which the voter is qualified to vote;

(d) Any other reason allowed by law(($\dot{\tau}$

17 (6) "Party ballot" means a primary election ballot specific to a 18 particular major political party that lists all candidates for partisan 19 office who affiliate with that same major political party, as well as 20 the nonpartisan races and ballot measures to be voted on at that 21 primary;

22 (7) "Nonpartisan ballot" means a primary election ballot that lists
23 all nonpartisan races and ballot measures to be voted on at that
24 primary)).

25 **Sec. 2.** RCW 29A.04.013 and 2011 c 10 s 2 are each amended to read 26 as follows:

27 "Canvassing" means the process of examining ballots or groups of 28 ballots, subtotals, and cumulative totals in order to determine the 29 official returns of a primary<u>, special</u>, or general election and 30 includes the tabulation of any votes that were not previously 31 tabulated.

32 Sec. 3. RCW 29A.04.079 and 2009 c 369 s 1 are each amended to read 33 as follows:

An "infamous crime" is a crime punishable by death in the state penitentiary or imprisonment in a state <u>or federal</u> correctional

1 facility. Neither an adjudication in juvenile court pursuant to 2 chapter 13.40 RCW, nor a conviction for a misdemeanor or gross 3 misdemeanor, is an "infamous crime."

4 **Sec. 4.** RCW 29A.04.086 and 2004 c 271 s 103 are each amended to 5 read as follows:

б "Major political party" means a political party ((of which at least 7 one)) whose nominees for president((-)) and vice president((-)) and vice president((-)) States senator, or a statewide office)) received at least five percent 8 9 of the total vote cast at the last ((preceding state general election 10 in an even-numbered year)) presidential election. A political party 11 qualifying as a major political party under this section retains such 12 status until the next ((even-year)) presidential election at which ((a 13 candidate)) the presidential and vice presidential candidates of that party ((does)) do not achieve at least five percent of the vote ((for 14 15 one of the previously specified offices)). ((If none of these offices 16 appear on the ballot in an even-year general election, the major party 17 retains its status as a major party through that election. However, a political party of which no nominee received at least ten percent of 18 19 the total vote cast may forgo its status as a major political party by 20 filing with the secretary of state an appropriate party rule within 21 sixty days of attaining major party status under this section, or 22 within fifteen days of June 10, 2004, whichever is later.))

23 Sec. 5. RCW 29A.04.097 and 2003 c 111 s 116 are each amended to 24 read as follows:

25 "Minor political party" means a political organization ((other than 26 a major political party)) whose nominees for president and vice 27 president qualified to appear on the ballot at the last presidential 28 election under RCW 29A.20.191 (as recodified by this act). A minor 29 political party retains such status until certification of the next 30 presidential election.

31 Sec. 6. RCW 29A.04.169 and 2003 c 111 s 130 are each amended to 32 read as follows:

33 "Short term" means the brief period of time starting upon ((the 34 completion of the)) certification of the general election ((returns)) 35 or issuance of a certificate of election, and ending with the start of the <u>next</u> full term, and is applicable only when ((the office concerned is being held by an appointee to fill a vacancy. The vacancy must have occurred)) there has been a vacancy in the office after the last election at which such office could have been voted upon for an unexpired term. Short term elections are always held in conjunction with elections for the full term for the office.

7 Sec. 7. RCW 29A.04.216 and 2011 c 10 s 6 are each amended to read 8 as follows:

9 The county auditor of each county shall be ex officio the supervisor of all primaries and elections, general or special, and it 10 11 shall be the county auditor's duty to provide places for holding such 12 primaries and elections; to provide the supplies and materials 13 necessary for the conduct of elections; and to publish and post notices of calling such primaries and elections in the manner provided by law. 14 15 ((The notice of a primary held in an even-numbered year must indicate that the office of precinct committee officer will be on the ballot.)) 16 17 The auditor shall also apportion to each city, town, or district, and to the state of Washington in the odd-numbered year, its share of the 18 expense of such primaries and elections. This section does not apply 19 20 to general or special elections for any city, town, or district that is 21 not subject to RCW 29A.04.321 and 29A.04.330, but all such elections 22 must be held and conducted at the time, in the manner, and by the 23 officials (with such notice, requirements for filing for office, and 24 certifications by local officers) as provided and required by the laws 25 governing such elections.

26 Sec. 8. RCW 29A.04.321 and 2011 c 349 s 3 are each amended to read 27 as follows:

(1) All state, county, city, town, and district general elections 28 for the election of federal, state, legislative, judicial, county, 29 30 city, town, and district officers, and for the submission to the voters of the state, county, city, town, or district of any measure for their 31 adoption and approval or rejection, shall be held on the first Tuesday 32 after the first Monday of November, in the year in which they may be 33 34 called. A statewide general election shall be held on the first 35 Tuesday after the first Monday of November of each year. However, the statewide general election held in odd-numbered years shall be limited 36

to (a) city, town, and district general elections as provided for in 1 2 RCW 29A.04.330, or as otherwise provided by law; (b) the election of federal officers for the remainder of any unexpired terms in the 3 4 membership of either branch of the Congress of the United States; (c) the election of state and county officers for the remainder of any 5 unexpired terms of offices created by or whose duties are described in 6 7 Article II, section 15, Article III, sections 16, 17, 19, 20, 21, 22, 8 and 23, and Article IV, sections 3 and 5 of the state Constitution and 9 RCW 2.06.080; (d) the election of county officers in any county governed by a charter containing provisions calling for general county 10 11 elections at this time; and (e) the approval or rejection of state 12 measures, including proposed constitutional amendments, matters 13 pertaining to any proposed constitutional convention, initiative 14 measures and referendum measures proposed by the electorate, referendum bills, and any other matter provided by the legislature for submission 15 16 to the electorate.

17 (2) A county legislative authority may call a special county 18 election by presenting a resolution to the county auditor prior to the 19 proposed election date. A special election called by the county 20 legislative authority shall be held on one of the following dates as 21 decided by such governing body:

22 (a

(a) The second Tuesday in February;

23 (b) The ((third Tuesday in April until January 1, 2013;

(c) The)) fourth Tuesday in April ((on or after January 1, 2013));

25 (((d))) <u>(c)</u> The day of the primary as specified by RCW 29A.04.311; 26 or

(((e))) <u>(d)</u> The first Tuesday after the first Monday in November.

(3) A resolution calling for a special election on a date set forth 28 in subsection (2)(a) ((through (c))) and (b) of this section must be 29 30 presented to the county auditor at least forty-six days prior to the election date. A resolution calling for a special election on a date 31 set forth in subsection (2)(((d))) (c) of this section must be 32 presented to the county auditor no later than the Friday immediately 33 before the first day of regular candidate filing. A resolution calling 34 35 for a special election on a date set forth in subsection (2)((+)) (d) 36 of this section must be presented to the county auditor no later than 37 the day of the primary.

(4) In addition to the dates set forth in subsection (2)(a) through (((e))) (d) of this section, a special election to validate an excess levy or bond issue may be called at any time to meet the needs resulting from fire, flood, earthquake, or other act of God. Such county special election shall be noticed and conducted in the manner provided by law.

7 (5) This section shall supersede the provisions of any and all 8 other statutes, whether general or special in nature, having different 9 dates for such city, town, and district elections, the purpose of this 10 section being to establish mandatory dates for holding elections. This 11 section shall not be construed as fixing the time for holding primary 12 elections, or elections for the recall of any elective public officer.

13 Sec. 9. RCW 29A.04.330 and 2011 c 349 s 4 are each amended to read 14 as follows:

(1) All city, town, and district general elections shall be held
 throughout the state of Washington on the first Tuesday following the
 first Monday in November in the odd-numbered years.

This section shall not apply to:

19 (a) Elections for the recall of any elective public officer;

(b) Public utility districts, conservation districts, or district elections at which the ownership of property within those districts is a prerequisite to voting, all of which elections shall be held at the times prescribed in the laws specifically applicable thereto;

(c) Consolidation proposals as provided for in RCW 28A.315.235 and
 nonhigh capital fund aid proposals as provided for in chapter 28A.540
 RCW; and

(d) Special flood control districts consisting of three or morecounties.

29 (2) The county auditor, as ex officio supervisor of elections, upon request in the form of a resolution of the governing body of a city, 30 31 town, or district, presented to the auditor prior to the proposed election date, ((may)) shall call a special election in such city, 32 town, or district, and for the purpose of such special election he or 33 she may combine, unite, or divide precincts. Such a special election 34 35 shall be held on one of the following dates as decided by the governing 36 body:

37 (a) The second Tuesday in February;

1 (b) The ((third Tuesday in April until January 1, 2013;

(c) The)) fourth Tuesday in April ((on or after January 1, 2013));

3 (((d))) <u>(c)</u> The day of the primary election as specified by RCW 4 29A.04.311; or

(3) A resolution calling for a special election on a date set forth 6 7 in subsection (2)(a) ((through (c))) and (b) of this section must be presented to the county auditor at least forty-six days prior to the 8 election date. A resolution calling for a special election on a date 9 10 set forth in subsection $(2)((\frac{d}{d}))$ (c) of this section must be presented to the county auditor no later than the Friday immediately 11 12 before the first day of regular candidate filing. A resolution calling 13 for a special election on a date set forth in subsection $(2)((\frac{(e)}{(e)}))$ (d) 14 of this section must be presented to the county auditor no later than the day of the primary. 15

16 (4) In addition to subsection (2)(a) through $\left(\left(\frac{1}{2}\right)\right)$ (d) of this 17 section, a special election to validate an excess levy or bond issue may be called at any time to meet the needs resulting from fire, flood, 18 earthquake, or other act of God, except that no special election may be 19 held between the first day for candidates to file for public office and 20 21 the last day to certify the returns of the general election other than 22 as provided in subsection $(2)((\frac{d}{d}))$ (c) and $((\frac{d}{d}))$ (d) of this Such special election shall be conducted and notice thereof 23 section. 24 given in the manner provided by law.

(5) This section shall supersede the provisions of any and all other statutes, whether general or special in nature, having different dates for such city, town, and district elections, the purpose of this section being to establish mandatory dates for holding elections.

29 Sec. 10. RCW 29A.04.410 and 2003 c 111 s 146 are each amended to 30 read as follows:

Every city, town, and district is liable for its proportionate share of the costs when such elections are held in conjunction with other elections held under RCW ((29A.04.320)) <u>29A.04.321</u> and 29A.04.330.

Whenever any city, town, or district holds any primary or election, general or special, on an isolated date, all costs of such elections must be borne by the city, town, or district concerned. 1 The purpose of this section is to clearly establish that the county 2 is not responsible for any costs involved in the holding of any city, 3 town, or district election.

4 In recovering such election expenses, including a reasonable proration of administrative costs, the county auditor shall certify the 5 cost to the county treasurer with a copy to the clerk or auditor of the б 7 city, town, or district concerned. Upon receipt of such certification, 8 the county treasurer shall make the transfer from any available and appropriate city, town, or district funds to the county current expense 9 10 fund or to the county election reserve fund if such a fund is established. Each city, town, or district must be promptly notified by 11 12 the county treasurer whenever such transfer has been completed. 13 However, in those districts wherein a treasurer, other than the county 14 treasurer, has been appointed such transfer procedure does not apply, but the district shall promptly issue its warrant for payment of 15 election costs. 16

17 **Sec. 11.** RCW 29A.04.420 and 2003 c 111 s 147 are each amended to 18 read as follows:

(1) Whenever state officers or measures are voted upon at a state primary or general election held in an odd-numbered year under RCW ((29A.04.320)) 29A.04.321, the state of Washington shall assume a prorated share of the costs of that state primary or general election.

(2) Whenever a primary or vacancy election is held to fill a vacancy in the position of United States senator or United States representative under chapter 29A.28 RCW, the state of Washington shall assume a prorated share of the costs of that primary or vacancy election.

(3) The county auditor shall apportion the state's share of these
 expenses when prorating election costs under RCW 29A.04.410 and shall
 file such expense claims with the secretary of state.

31 (4) The secretary of state shall include in his or her biennial 32 budget requests sufficient funds to carry out this section. 33 Reimbursements for election costs shall be from appropriations 34 specifically provided by law for that purpose.

35 **Sec. 12.** RCW 29A.08.020 and 2004 c 267 s 103 are each amended to 36 read as follows:

1 The definitions set forth in this section apply throughout this 2 chapter, unless the context clearly requires otherwise.

3 (1) "By mail" means delivery of a completed original voter 4 registration application by mail to <u>a county auditor or</u> the office of 5 the secretary of state.

(2) For voter registration applicants, "date of mailing" means the б 7 date of the postal cancellation on the voter registration application. 8 This date will also be used as the date of application for the purpose meeting the registration cutoff deadline. 9 of If the postal 10 cancellation date is illegible then the date of receipt by the elections official is considered the date of application. 11 If an 12 application is received by ((the elections official)) a county auditor 13 or the office of the secretary of state by the close of business on the fifth day after the cutoff date for voter registration and the postal 14 cancellation date is illegible, the application will be considered to 15 have arrived by the cutoff date for voter registration. 16

17 **Sec. 13.** RCW 29A.08.220 and 2004 c 267 s 115 are each amended to 18 read as follows:

(1) The secretary of state shall specify by rule the format of all 19 20 voter registration applications. These applications shall be 21 compatible with existing voter registration records. An applicant for 22 voter registration shall be required to complete only one application 23 and to provide the required information other than his or her signature 24 no more than one time. These applications shall also contain 25 information for the voter to ((transfer)) update his or her 26 registration.

27 (2) Any application format specified by the secretary for use in 28 registering to vote in state and local elections shall satisfy the 29 requirements of the National Voter Registration Act of 1993 (P.L. 103-30 31) and the Help America Vote Act of 2002 (P.L. 107-252) for 31 registering to vote in federal elections.

32 (((2) All registration applications required under RCW 29A.08.210 33 and 29A.08.340 shall be produced and furnished by the secretary of 34 state to the county auditors and the department of licensing.))

35 **Sec. 14.** RCW 29A.08.230 and 2009 c 369 s 17 are each amended to 36 read as follows:

For all voter registrations, the registrant shall sign the
 following oath:

3 "I declare that the facts on this voter registration form are true. I am a citizen of the United States, I am not ((presently denied the 4 5 right to vote as a result of being convicted of a felony)) under the authority of the department of corrections for a Washington felony б conviction, I am not disqualified from voting due to a court order, I 7 will have lived in Washington at this address for thirty days 8 9 immediately before the next election at which I vote, and I will be at 10 least eighteen years old when I vote."

11 **Sec. 15.** RCW 29A.08.260 and 2009 c 369 s 18 are each amended to 12 read as follows:

(1) All registration applications required under RCW 29A.08.210 and
 29A.08.340 shall be produced and furnished by the secretary of state to
 the county auditors and the department of licensing.

(2) The county auditor shall distribute forms by which a person may 16 17 register to vote by mail and transfer any previous registration in this The county auditor shall keep a supply of voter registration 18 state. 19 forms in his or her office at all times for political parties and 20 others interested in assisting in voter registration, and shall make 21 every effort to make these forms generally available to the public. The county auditor shall provide voter registration forms to city and 22 23 town clerks, state offices, schools, fire stations, public libraries, 24 and any other locations considered appropriate by the auditor or 25 secretary of state for extending registration opportunities to all After the initial distribution of voter 26 areas of the county. registration forms to a given location, a representative designated by 27 the official in charge of that location shall notify the county auditor 28 of the need for additional voter registration supplies. 29

30 Sec. 16. RCW 29A.08.330 and 2009 c 369 s 20 are each amended to 31 read as follows:

32 (1) The secretary of state shall prescribe the method of voter 33 registration for each designated agency. The agency shall use either 34 the state voter registration by mail form with a separate declination 35 form for the applicant to indicate that he or she declines to register at this time, or the agency may use a separate form approved for use by
 the secretary of state.

(2) The person providing service at the agency shall offer voter 3 registration services to every client whenever he or she applies for 4 5 service or assistance and with each renewal, recertification, or change of address. The person providing service shall give the applicant the б 7 same level of assistance with the voter registration application as is 8 offered to fill out the agency's forms and documents, including and 9 information about age citizenship requirements for voter 10 registration.

(3) The person providing service at the agency shall determine if the prospective applicant wants to register to vote or ((transfer)) update his or her voter registration by asking the following question:

14 "Do you want to register to vote or ((transfer)) <u>update</u> your voter 15 registration?"

16 If the applicant chooses to register or ((transfer)) <u>update</u> a 17 registration, the service agent shall ask the following:

18 (a) "Are you a United States citizen?"

19 (b) "Are you or will you be eighteen years of age on or before the 20 next election?"

If the applicant answers in the affirmative to both questions, the agent shall then provide the applicant with a voter registration form and instructions and shall record that the applicant has requested to register ((to vote or transfer)) or update a voter registration. If the applicant answers in the negative to either question, the agent shall not provide the applicant with a voter registration form.

(4) If an agency uses a computerized application process, it may, in consultation with the secretary of state, develop methods to capture simultaneously the information required for voter registration during a person's computerized application process.

31 (5) Each designated agency shall transmit the applications to the 32 secretary of state or appropriate county auditor within three business 33 days.

34 **Sec. 17.** RCW 29A.08.340 and 2003 c 111 s 225 are each amended to 35 read as follows:

36 (1) A person may register to vote((, transfer a voter registration,

or change his or her name for)) or update his or her voter registration
((purposes)) when he or she applies for or renews a driver's license or
identification card under chapter 46.20 RCW.

4 (2) To register to vote((, transfer his or her voter registration,
5 or change his or her name for voter registration purposes under this
6 section)) or update a registration, the applicant shall provide the
7 information required by RCW ((29A.08.210)) 29A.08.010.

8 (3) The driver licensing agent shall record that the applicant has 9 requested to register to vote or ((transfer)) <u>update</u> a voter 10 registration.

11 **Sec. 18.** RCW 29A.08.350 and 2009 c 369 s 21 are each amended to 12 read as follows:

13 The department of licensing shall produce and transmit to the 14 secretary of state the following information from the records of each individual who requested a voter registration or ((transfer)) update at 15 a driver's license facility: The name, address, date of birth, gender 16 of the applicant, the driver's license number, and the date on which 17 18 the application for voter registration or ((transfer)) update was submitted. The secretary of state shall process the registrations and 19 20 ((transfers)) updates as an electronic application.

21 Sec. 19. RCW 29A.08.520 and 2009 c 325 s 1 are each reenacted to 22 read as follows:

(1) For a felony conviction in a Washington state court, the right to vote is provisionally restored as long as the person is not under the authority of the department of corrections. For a felony conviction in a federal court or any state court other than a Washington state court, the right to vote is restored as long as the person is no longer incarcerated.

(2)(a) Once the right to vote has been provisionally restored, the sentencing court may revoke the provisional restoration of voting rights if the sentencing court determines that a person has willfully failed to comply with the terms of his or her order to pay legal financial obligations.

34 (b) If the person has failed to make three payments in a 35 twelve-month period and the county clerk or restitution recipient requests, the prosecutor shall seek revocation of the provisional
 restoration of voting rights from the court.

3 (c) To the extent practicable, the prosecutor and county clerk 4 shall inform a restitution recipient of the recipient's right to ask 5 for the revocation of the provisional restoration of voting rights.

Immediately after their tabulation, all ballots counted at a ballot counting center must be sealed in containers that identify the primary or election and be retained for at least sixty days or according to federal law, whichever is longer.

In the presence of major party observers who are available, ballots 1 2 may be removed from the sealed containers at the elections department 3 and consolidated into one sealed container for storage purposes. (4) A record must be kept of all ballots with missing and mismatched signatures.
