1 AN ACT Relating to promoting economic development by providing
2 information to businesses; and amending RCW 19.02.050.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 19.02.050 and 2011 c 298 s 6 are each amended to read

5 (m) Department of archaeology and historic preservation;
6 (n) Department of early learning;
7 (o) Department of ecology;
8 (p) Department of financial institutions;
9 (q) Department of transportation;
10 (r) Gambling commission;
11 (s) Horse racing commission;
12 (t) Office of the insurance commissioner;
13 (u) State lottery;
14 (v) Student achievement council;
15 (w) Washington state patrol;
16 (x) Workforce training and education coordinating board; and
17 (y) Other agencies as determined by the governor.

18 (2) Each agency will be considered as fully participating upon
19 providing the department with the application and the information
20 identifying the requirements to complete the application for every
21 business license issued by the agency.

22 (3) Unless provided otherwise in the timetable established under
23 subsection (1) of this section, each agency, using a format acceptable
24 to the department, must certify its full participation to the
25 department by the November 1st of each year, beginning November 1,
26 2013. If an agency has not submitted all the licensing information
27 necessary for full participation, the agency must instead submit a
28 progress report and explanation to the department. The department
29 shall compile the information submitted by each agency, and submit an
30 aggregate report to the governor and the economic development
31 committees of the legislature by January 1st of each year, beginning
32 January 1, 2014.
