1 AN ACT Relating to promoting economic development by providing
2 information to businesses; and amending RCW 19.02.050.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 19.02.050 and 2011 c 298 s 6 are each amended to read

16 (y) Other agencies as determined by the governor.

17 (2) Each agency will be considered as fully participating upon
18 providing the department with the application and the information
19 identifying the requirements to complete the application for every
20 business license issued by the agency.

21 (3) Each agency, using a format acceptable to the department, must
22 certify its full participation to the department by the November 1st of
23 each year, beginning November 1, 2013. If an agency has not submitted
24 all the licensing information necessary for full participation, the
25 agency must instead submit a progress report and explanation to the
26 department. The department shall compile the information submitted by
27 each agency, and submit an aggregate report to the governor and the
28 economic development committees of the legislature by January 1st of
29 each year, beginning January 1, 2014.
