- 5 **Sec. 1.** RCW 79A.05.230 and 1990 c 49 s 3 are each amended to read 6 as follows:
- 7 The fee for the issuance of special winter recreational area
- 8 parking permits shall be determined by the commission after
- 9 consultation with the winter recreation advisory committee. If the
- 10 person making application therefor is also the owner of a snowmobile
- 11 registered pursuant to chapter 46.10 RCW, there ((shall)) may be ((no))
- 12 <u>a</u> fee for the issuance of an annual permit <u>as determined by the</u>
- 13 <u>commission after consultation with the snowmobile advisory committee</u>.
- 14 All special winter recreational area parking permits shall commence and
- 15 expire on the dates established by the commission.
