1 AN ACT Relating to continuing the use of the legislature's sunset  
2 review process; amending RCW 43.131.900; creating a new section; and  
3 providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that the sunset review  
6 process allows the legislature to evaluate the need for the continued  
7 existence of agencies and programs, to assess the effectiveness and  
8 performance of these agencies and programs, and to ensure public  
9 accountability. It is the intent of the legislature to continue using  
10 this important accountability tool.

11 **Sec. 2.** RCW 43.131.900 and 2000 c 189 s 12 are each amended to  
12 read as follows:

13 RCW 43.131.010 through 43.131.150 (~~shall~~) expire (~~on~~) June 30,  
14 (~~2015~~) 2025, unless extended by law for an additional fixed period of  
15 time.
