1 AN ACT Relating to Seattle Sounders FC and Seattle Seahawks special
2 license plates; amending RCW 46.18.200, 46.17.220, 46.68.420,
3 46.18.100, and 46.18.060; adding new sections to chapter 46.04 RCW; and
4 providing an effective date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 46.18.200 and 2012 c 65 s 1 are each amended to read
7 as follows:

8 (1) Special license plate series reviewed and approved by the
9 department:

10 (a) May be issued in lieu of standard issue or personalized license
11 plates for vehicles required to display one and two license plates
12 unless otherwise specified;

13 (b) Must be issued under terms and conditions established by the
14 department;

15 (c) Must not be issued for vehicles registered under chapter 46.87
16 RCW; and

17 (d) Must display a symbol or artwork approved by the department.

18 (2) The department approves and shall issue the following special
19 license plates:

13 (3) Applicants for initial and renewal professional firefighters
14 and paramedics special license plates must show proof eligibility by
15 providing a certificate of current membership from the Washington state
16 council of firefighters.

17 (4) Applicants for initial volunteer firefighters special license
18 plates must (a) have been a volunteer firefighter for at least ten
19 years or be a volunteer firefighter for one or more years and (b) have
20 documentation of service from the district of the appropriate fire
21 service. If the volunteer firefighter leaves firefighting service
22 before ten years of service have been completed, the volunteer
23 firefighter shall surrender the license plates to the department on the
24 registration renewal date. If the volunteer firefighter stays in
25 service for at least ten years and then leaves, the license plate may
26 be retained by the former volunteer firefighter and as long as the
27 license plate is retained for use the person will continue to pay the
28 future registration renewals. A qualifying volunteer firefighter may
29 have no more than one set of license plates per vehicle, and a maximum
30 of two sets per applicant, for their personal vehicles. If the
31 volunteer firefighter is convicted of a violation of RCW 46.61.502 or
32 a felony, the license plates must be surrendered upon conviction.

33 **Sec. 2.** RCW 46.17.220 and 2012 c 65 s 4 are each amended to read
34 as follows:

35 (1) In addition to all fees and taxes required to be paid upon

1 application for a vehicle registration in chapter 46.16A RCW, the
 2 holder of a special license plate shall pay the appropriate special
 3 license plate fee as listed in this section.

10 (2) After deducting administration and collection expenses for the
11 sale of baseball stadium license plates, the remaining proceeds must be
12 distributed to a county for the purpose of paying the principal and
13 interest payments on bonds issued by the county to construct a baseball
14 stadium, as defined in RCW 82.14.0485, including reasonably necessary
15 preconstruction costs, while the taxes are being collected under RCW
16 82.14.360. After this date, the state treasurer shall credit the funds
17 to the state general fund.

18 **Sec. 3.** RCW 46.68.420 and 2012 c 65 s 5 are each amended to read
19 as follows:

20 (1) The department shall:

21 (a) Collect special license plate fees established under RCW
22 46.17.220;

23 (b) Deduct an amount not to exceed twelve dollars for initial issue
24 and two dollars for renewal issue for administration and collection
25 expenses incurred by it; and

26 (c) Remit the remaining proceeds to the custody of the state
27 treasurer with a proper identifying detailed report.

28 (2) The state treasurer shall credit the proceeds to the motor
29 vehicle account until the department determines that the state has been
30 reimbursed for the cost of implementing the special license plate.
31 Upon determination by the department that the state has been
32 reimbursed, the state treasurer shall credit the remaining special
33 license plate fee amounts for each special license plate to the
34 following appropriate account as created in this section in the custody
35 of the state treasurer:

5 (3) Only the director or the director's designee may authorize
6 expenditures from the accounts described in subsection (2) of this
7 section. The accounts are subject to allotment procedures under
8 chapter 43.88 RCW, but an appropriation is not required for
9 expenditures.

10 (4) Funds in the special license plate accounts described in
11 subsection (2) of this section must be disbursed subject to the
12 conditions described in subsection (2) of this section and under
13 contract between the department and qualified nonprofit organizations
14 that provide the services described in subsection (2) of this section.

15 (5) For the purposes of this section, a "qualified nonprofit
16 organization" means a not-for-profit corporation operating in
17 Washington that has received a determination of tax exempt status under
18 26 U.S.C. Sec. 501(c)(3). The qualified nonprofit organization must
19 meet all the requirements under RCW 46.18.100(1).

20 **Sec. 4.** RCW 46.18.100 and 2010 c 161 s 605 are each amended to
21 read as follows:

22 (1) For an organization to qualify for a special license plate
23 under the special license plate approval program created in this
24 chapter, the sponsoring organization must submit documentation (~~in~~
25 ~~conjunction with the application~~) to the department that verifies that
26 the organization is:

27 (a)(i) A nonprofit organization, as defined in 26 U.S.C. Sec.
28 501(c)(3). The department may request a copy of an Internal Revenue
29 Service ruling to verify an organization's nonprofit status; and

30 ~~((b))~~ (ii) Located in Washington state and has registered as a
31 charitable organization with the secretary of state's office as
32 required by law; or

33 (b)(i) A professional sports franchise located in Washington state;
34 and

35 (ii) Using the proceeds from a special license plate in conjunction

1 with a nonprofit organization, as defined in 26 U.S.C. Sec. 501(c)(3),
2 solely for the purposes outlined under RCW 46.68.420.

3 (2) For a governmental body to qualify for a special license plate
4 under the special license plate approval program created in this
5 chapter, a governmental body must be:

6 (a) A political subdivision including, but not limited to, any
7 county, city, town, municipal corporation, or special purpose taxing
8 district that has the express permission of the political subdivision's
9 executive body to sponsor a special license plate;

10 (b) A federally recognized tribal government that has received the
11 approval of the executive body of that government to sponsor a special
12 license plate;

13 (c) A state agency that has received approval from the director of
14 the agency or the department head; or

15 (d) A community or technical college that has the express
16 permission of the college's board of trustees to sponsor a special
17 license plate.

18 **Sec. 5.** RCW 46.18.060 and 2012 c 65 s 6 are each amended to read
19 as follows:

20 (1) The department must review and either approve or reject special
21 license plate applications submitted by sponsoring organizations.

22 (2) Duties of the department include, but are not limited to, the
23 following:

24 (a) Review and approve the annual financial reports submitted by
25 sponsoring organizations with active special license plate series and
26 present those annual financial reports to the joint transportation
27 committee;

28 (b) Report annually to the joint transportation committee on the
29 special license plate applications that were considered by the
30 department;

31 (c) Issue approval and rejection notification letters to sponsoring
32 organizations, the executive committee of the joint transportation
33 committee, and the legislative sponsors identified in each application.
34 The letters must be issued within seven days of making a determination
35 on the status of an application; and

36 (d) Review annually the number of plates sold for each special

1 license plate series created after January 1, 2003. The department may
2 submit a recommendation to discontinue a special plate series to the
3 executive committee of the joint transportation committee.

4 (3) (~~Except as provided in RCW 46.18.245,~~) In order to assess the
5 effects and impact of the proliferation of special license plates, the
6 legislature declares a temporary moratorium on the issuance of any
7 additional plates until July 1, 2013. During this period of time, the
8 department is prohibited from accepting, reviewing, processing, or
9 approving any applications. Additionally, a special license plate may
10 not be enacted by the legislature during the moratorium, unless the
11 proposed license plate has been approved by the former special license
12 plate review board before February 15, 2005.

13 (4) The limitations under subsection (3) of this section do not
14 apply to the following special license plates:

15 (a) 4-H license plates created under RCW 46.18.200;

16 (b) Gold star license plates created under RCW 46.18.245;

17 (c) Music Matters license plates created under RCW 46.18.200;

18 (~~(e)~~) (d) Seattle Seahawks license plates created under RCW
19 46.18.200;

20 (e) Seattle Sounders FC license plates created under RCW 46.18.200;

21 (f) State flower license plates created under RCW 46.18.200;

22 (~~(d)~~) (g) Volunteer firefighter license plates created under RCW
23 46.18.200.

24 NEW SECTION. Sec. 6. A new section is added to chapter 46.04 RCW
25 to read as follows:

26 "Seattle Sounders FC license plates" means special license plates
27 issued under RCW 46.18.200 that display a symbol or artwork recognizing
28 Seattle Sounders FC.

29 NEW SECTION. Sec. 7. A new section is added to chapter 46.04 RCW
30 to read as follows:

31 "Seattle Seahawks license plates" means special license plates
32 issued under RCW 46.18.200 that display a symbol or artwork recognizing
33 the Seattle Seahawks.

1 NEW SECTION. **Sec. 8.** This act takes effect January 1, 2014.
