- 4 **Sec. 1.** RCW 46.18.245 and 2010 c 161 s 621 are each amended to read as follows:
- (1) A registered owner who is ((the mother or father)) an eliqible
 family member of a member of the United States armed forces who died
 while in service to his or her country, or as a result of his or her
- 9 service, may apply to the department for special gold star license 10 plates for use on a motor vehicle. The registered owner must:

- 3 (c) Provide certification from the Washington state department of 4 veterans affairs that the registered owner qualifies for the special 5 license plate under this section;
 - $((\frac{c}{c}))$ <u>(d)</u> Be recorded as the registered owner of the motor vehicle on which the gold star license plates will be displayed; and
- 8 $((\frac{d}{d}))$ <u>(e)</u> Pay all fees and taxes required by law for registering 9 the motor vehicle.
- 10 (2) Gold star license plates must be issued:
 - (a) Only for motor vehicles owned by qualifying applicants; and
- 12 (b) Without payment of any license plate fee.
- 13 (3) Gold star license plates must be replaced, free of charge, if 14 the license plates become lost, stolen, damaged, defaced, or destroyed.
