1            AN ACT Relating to requiring certain information in commercial  
2 fishing guide license applications; amending RCW 77.65.480 and  
3 77.65.370; and adding a new section to chapter 77.65 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            NEW SECTION.    **Sec. 1.** A new section is added to chapter 77.65 RCW  
6 to read as follows:

7            (1) Any application for a food fish guide license under RCW  
8 77.65.370 or game fish guide license under RCW 77.65.480 must include:

9            (a) The applicant's driver's license or other government-issued  
10 identification card number and the jurisdiction of issuance;

11            (b) The applicant's unified business identifier number under a  
12 master license issued under RCW 19.02.070;

13            (c) Proof of current certification in first aid and cardiopulmonary  
14 resuscitation;

15            (d) A certificate of insurance demonstrating that the applicant has  
16 commercial liability coverage of at least three hundred thousand  
17 dollars; and

18            (e) If applicable, an original or notarized copy of a valid license

1 issued by the United States coast guard to the applicant that  
2 authorizes the holder to carry passengers for hire.

3 (2) The requirements of this section related to licensure by the  
4 United States coast guard apply only to applicants intending to carry  
5 passengers for hire with a motorized vessel on federally recognized  
6 navigable waters. The license issued by the United States coast guard  
7 must be valid in the waters where the game fish guide or food fish  
8 guide license applicant will be carrying passengers for hire in a  
9 motorized vessel.

10 (3) The requirements in this section are in addition to the  
11 requirements of RCW 77.65.050.

12 **Sec. 2.** RCW 77.65.480 and 2011 c 339 s 30 are each amended to read  
13 as follows:

14 (1) A taxidermy license allows the holder to practice taxidermy for  
15 commercial purposes, as that term is defined in RCW 77.15.110. The fee  
16 for this license is one hundred eighty dollars. The application fee is  
17 seventy dollars.

18 (2) A fur dealer's license allows the holder to purchase, receive,  
19 or resell raw furs for commercial purposes, as that term is defined in  
20 RCW 77.15.110. The fee for this license is one hundred eighty dollars.  
21 The application fee is seventy dollars.

22 (3) A game fish guide license allows the holder to offer or perform  
23 the services of a game fish guide in the taking of game fish. The fee  
24 for this license is one hundred eighty dollars for a resident and six  
25 hundred dollars for a nonresident. The application fee is seventy  
26 dollars. An application for a game fish guide license must include the  
27 information required in section 1 of this act.

28 (4) A game farm license allows the holder to operate a game farm to  
29 acquire, breed, grow, keep, and sell wildlife under conditions  
30 prescribed by the rules adopted pursuant to this title. The fee for  
31 this license is seventy-two dollars for the first year and forty-eight  
32 dollars for each following year. The application fee is seventy  
33 dollars.

34 (5) A game fish stocking permit allows the holder to release game  
35 fish into the waters of the state as prescribed by rule of the  
36 commission. The fee for this permit is twenty-four dollars. The  
37 application fee is seventy dollars.

1 (6) A fishing or field trial permit allows the holder to promote,  
2 conduct, hold, or sponsor a fishing or field trial contest in  
3 accordance with rules of the commission. The fee for a fishing contest  
4 permit is twenty-four dollars. The fee for a field trial contest  
5 permit is twenty-four dollars. The application fee is seventy dollars.

6 (7)(a) An anadromous game fish buyer's license allows the holder to  
7 purchase or sell steelhead trout and other anadromous game fish  
8 harvested by Indian fishers lawfully exercising fishing rights reserved  
9 by federal statute, treaty, or executive order, under conditions  
10 prescribed by rule of the director. The fee for this license is one  
11 hundred eighty dollars. The application fee is one hundred five  
12 dollars.

13 (b) An anadromous game fish buyer's license is not required for  
14 those businesses that buy steelhead trout and other anadromous game  
15 fish from Washington licensed game fish dealers and sell solely at  
16 retail.

17 **Sec. 3.** RCW 77.65.370 and 2009 c 333 s 8 are each amended to read  
18 as follows:

19 (1) A person shall not offer or perform the services of a food fish  
20 guide without a food fish guide license in the taking of food fish for  
21 personal use in freshwater rivers and streams, except that a charter  
22 boat license is required to operate a vessel from which a person may  
23 for a fee fish for food fish in state waters listed in RCW  
24 77.65.150(4)(b).

25 (2) Only an individual at least sixteen years of age may hold a  
26 food fish guide license. No individual may hold more than one food  
27 fish guide license.

28 (3) An application for a food fish guide license must include the  
29 information required in section 1 of this act.
