- 1 AN ACT Relating to recognizing "Native American Heritage Day";
- 2 amending RCW 1.16.050 and 28A.150.050; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** (1) The Washington state legislature finds 5 that:
  - (a) Native Americans have long inhabited the area now known as Washington state, living in sustainable cultures based on cooperation and respect for the land and all creatures;
    - (b) Native Americans suffered many grave injustices when nontribal people settled in Washington state, but endured to preserve remarkable American Indian cultures;
- 12 (c) Native Americans have contributed immeasurably to Washington 13 state and the United States as scholars, artists, entrepreneurs, and 14 leaders in all realms of society;
- (d) Native Americans have served with honor and distinction in the United States armed forces, and many made the ultimate sacrifice in that service;
- 18 (e) Many states have designated days, weeks, or months honoring 19 Native American heritage, and on October 21, 2013, President Barack

- 1 Obama proclaimed November 2013 as National Native American Heritage
- 2 Month and called upon all Americans to celebrate November 29, 2013, as
- 3 Native American Heritage Day; and
- 4 (f) More than one hundred eighty federally acknowledged Native 5 American tribes in the United States, including many Washington state 6 tribes, support recognizing a day honoring Native American heritage.
- 7 (2) The Washington state legislature therefore intends to recognize 8 and honor Washington state's proud and resonant Native American 9 heritage by designating the Friday immediately following the fourth 10 Thursday in November, currently a state legal and school holiday, as 11 "Native American Heritage Day."
- 12 **Sec. 2.** RCW 1.16.050 and 2013 c 5 s 1 are each amended to read as 13 follows:
- 14 <u>(1)</u> The following are <u>state</u> legal holidays:
- 15 <u>(a)</u> Sunday;
- 16 (b) The first day of January, commonly called New Year's Day;
- 17 <u>(c)</u> The third Monday of January, ((being)) celebrated as the anniversary of the birth of Martin Luther King, Jr.;
- 19 <u>(d) The third Monday of February,</u> to be known as Presidents' Day 20 and ((to be)) celebrated as the anniversary of the births of Abraham 21 Lincoln and George Washington;
- 22 <u>(e)</u> The last Monday of May, commonly known as Memorial Day;
- 23 <u>(f)</u> The fourth day of July, ((being)) the anniversary of the 24 Declaration of Independence;
- 25 (g) The first Monday in September, to be known as Labor Day;
- 26 (h) The eleventh day of November, to be known as Veterans' Day;
- 27 <u>(i) The fourth Thursday in November, to be known as Thanksgiving</u>
  28 Day;
- 29 <u>(j) The ((day)) Friday</u> immediately following ((<del>Thanksgiving</del>)) the 30 <u>fourth Thursday in November, to be known as Native American Heritage</u>
- 31 Day; and
- 32 <u>(k) The twenty-fifth day of December, commonly called Christmas</u>
  33 Day.
- 34 (2) Employees of the state and its political subdivisions, except 35 employees of school districts and except those nonclassified employees 36 of institutions of higher education who hold appointments or are 37 employed under contracts to perform services for periods of less than

- twelve consecutive months, ((shall-be)) are entitled to one paid 1 holiday per calendar year in addition to those specified in this 2 section. Each employee of the state or its political subdivisions may 3 select the day on which the employee desires to take the additional 4 holiday provided for ((herein)) in this section after consultation with 5 the employer pursuant to guidelines to be promulgated by rule of the 6 7 appropriate personnel authority, or in the case of local government by ordinance or resolution of the legislative authority. 8
  - (3) If any of the ((above—specified)) state legal holidays specified in this section are also federal legal holidays but observed on different dates, only the state legal holidays ((shall—be)) are recognized as a paid legal holiday for employees of the state and its political subdivisions ((except—that—for)). However, for port districts and the law enforcement and public transit employees of municipal corporations, either the federal or the state legal holiday is recognized as a paid legal holiday, but in no case may both((, may)) holidays be recognized as a paid legal holiday for employees.
- 18 (4) Whenever any state legal holiday((-)):
- 19 <u>(a) O</u>ther than Sunday, falls upon a Sunday, the following Monday 20 ((shall be)) <u>is</u> the legal holiday((-

  - (5) Nothing in this section ((shall)) may be construed to have the effect of adding or deleting the number of paid holidays provided for in an agreement between employees and employers of political subdivisions of the state or as established by ordinance or resolution of the local government legislative authority.
- 29 <u>(6)</u> The legislature declares that <u>the following days are recognized</u>
