1 AN ACT Relating to use of the job order contracting procedure by
2 the department of transportation; and amending RCW 39.10.420 and
3 43.131.408.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 39.10.420 and 2012 c 102 s 1 are each amended to read
6 as follows:

7 (1) The following public bodies are authorized to use the job order
8 contracting procedure:

9 (a) The department of enterprise services;

10 (b) The state universities, regional universities, and The
11 Evergreen State College;

12 (c) Sound transit (central Puget Sound regional transit authority);

13 (d) Every city with a population greater than seventy thousand and
14 any public authority chartered by such city under RCW 35.21.730 through
15 35.21.755;

16 (e) Every county with a population greater than four hundred fifty
17 thousand;

18 (f) Every port district with total revenues greater than fifteen
19 million dollars per year;

1 (g) Every public utility district with revenues from energy sales
2 greater than twenty-three million dollars per year;

3 (h) Every school district; (~~and~~)

4 (i) The state ferry system; and

5 (j) The Washington state department of transportation, for the
6 administration of building improvement, replacement, and renovation
7 projects only.

8 (2)(a) The department of enterprise services may issue job order
9 contract work orders for Washington state parks department projects.

10 (b) The department of enterprise services, the University of
11 Washington, and Washington State University may issue job order
12 contract work orders for the state regional universities and The
13 Evergreen State College.

14 (3) Public bodies may use a job order contract for public works
15 projects when a determination is made that the use of job order
16 contracts will benefit the public by providing an effective means of
17 reducing the total lead-time and cost for the construction of public
18 works projects for repair and renovation required at public facilities
19 through the use of unit price books and work orders by eliminating
20 time-consuming, costly aspects of the traditional public works process,
21 which require separate contracting actions for each small project.
