1 On page 2, after line 10, insert the following:

2 "Sec. 2. RCW 46.17.350 and 2014 c 30 s 2 are each amended to
3 read as follows:

4 (1) Before accepting an application for a vehicle registration,
5 the department, county auditor or other agent, or subagent appointed
6 by the director shall require the applicant, unless specifically
7 exempt, to pay the following vehicle license fee by vehicle type:

8 (2) The vehicle license fee required in subsection (1) of this
9 section is in addition to the filing fee required under RCW
10 46.17.005, except as provided in RCW 46.17.005(2), and any other fee
11 or tax required by law.

12 **Sec. 3.** RCW 46.17.005 and 2010 c 161 s 501 are each amended to
13 read as follows:

14 (1) Except as provided in subsection (2) of this section, a
15 person who applies for a vehicle registration or for any other right
16 to operate a vehicle on the highways of this state shall pay a three
17 dollar filing fee in addition to any other fees and taxes required by
18 law.

19 (2) The three dollar filing fee required under subsection (1) of
20 this section for a person who applies for a vehicle registration for
21 a vehicle subject to the license fee under RCW 46.17.350(1)(a), (d)
22 through (h), (j), and (n) through (q) is contained in the cost of the
23 vehicle license fee and is not in addition to any other fees and
24 taxes required by law. However, this three dollar filing fee must be
25 distributed under RCW 46.68.400.

26 (3) A person who applies for a certificate of title shall pay a
27 four dollar filing fee in addition to any other fees and taxes
28 required by law.

29 ~~((3))~~ (4) The filing fees established in this section must be
30 distributed under RCW 46.68.400."

31 Renumber the remaining section consecutively, correct any
32 internal references accordingly, and correct the title.

EFFECT: The existing three dollar filing fee from the existing thirty dollar registration fee will be distributed as currently distributed in statute (RCW 46.68.400).
