- 9 (1) The superintendent of public instruction shall develop
- 10 regulations and guidelines to eliminate sex discrimination as it
- 11 applies to public school employment, counseling and guidance
- 12 services to students, recreational and athletic activities for
- 13 students, access to course offerings, and in textbooks and
- 14 instructional materials used by students.
- 15 (a) Specifically with respect to public school employment, all
- 16 schools shall be required to:
- 17 (i) Maintain credential requirements for all personnel without
- 18 regard to sex;
- 19 (ii) Make no differentiation in pay scale on the basis of sex;
- 20 (iii) Assign school duties without regard to sex except where
- 21 such assignment would involve duty in areas or situations, such as
- 22 but not limited to a shower room, where persons might be disrobed;
- 23 (iv) Provide the same opportunities for advancement to males and
- 24 females; and
- 25 (v) Make no difference in conditions of employment including,
- 26 but not limited to, hiring practices, leaves of absence, hours of

- $\ensuremath{\mathbf{1}}$  employment, and assignment of, or pay for, instructional and
- 2 noninstructional duties, on the basis of sex.
- 3 (b) Specifically with respect to counseling and guidance
- 4 services for students, they shall be made available to all students
- 5 equally. All certificated personnel shall be required to stress
- 6 access to all career and vocational opportunities to students
- 7 without regard to sex.
- 8 (c) Specifically with respect to recreational and athletic
- 9 activities, they shall be offered to all students without regard to
- 10 sex. Schools may provide separate teams for each sex. Schools which
- 11 provide the following shall do so with no disparities based on sex:
- 12 Equipment and supplies; medical care; services and insurance;
- 13 transportation and per diem allowances; opportunities to receive
- 14 coaching and instruction; laundry services; assignment of game
- 15 officials; opportunities for competition, publicity and awards;
- 16 scheduling of games and practice times including use of courts,
- 17 gyms, and pools: PROVIDED, That such scheduling of games and
- 18 practice times shall be determined by local administrative
- 19 authorities after consideration of the public and student interest
- 20 in attending and participating in various recreational and athletic
- 21 activities. Each school which provides showers, toilets, or training
- 22 room facilities for athletic purposes shall provide comparable
- 23 facilities for both sexes. Such facilities may be provided either as
- 24 separate facilities or shall be scheduled and used separately by
- 25 each sex.
- 26 The superintendent of public instruction shall also be required
- 27 to develop a student survey to distribute every three years to each
- 28 local school district in the state to determine student interest for
- 29 male/female participation in specific sports.
- 30 (d) Specifically with respect to course offerings, all classes
- 31 shall be required to be available to all students without regard to
- 32 sex: PROVIDED, That separation is permitted within any class during
- 33 sessions on sex education or gym classes.

- 1 (e) Specifically with respect to textbooks and instructional
- 2 materials, which shall also include, but not be limited to,
- 3 reference books and audiovisual materials, they shall be required to
- 4 adhere to the guidelines developed by the superintendent of public
- 5 instruction to implement the intent of this chapter: PROVIDED, That
- 6 this subsection shall not be construed to prohibit the introduction
- 7 of material deemed appropriate by the instructor for educational
- 8 purposes.
- 9 (2)(a) By December 31, 1994, the superintendent of public
- 10 instruction shall develop criteria for use by school districts in
- 11 developing sexual harassment policies as required under (b) of this
- 12 subsection. The criteria shall address the subjects of grievance
- 13 procedures, remedies to victims of sexual harassment, disciplinary
- 14 actions against violators of the policy, and other subjects at the
- 15 discretion of the superintendent of public instruction. Disciplinary
- 16 actions must conform with collective bargaining agreements and state
- 17 and federal laws. The superintendent of public instruction also
- 18 shall supply sample policies to school districts upon request.
- 19 (b) By June 30, 1995, every school district shall adopt and
- 20 implement a written policy concerning sexual harassment. The policy
- 21 shall apply to all school district employees, volunteers, parents,
- 22 and students, including, but not limited to, conduct between
- 23 students.
- 24 (c) School district policies on sexual harassment shall be
- 25 reviewed by the superintendent of public instruction considering the
- 26 criteria established under (a) of this subsection as part of the
- 27 monitoring process established in RCW 28A.640.030.
- 28 (d) The school district's sexual harassment policy shall be
- 29 conspicuously posted throughout each school building, and provided
- 30 to each employee. A copy of the policy shall appear in any
- 31 publication of the school or school district setting forth the
- 32 rules, regulations, procedures, and standards of conduct for the
- 33 school or school district.

- 1 (e) Each school shall develop a process for discussing the
- 2 district's sexual harassment policy. The process shall ensure the
- 3 discussion addresses the definition of sexual harassment and issues
- 4 covered in the sexual harassment policy.
- 5 (f) "Sexual harassment" as used in this section means unwelcome
- 6 sexual advances, requests for sexual favors, sexually motivated
- 7 physical contact, or other verbal or physical conduct or
- 8 communication of a sexual nature if:
- 9 (i) Submission to that conduct or communication is made a term
- 10 or condition, either explicitly or implicitly, of obtaining an
- 11 education or employment;
- 12 (ii) Submission to or rejection of that conduct or communication
- 13 by an individual is used as a factor in decisions affecting that
- 14 individual's education or employment; or
- 15 (iii) That conduct or communication has the purpose or effect of
- 16 substantially interfering with an individual's educational or work
- 17 performance, or of creating an intimidating, hostile, or offensive
- 18 educational or work environment.
- 19 (3) Schools must provide toilets and restroom facilities for
- 20 each sex with no disparities based on sex. Each school must provide
- 21 facilities to be used separately by each sex. Schools may provide a
- 22 gender-neutral single occupant bathroom to accommodate a student's
- 23 privacy concerns.
- 24 (4) "Sex" as used in this section means biological sex or sex
- 25 assigned at birth.
- 26 (5) The provisions of chapter 49.60 RCW and any rules or
- 27 guidelines adopted by the superintendent of public instruction
- 28 pursuant to the provisions of chapter 49.60 RCW do not apply to
- 29 subsections (1)(c) and (3) of this section."

EFFECT: Makes the following changes:

1

- Provides that school counselors, psychologists, and social workers work with students and families to determine what toilet, restroom and locker room facilities are to be used as required below;
- Requires schools to provide toilets and restroom facilities for each sex with no disparities based on sex and that must be used separately by each sex;
- Allows schools to provide gender-neutral single occupancy bathrooms to accommodate students' privacy concerns;
- Defines sex to mean biological sex or sex assigned at birth; and
- Specifies that the Law Against Discrimination and any rules or guidelines adopted by the Superintendent of Public Instruction do not apply statutes related to provision of toilet and restroom facilities, or recreational and athletic activities, with no disparities based on sex.
