EFFECT: (1) Specifies that the prohibition on a for-profit

school or its agent from selling student loan products applies to "specific consumer student loan products" (rather than "student loan products") and that the for-profit institution is prohibited from inducing students in obtaining specific student loan products (as opposed to prohibiting the "enrollment of students in student loan products"). Defines "agent" to mean any employee, officer, or contractor working on behalf of the institution.

- (2) Allows a for-profit institution to engage in the sale of specific consumer student loan products if the institution can demonstrate that the student has exhausted all federal aid options and has been denied non-institutional private commercial loan products.
- (3) Provides that if the Workforce Training and Education Coordinating Board (Board) does not have information from the forprofit schools that can be calculated for the Career Bridge web site, then the Board must establish procedures, a methodology, and required descriptive material for alternative data to be posted.
