1 Strike everything after the enacting clause and insert the  
2 following:

3 "NEW SECTION. **Sec. 1.** (1) In 2014, the legislature required the  
4 integration of the treatment systems for chemical dependency and  
5 mental health into behavioral health organizations beginning April 1,  
6 2016. There currently exists involuntary treatment for mental health  
7 and limited involuntary treatment for chemical dependency. With the  
8 integration of mental health and chemical dependency into a  
9 behavioral health treatment system, it is the intention of the  
10 legislature to determine the best course of action for integration of  
11 the two involuntary treatment systems into one integrated system.

12 (2) The Washington state institute for public policy shall  
13 complete an evaluation of involuntary treatment systems for chemical  
14 dependency and shall submit a report to the appropriate committees of  
15 the legislature by December 31, 2015. To the extent it is not  
16 duplicative of other studies, the report must study how other states  
17 have implemented involuntary chemical dependency treatment with  
18 respect to emergency and nonemergency detentions. The study must  
19 include, but not be limited to:

20 (a) Court processes for referral for involuntary chemical  
21 dependency treatment;

22 (b) Statutory lengths of stay;

23 (c) Types of professionals providing evaluation and referral for  
24 treatment;

25 (d) Required qualifications of professionals providing evaluation  
26 and referral for treatment;

27 (e) Number of beds per one thousand residents;

28 (f) Less restrictive alternatives to detention; and

29 (g) Integration of involuntary mental health and chemical  
30 dependency treatment processes.

31 (3) The Washington state institute for public policy shall update  
32 its analyses of Washington's integrated crisis response pilots

1 published in 2007, 2008, and 2011 using the institute's most recent  
2 cost benefit analysis methodology.

3 **Sec. 2.** RCW 71.24.025 and 2014 c 225 s 10 are each reenacted and  
4 amended to read as follows:

5 Unless the context clearly requires otherwise, the definitions in  
6 this section apply throughout this chapter.

7 (1) "Acutely mentally ill" means a condition which is limited to  
8 a short-term severe crisis episode of:

9 (a) A mental disorder as defined in RCW 71.05.020 or, in the case  
10 of a child, as defined in RCW 71.34.020;

11 (b) Being gravely disabled as defined in RCW 71.05.020 or, in the  
12 case of a child, a gravely disabled minor as defined in RCW  
13 71.34.020; or

14 (c) Presenting a likelihood of serious harm as defined in RCW  
15 71.05.020 or, in the case of a child, as defined in RCW 71.34.020.

16 (2) "Available resources" means funds appropriated for the  
17 purpose of providing community mental health programs, federal funds,  
18 except those provided according to Title XIX of the Social Security  
19 Act, and state funds appropriated under this chapter or chapter 71.05  
20 RCW by the legislature during any biennium for the purpose of  
21 providing residential services, resource management services,  
22 community support services, and other mental health services. This  
23 does not include funds appropriated for the purpose of operating and  
24 administering the state psychiatric hospitals.

25 (3) "Behavioral health organization" means any county authority  
26 or group of county authorities or other entity recognized by the  
27 secretary in contract in a defined region.

28 (4) "Behavioral health services" means mental health services as  
29 described in this chapter and chapter 71.36 RCW and (~~chemical~~  
30 ~~dependency~~) substance use disorder treatment services as described  
31 in this chapter and chapter 70.96A RCW.

32 (5) "Child" means a person under the age of eighteen years.

33 (6) "Chronically mentally ill adult" or "adult who is chronically  
34 mentally ill" means an adult who has a mental disorder and meets at  
35 least one of the following criteria:

36 (a) Has undergone two or more episodes of hospital care for a  
37 mental disorder within the preceding two years; or

1 (b) Has experienced a continuous psychiatric hospitalization or  
2 residential treatment exceeding six months' duration within the  
3 preceding year; or

4 (c) Has been unable to engage in any substantial gainful activity  
5 by reason of any mental disorder which has lasted for a continuous  
6 period of not less than twelve months. "Substantial gainful activity"  
7 shall be defined by the department by rule consistent with Public Law  
8 92-603, as amended.

9 (7) "Clubhouse" means a community-based program that provides  
10 rehabilitation services and is certified by the department of social  
11 and health services.

12 ~~(8) ("Community mental health program" means all mental health~~  
13 ~~services, activities, or programs using available resources.~~

14 ~~(9))~~ "Community mental health service delivery system" means  
15 public, private, or tribal agencies that provide services  
16 specifically to persons with mental disorders as defined under RCW  
17 71.05.020 and receive funding from public sources.

18 ~~((10))~~ (9) "Community support services" means services  
19 authorized, planned, and coordinated through resource management  
20 services including, at a minimum, assessment, diagnosis, emergency  
21 crisis intervention available twenty-four hours, seven days a week,  
22 prescreening determinations for persons who are mentally ill being  
23 considered for placement in nursing homes as required by federal law,  
24 screening for patients being considered for admission to residential  
25 services, diagnosis and treatment for children who are acutely  
26 mentally ill or severely emotionally disturbed discovered under  
27 screening through the federal Title XIX early and periodic screening,  
28 diagnosis, and treatment program, investigation, legal, and other  
29 nonresidential services under chapter 71.05 RCW, case management  
30 services, psychiatric treatment including medication supervision,  
31 counseling, psychotherapy, assuring transfer of relevant patient  
32 information between service providers, recovery services, and other  
33 services determined by behavioral health organizations.

34 ~~((11))~~ (10) "Consensus-based" means a program or practice that  
35 has general support among treatment providers and experts, based on  
36 experience or professional literature, and may have anecdotal or case  
37 study support, or that is agreed but not possible to perform studies  
38 with random assignment and controlled groups.

39 ~~((12))~~ (11) "County authority" means the board of county  
40 commissioners, county council, or county executive having authority

1 to establish a community mental health program, or two or more of the  
2 county authorities specified in this subsection which have entered  
3 into an agreement to provide a community mental health program.

4 ~~((13))~~ (12) "Department" means the department of social and  
5 health services.

6 ~~((14))~~ (13) "Designated mental health professional" means a  
7 mental health professional designated by the county or other  
8 authority authorized in rule to perform the duties specified in this  
9 chapter.

10 ~~((15))~~ (14) "Emerging best practice" or "promising practice"  
11 means a program or practice that, based on statistical analyses or a  
12 well established theory of change, shows potential for meeting the  
13 evidence-based or research-based criteria, which may include the use  
14 of a program that is evidence-based for outcomes other than those  
15 listed in subsection ~~((16))~~ (15) of this section.

16 ~~((16))~~ (15) "Evidence-based" means a program or practice that  
17 has been tested in heterogeneous or intended populations with  
18 multiple randomized, or statistically controlled evaluations, or  
19 both; or one large multiple site randomized, or statistically  
20 controlled evaluation, or both, where the weight of the evidence from  
21 a systemic review demonstrates sustained improvements in at least one  
22 outcome. "Evidence-based" also means a program or practice that can  
23 be implemented with a set of procedures to allow successful  
24 replication in Washington and, when possible, is determined to be  
25 cost-beneficial.

26 ~~((17))~~ (16) "Licensed service provider" means an entity  
27 licensed according to this chapter or chapter 71.05 or 70.96A RCW or  
28 an entity deemed to meet state minimum standards as a result of  
29 accreditation by a recognized behavioral health accrediting body  
30 recognized and having a current agreement with the department, or  
31 tribal attestation that meets state minimum standards, or persons  
32 licensed under chapter 18.57, 18.71, 18.83, or 18.79 RCW, as it  
33 applies to registered nurses and advanced registered nurse  
34 practitioners.

35 ~~((18))~~ (17) "Long-term inpatient care" means inpatient services  
36 for persons committed for, or voluntarily receiving intensive  
37 treatment for, periods of ninety days or greater under chapter 71.05  
38 RCW. "Long-term inpatient care" as used in this chapter does not  
39 include: (a) Services for individuals committed under chapter 71.05  
40 RCW who are receiving services pursuant to a conditional release or a

1 court-ordered less restrictive alternative to detention; or (b)  
2 services for individuals voluntarily receiving less restrictive  
3 alternative treatment on the grounds of the state hospital.

4 ~~((19))~~ (18) "Mental health services" means all services  
5 provided by behavioral health organizations and other services  
6 provided by the state for persons who are mentally ill.

7 ~~((20))~~ (19) "Mentally ill persons," "persons who are mentally  
8 ill," and "the mentally ill" mean persons and conditions defined in  
9 subsections (1), (6), (27), and (28)~~((, and (29))~~ of this section.

10 ~~((21))~~ (20) "Recovery" means the process in which people are  
11 able to live, work, learn, and participate fully in their  
12 communities.

13 ~~((22))~~ (21) "Registration records" include all the records of  
14 the department, behavioral health organizations, treatment  
15 facilities, and other persons providing services to the department,  
16 county departments, or facilities which identify persons who are  
17 receiving or who at any time have received services for mental  
18 illness.

19 ~~((23))~~ (22) "Research-based" means a program or practice that  
20 has been tested with a single randomized, or statistically controlled  
21 evaluation, or both, demonstrating sustained desirable outcomes; or  
22 where the weight of the evidence from a systemic review supports  
23 sustained outcomes as described in subsection ~~((16))~~ (15) of this  
24 section but does not meet the full criteria for evidence-based.

25 ~~((24))~~ (23) "Residential services" means a complete range of  
26 residences and supports authorized by resource management services  
27 and which may involve a facility, a distinct part thereof, or  
28 services which support community living, for persons who are acutely  
29 mentally ill, adults who are chronically mentally ill, children who  
30 are severely emotionally disturbed, or adults who are seriously  
31 disturbed and determined by the behavioral health organization to be  
32 at risk of becoming acutely or chronically mentally ill. The services  
33 shall include at least evaluation and treatment services as defined  
34 in chapter 71.05 RCW, acute crisis respite care, long-term adaptive  
35 and rehabilitative care, and supervised and supported living  
36 services, and shall also include any residential services developed  
37 to service persons who are mentally ill in nursing homes, assisted  
38 living facilities, and adult family homes, and may include outpatient  
39 services provided as an element in a package of services in a  
40 supported housing model. Residential services for children in out-of-

1 home placements related to their mental disorder shall not include  
2 the costs of food and shelter, except for children's long-term  
3 residential facilities existing prior to January 1, 1991.

4 ~~((+25))~~ (24) "Resilience" means the personal and community  
5 qualities that enable individuals to rebound from adversity, trauma,  
6 tragedy, threats, or other stresses, and to live productive lives.

7 ~~((+26))~~ (25) "Resource management services" mean the planning,  
8 coordination, and authorization of residential services and community  
9 support services administered pursuant to an individual service plan  
10 for: (a) Adults and children who are acutely mentally ill; (b) adults  
11 who are chronically mentally ill; (c) children who are severely  
12 emotionally disturbed; or (d) adults who are seriously disturbed and  
13 determined solely by a behavioral health organization to be at risk  
14 of becoming acutely or chronically mentally ill. Such planning,  
15 coordination, and authorization shall include mental health screening  
16 for children eligible under the federal Title XIX early and periodic  
17 screening, diagnosis, and treatment program. Resource management  
18 services include seven day a week, twenty-four hour a day  
19 availability of information regarding enrollment of adults and  
20 children who are mentally ill in services and their individual  
21 service plan to designated mental health professionals, evaluation  
22 and treatment facilities, and others as determined by the behavioral  
23 health organization.

24 ~~((+27))~~ (26) "Secretary" means the secretary of social and  
25 health services.

26 ~~((+28))~~ (27) "Seriously disturbed person" means a person who:

27 (a) Is gravely disabled or presents a likelihood of serious harm  
28 to himself or herself or others, or to the property of others, as a  
29 result of a mental disorder as defined in chapter 71.05 RCW;

30 (b) Has been on conditional release status, or under a less  
31 restrictive alternative order, at some time during the preceding two  
32 years from an evaluation and treatment facility or a state mental  
33 health hospital;

34 (c) Has a mental disorder which causes major impairment in  
35 several areas of daily living;

36 (d) Exhibits suicidal preoccupation or attempts; or

37 (e) Is a child diagnosed by a mental health professional, as  
38 defined in chapter 71.34 RCW, as experiencing a mental disorder which  
39 is clearly interfering with the child's functioning in family or

1 school or with peers or is clearly interfering with the child's  
2 personality development and learning.

3 ~~((29))~~ (28) "Severely emotionally disturbed child" or "child  
4 who is severely emotionally disturbed" means a child who has been  
5 determined by the behavioral health organization to be experiencing a  
6 mental disorder as defined in chapter 71.34 RCW, including those  
7 mental disorders that result in a behavioral or conduct disorder,  
8 that is clearly interfering with the child's functioning in family or  
9 school or with peers and who meets at least one of the following  
10 criteria:

11 (a) Has undergone inpatient treatment or placement outside of the  
12 home related to a mental disorder within the last two years;

13 (b) Has undergone involuntary treatment under chapter 71.34 RCW  
14 within the last two years;

15 (c) Is currently served by at least one of the following child-  
16 serving systems: Juvenile justice, child-protection/welfare, special  
17 education, or developmental disabilities;

18 (d) Is at risk of escalating maladjustment due to:

19 (i) Chronic family dysfunction involving a caretaker who is  
20 mentally ill or inadequate;

21 (ii) Changes in custodial adult;

22 (iii) Going to, residing in, or returning from any placement  
23 outside of the home, for example, psychiatric hospital, short-term  
24 inpatient, residential treatment, group or foster home, or a  
25 correctional facility;

26 (iv) Subject to repeated physical abuse or neglect;

27 (v) Drug or alcohol abuse; or

28 (vi) Homelessness.

29 ~~((30))~~ (29) "State minimum standards" means minimum  
30 requirements established by rules adopted by the secretary and  
31 necessary to implement this chapter for: (a) Delivery of mental  
32 health services; (b) licensed service providers for the provision of  
33 mental health services; (c) residential services; and (d) community  
34 support services and resource management services.

35 ~~((31))~~ (30) Mental health "treatment records" include  
36 registration and all other records concerning persons who are  
37 receiving or who at any time have received services for mental  
38 illness, which are maintained by the department, by behavioral health  
39 organizations and their staffs, and by treatment facilities.  
40 Treatment records do not include notes or records maintained for

1 personal use by a person providing treatment services for the  
2 department, behavioral health organizations, or a treatment facility  
3 if the notes or records are not available to others.

4 ~~((32))~~ (31) "Tribal authority," for the purposes of this  
5 section and RCW 71.24.300 only, means: The federally recognized  
6 Indian tribes and the major Indian organizations recognized by the  
7 secretary insofar as these organizations do not have a financial  
8 relationship with any behavioral health organization that would  
9 present a conflict of interest.

10 (32) "Alcoholism" means a disease, characterized by a dependency  
11 on alcoholic beverages, loss of control over the amount and  
12 circumstances of use, symptoms of tolerance, physiological or  
13 psychological withdrawal, or both, if use is reduced or discontinued,  
14 and impairment of health or disruption of social or economic  
15 functioning.

16 (33) "Approved substance use disorder treatment program" means a  
17 program for persons with a substance use disorder provided by a  
18 treatment program certified by the department of social and health  
19 services as meeting standards adopted under this chapter.

20 (34) "Behavioral health program" means all expenditures,  
21 services, activities, or programs, including reasonable  
22 administration and overhead, designed and conducted to prevent or  
23 treat chemical dependency and mental illness.

24 (35) "Substance use disorder" means a cluster of cognitive,  
25 behavioral, and physiological symptoms indicating that an individual  
26 continues using the substance despite significant substance-related  
27 problems. The diagnosis of a substance use disorder is based on a  
28 pathological pattern of behaviors related to the use of the  
29 substances.

30 (36) "Designated chemical dependency specialist" means a person  
31 designated by the behavioral health organization or by the county  
32 alcoholism and other drug addiction program coordinator designated by  
33 the behavioral health organization to perform the commitment duties  
34 described in RCW 70.96A.140 and qualified to do so by meeting  
35 standards adopted by the department.

36 (37) "Drug addiction" means a disease characterized by a  
37 dependency on psychoactive chemicals, loss of control over the amount  
38 and circumstances of use, symptoms of tolerance, physiological or  
39 psychological withdrawal, or both, if use is reduced or discontinued,

1 and impairment of health or disruption of social or economic  
2 functioning.

3 (38) "Early adopter" means a regional service area for which all  
4 of the county authorities have requested that the department and the  
5 health care authority jointly purchase medical and behavioral health  
6 services through a managed care health system as defined under RCW  
7 71.24.380(6).

8 (39) "Licensed physician" means a person licensed to practice  
9 medicine or osteopathic medicine and surgery in the state of  
10 Washington.

11 **Sec. 3.** RCW 71.24.035 and 2014 c 225 s 11 are each amended to  
12 read as follows:

13 (1) The department is designated as the state (~~mental~~)  
14 behavioral health authority which includes recognition as the single  
15 state authority for substance use disorders and state mental health  
16 authority.

17 (2) The secretary shall provide for public, client, tribal, and  
18 licensed service provider participation in developing the state  
19 (~~mental~~) behavioral health program, developing contracts with  
20 behavioral health organizations, and any waiver request to the  
21 federal government under medicaid.

22 (3) The secretary shall provide for participation in developing  
23 the state (~~mental~~) behavioral health program for children and other  
24 underserved populations, by including representatives on any  
25 committee established to provide oversight to the state (~~mental~~)  
26 behavioral health program.

27 (4) The secretary shall be designated as the behavioral health  
28 organization if the behavioral health organization fails to meet  
29 state minimum standards or refuses to exercise responsibilities under  
30 its contract or RCW 71.24.045, until such time as a new behavioral  
31 health organization is designated.

32 (5) The secretary shall:

33 (a) Develop a biennial state (~~mental~~) behavioral health program  
34 that incorporates regional biennial needs assessments and regional  
35 mental health service plans and state services for adults and  
36 children with mental (~~illness~~) disorders or substance use disorders  
37 or both;

38 (b) Assure that any behavioral health organization or county  
39 community (~~mental~~) behavioral health program provides medically

1 necessary services to medicaid recipients consistent with the state's  
2 medicaid state plan or federal waiver authorities, and nonmedicaid  
3 services consistent with priorities established by the department;

4 (c) Develop and adopt rules establishing state minimum standards  
5 for the delivery of (~~mental~~) behavioral health services pursuant to  
6 RCW 71.24.037 including, but not limited to:

7 (i) Licensed service providers. These rules shall permit a  
8 county-operated (~~mental~~) behavioral health program to be licensed  
9 as a service provider subject to compliance with applicable statutes  
10 and rules. The secretary shall provide for deeming of compliance with  
11 state minimum standards for those entities accredited by recognized  
12 behavioral health accrediting bodies recognized and having a current  
13 agreement with the department;

14 (ii) Inpatient services, evaluation and treatment services and  
15 facilities under chapter 71.05 RCW, resource management services, and  
16 community support services;

17 (d) Assure that the special needs of persons who are minorities,  
18 elderly, disabled, children, low-income, and parents who are  
19 respondents in dependency cases are met within the priorities  
20 established in this section;

21 (e) Establish a standard contract or contracts, consistent with  
22 state minimum standards which shall be used in contracting with  
23 behavioral health organizations. The standard contract shall include  
24 a maximum fund balance, which shall be consistent with that required  
25 by federal regulations or waiver stipulations;

26 (f) Make contracts necessary or incidental to the performance of  
27 its duties and the execution of its powers, including managed care  
28 contracts for behavioral health services, contracts entered into  
29 under RCW 74.09.522, and contracts with public and private agencies,  
30 organizations, and individuals to pay them for behavioral health  
31 services;

32 (g) Establish, to the extent possible, a standardized auditing  
33 procedure which is designed to assure compliance with contractual  
34 agreements authorized by this chapter and minimizes paperwork  
35 requirements of behavioral health organizations and licensed service  
36 providers. The audit procedure shall focus on the outcomes of service  
37 as provided in RCW 43.20A.895, 70.320.020, and 71.36.025;

38 (~~g~~) (h) Develop and maintain an information system to be used  
39 by the state and behavioral health organizations that includes a  
40 tracking method which allows the department and behavioral health

1 organizations to identify ~~((mental))~~ behavioral health clients'  
2 participation in any ~~((mental))~~ behavioral health service or public  
3 program on an immediate basis. The information system shall not  
4 include individual patient's case history files. Confidentiality of  
5 client information and records shall be maintained as provided in  
6 this chapter and chapter 70.02 RCW;

7 ~~((h))~~ (i) License service providers who meet state minimum  
8 standards;

9 ~~((i))~~ (j) Periodically monitor the compliance of behavioral  
10 health organizations and their network of licensed service providers

13 reasonable times and in a reasonable manner;

14 ~~((j))~~ (k) Fix fees to be paid by evaluation and treatment  
15 centers to the secretary for the required inspections;

37 client outcomes established in RCW 43.20A.895, 70.320.020, and  
38 71.36.025, integration of behavioral health and medical services at  
39 the clinical level, and improved care coordination for individuals  
40 with complex care needs.

1 (7) Each behavioral health organization and licensed service  
2 provider shall file with the secretary, on request, such data,  
3 statistics, schedules, and information as the secretary reasonably  
4 requires. A behavioral health organization or licensed service  
5 provider which, without good cause, fails to furnish any data,  
6 statistics, schedules, or information as requested, or files  
7 fraudulent reports thereof, may be subject to the behavioral health  
8 organization contractual remedies in RCW 43.20A.894 or may have its  
9 service provider certification or license revoked or suspended.

10 (8) The secretary may suspend, revoke, limit, or restrict a  
11 certification or license, or refuse to grant a certification or  
12 license for failure to conform to: (a) The law; (b) applicable rules  
13 and regulations; (c) applicable standards; or (d) state minimum

15 (9) The superior court may restrain any behavioral health  
16 organization or service provider from operating without a contract,  
17 certification, or a license or any other violation of this section.  
18 The court may also review, pursuant to procedures contained in  
19 chapter 34.05 RCW, any denial, suspension, limitation, restriction,  
20 or revocation of certification or license, and grant other relief  
21 required to enforce the provisions of this chapter.

22 (10) Upon petition by the secretary, and after hearing held upon  
23 reasonable notice to the facility, the superior court may issue a  
24 warrant to an officer or employee of the secretary authorizing him or  
25 her to enter at reasonable times, and examine the records, books, and

10 revoked or denied by the department for one year;

11 (ii) Where there has been one prior offense within seven years,  
12 be revoked or denied by the department for nine hundred days; or
