1 Strike everything after the enacting clause and insert the  
2 following:

3 "Sec. 1. RCW 74.08A.250 and 2013 c 39 s 27 are each amended to  
4 read as follows:

5 Unless the context clearly requires otherwise, as used in this  
6 chapter, "work activity" means:

7 (1) Unsubsidized paid employment in the private or public sector;

8 (2) Subsidized paid employment in the private or public sector,  
9 including employment through the state or federal work-study program  
10 for a period not to exceed twenty-four months;

11 (3) Work experience, including:

12 (a) An internship or practicum, that is paid or unpaid and is  
13 required to complete a course of vocational training or to obtain a  
14 license or certificate in a high-demand occupation, as determined by  
15 the employment security department. No internship or practicum shall  
16 exceed twelve months; or

17 (b) Work associated with the refurbishing of publicly assisted  
18 housing, if sufficient paid employment is not available;

19 (4) On-the-job training;

20 (5) Job search and job readiness assistance;

21 (6) Community service programs, including a recipient's voluntary  
22 service at a child care or preschool facility licensed under chapter  
23 43.215 RCW or an elementary school in which his or her child is  
24 enrolled;

25 (7) Vocational educational training, not to exceed (~~twelve~~)  
26 twenty-four months with respect to any individual. For the purposes  
27 of this section and RCW 74.08A.341, vocational educational training  
28 that exceeds twelve months is limited to vocational educational  
29 training for high-demand/high-wage jobs which means (a) information  
30 technology, health care, or other professional-technical programs  
31 that can be completed in twenty-four months or less; or (b)

1 certificate/degree completion, not to exceed a baccalaureate degree,  
2 in a high-wage/high-demand field on an exception basis. The high-  
3 wage/high-demand criteria for this option is based on median income  
4 and high-demand occupations within the local labor market as  
5 determined by the employment security department;

6 (8) Job skills training directly related to employment;

7 (9) Education directly related to employment, in the case of a  
8 recipient who has not received a high school diploma or a high school  
9 equivalency certificate as provided in RCW 28B.50.536;

10 (10) Satisfactory attendance at secondary school or in a course  
11 of study leading to a high school equivalency certificate as provided  
12 in RCW 28B.50.536, in the case of a recipient who has not completed  
13 secondary school or received such a certificate;

14 (11) The provision of child care services to an individual who is  
15 participating in a community service program;

16 (12) Internships, that shall be paid or unpaid work experience  
17 performed by an intern in a business, industry, or government or  
18 nongovernmental agency setting;

19 (13) Practicums, which include any educational program in which a  
20 student is working under the close supervision of a professional in  
21 an agency, clinic, or other professional practice setting for  
22 purposes of advancing their skills and knowledge;

23 (14) Services required by the recipient under RCW 74.08.025(3)  
24 and 74.08A.010(4) to become employable;

25 (15) Financial literacy activities designed to be effective in  
26 assisting a recipient in becoming self-sufficient and financially  
27 stable; and

28 (16) Parent education services or programs that support  
29 development of appropriate parenting skills, life skills, and  
30 employment-related competencies.

31 **Sec. 2.** RCW 74.08A.341 and 2012 c 217 s 1 are each amended to  
32 read as follows:

33 The department of social and health services shall operate the  
34 Washington WorkFirst program authorized under RCW 74.08A.210 through  
35 74.08A.330, 43.330.145, 43.215.545, and 74.25.040, and chapter 74.12  
36 RCW within the following constraints:

37 (1) The program shall be operated within amounts appropriated by  
38 the legislature and consistent with policy established by the

1 legislature to achieve self-sufficiency through work and the  
2 following additional outcomes:

3 (a) Recipients' economic status is improving through wage  
4 progression, job retention, and educational advancement;

5 (b) Recipients' status regarding housing stability, medical and  
6 behavioral health, and job readiness is improving;

7 (c) The well-being of children whose caretaker is receiving  
8 benefits on their behalf is improving with respect to child welfare  
9 and educational achievement.

10 (2)(a) The department shall create a budget structure that allows  
11 for more transparent tracking of program spending. The budget  
12 structure shall outline spending for the following: Temporary  
13 assistance for needy family grants, working connections child care,  
14 WorkFirst activities and administration of the program.

15 (b) Each biennium, the department shall establish a biennial  
16 spending plan, using the budget structure created in (a) of this  
17 subsection, for this program and submit the plan to the legislative  
18 fiscal committees and the legislative-executive WorkFirst oversight  
19 task force no later than July 1st of every odd-numbered year,  
20 beginning on July 1, 2013. The department shall update the  
21 legislative fiscal committees and the task force on the spending plan  
22 if modifications are made to the plan previously submitted to the  
23 legislature and the task force for that biennium.

24 (c) The department also shall provide expenditure reports to the  
25 fiscal committees of the legislature and the legislative-executive  
26 WorkFirst oversight task force beginning September 1, 2012, and on a  
27 quarterly basis thereafter. If the department determines, based upon  
28 quarterly expenditure reports, that expenditures will exceed funding  
29 at the end of the fiscal year, the department shall take those  
30 actions necessary to ensure that services provided under this chapter  
31 are available only to the extent of and consistent with  
32 appropriations in the operating budget and policy established by the  
33 legislature following notification provided in (b) of this  
34 subsection.

35 (3) No more than fifteen percent of the temporary assistance for  
36 needy families block grant, the federal child care funds, and  
37 qualifying state expenditures may be spent for administrative  
38 purposes. For purposes of this subsection, "administrative purposes"  
39 does not include expenditures for information technology and

1 computerization needed for tracking and monitoring required by P.L.  
2 104-193.

3 (4) The department shall expend funds appropriated for work  
4 activities, as defined in RCW 74.08A.250, or for other services  
5 provided to WorkFirst recipients, as authorized under RCW 74.08A.290.  
6 The vocational education training work activity, as defined in RCW  
7 74.08A.250, is subject to the availability of amounts appropriated  
8 for this purpose.

9 NEW SECTION. Sec. 3. A new section is added to chapter 43.131  
10 RCW to read as follows:

11 The definition of "work activity" related to the length of  
12 vocational educational training a WorkFirst participant may receive  
13 as established under section 1 of this act shall be terminated on  
14 August 1, 2021, as provided in section 4 of this act.

15 NEW SECTION. Sec. 4. A new section is added to chapter 43.131  
16 RCW to read as follows:

17 The following acts or parts of acts, as now existing or hereafter  
18 amended, are each repealed, effective August 1, 2022:

19 Section 1, chapter ..., Laws of 2016 (section 1 of this act)."

20 On page 1, line 2 of the title, after "program;" strike the  
21 remainder of the title and insert "amending RCW 74.08A.250 and  
22 74.08A.341; adding new sections to chapter 43.131 RCW; and providing  
23 an effective date."

EFFECT: Adds the requirement that the Joint Legislative Audit and  
Review Committee conduct a sunset review by August 1, 2021, on the  
time limit extension from 12 months to 24 months for purposes of  
vocational education training for WorkFirst participants. The new  
language is repealed in 2022. Chapter law reference is changed from  
2015 to 2016.

Vocational training exceeding twelve months is limited to  
training for high-demand/high-wage jobs, which is defined.
