8 NEW SECTION. **Sec. 2.** A new section is added to chapter 41.80  
9 RCW to read as follows:

10 The employer shall submit a digital copy of their collective  
11 bargaining agreement to the commission within thirty days of the  
12 effective date of the collective bargaining agreement.

13 NEW SECTION. **Sec. 3.** A new section is added to chapter 41.76  
14 RCW to read as follows:

15 The employer shall submit a digital copy of their collective  
16 bargaining agreement to the commission within thirty days of the  
17 effective date of the collective bargaining agreement.

18 NEW SECTION. **Sec. 4.** A new section is added to chapter 41.59  
19 RCW to read as follows:

20 The employer shall submit a digital copy of their collective  
21 bargaining agreement to the commission within thirty days of the  
22 effective date of the collective bargaining agreement.

23 NEW SECTION. **Sec. 5.** A new section is added to chapter 49.39  
24 RCW to read as follows:

25 The employer shall submit a digital copy of their collective  
26 bargaining agreement to the commission within thirty days of the  
27 effective date of the collective bargaining agreement.

1        NEW SECTION.    **Sec. 6.**    A new section is added to chapter 28B.52  
2    RCW to read as follows:

3        Employers of academic employees under this chapter shall submit a  
4    digital copy of their collective bargaining agreement to the  
5    commission within thirty days of the effective date of the collective  
6    bargaining agreement.

7        NEW SECTION.    **Sec. 7.**    A new section is added to chapter 47.64  
8    RCW to read as follows:

9        The employer shall submit a digital copy of their collective  
10   bargaining agreement to the commission within thirty days of the  
11   effective date of the collective bargaining agreement.

12       NEW SECTION.    **Sec. 8.**    A new section is added to chapter 49.66  
13   RCW to read as follows:

14       The employer shall submit a digital copy of their collective  
15   bargaining agreement to the department within thirty days of the  
16   effective date of the collective bargaining agreement. The department  
17   shall maintain a web site that allows the public to view and download  
18   the collective bargaining agreements submitted by employers pursuant  
19   to this section. The collective bargaining agreements shall be  
20   available in a uniform digital format. Expired collective bargaining  
21   agreements shall be available on the web site for up to ten years  
22   following expiration.

23       NEW SECTION.    **Sec. 9.**    A new section is added to chapter 41.58  
24   RCW to read as follows:

25       The commission shall maintain a web site that allows the public  
26   to view and download the collective bargaining agreements submitted  
27   by employers pursuant to sections 1 through 8 of this act. The  
28   collective bargaining agreements shall be available in a uniform  
29   digital format. Expired collective bargaining agreements shall be  
30   available on the web site for up to ten years following expiration."

EFFECT: The public employers, rather than the labor organizations, must submit digital copies of the collective bargaining agreements.
