**Background**: Current law authorizes the Washington State Transportation Commission (WSTC) to name or rename state transportation facilities. The process to name or rename a facility can be initiated by the Washington State Department of Transportation (WSDOT), state and local governmental entities, citizen organizations, or by an individual person. In order for WSTC to consider the proposal, the requesting entity must provide sufficient evidence indicating community support and acceptance of the proposal. This evidence can include a letter of support from the state or federal legislator representing the area encompassing the facility to be renamed. Other evidence that would provide proof of community support includes a resolution passed by other elected bodies in the impacted area, WSDOT support, and supportive action from a local organization such as the chamber of commerce. Upon passage of a joint memorial requesting the naming of a transportation facility, the WSTC holds a public hearing prior to taking action. After WSTC takes final action, WSDOT designs and installs the appropriate signs.

Stewart Memorial Highway to honor his service in the 29th U.S. Colored Infantry Regiment during the Civil War and his role as a farmer and pioneer of the City of Snohomish. Copies of the memorial must be forwarded to the Secretary of Transportation, WSTC, and WSDOT.
