1 AN ACT Relating to establishing wage liens; and adding a new 2 chapter to Title 60 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 <u>NEW SECTION.</u> **Sec. 1.** This act may be known and cited as the 5 Washington wage recovery act.

6 <u>NEW SECTION.</u> Sec. 2. The definitions in this section apply 7 throughout this chapter unless the context clearly requires 8 otherwise.

9

(1) "Department" means the department of labor and industries.

10

(2) "Director" means the director of labor and industries.

11

(3) "Employ" includes permit to work.

12 (4) "Employee" includes any individual currently or formerly13 employed by an employer.

14 (5) "Employer" includes any individual, partnership, association, 15 corporation, business trust, or any person or group of persons acting 16 directly or indirectly in the interest of an employer in relation to 17 an employee.

18 (6) "Maintain" includes to maintain, clean, manage, improve,19 protect, repair, monitor, or restore real property at the instance of

1 the owner or tenant or of any person acting by the owner's or 2 tenant's authority.

3 (7) "Wage claim" means a claim for any unpaid wages owed to the 4 claimant as an employee of an employer, as well as any other 5 compensation, interest, statutory damages, liquidated damages, or 6 statutory penalties that may be owed for violation of a state or 7 federal wage law, including but not limited to chapters 39.12, 49.12, 8 49.46, 49.48, and 49.52 RCW, and the fair labor standards act, 29 9 U.S.C. Sec. 201 et seq.

10 <u>NEW SECTION.</u> Sec. 3. (1)(a) A person has a wage lien for wage 11 claims on:

(i) Any property in the state of Washington that is owned or issubsequently acquired by the person's employer;

(ii) Any property in the state of Washington that is owned or is subsequently acquired by an officer, vice principal, or agent of the employer who is personally liable for a wage claim under RCW 49.52.070; and

18 (iii) Any real property in the state of Washington that the 19 person has maintained, for all wage claims for maintenance of that 20 property.

(b) A person does not have a wage lien under this chapter on any property that is or would be subject to a lien by that person under chapter 60.04 RCW.

(2) A wage lien is not effective against:

(a) With respect to goods as defined in RCW 62A.9A-102, a buyer
in the ordinary course of business, as such term is defined in RCW
62A.1-201(a)(9); or

(b) Third persons who, prior to the filing of the wage lien notice required under this chapter, acquired title in good faith, for value and without actual notice of the wage lien, to property other than goods.

32 (3) Chapter 62A.9A RCW of the uniform commercial code does not33 apply to a wage lien on personal property under this chapter.

(4) A person, other than a consumer as defined in RCW 62A.1-201, who controls or possesses amounts payable to the employer that are not health-care-insurance receivables as defined in chapter 62A.9A RCW, and that are properly encumbered by a wage lien upon an account receivable, is not obligated to pay a lien claimant amounts to which the wage lien has attached until that person receives written notice

1 of such lien, nor is the person liable to the lien claimant for any 2 amounts paid out prior to receipt of notice of the wage lien. The notice required must state that the amount due or to become due has 3 been assigned and that payment is to be made to the lien claimant, 4 and it must contain the information described in section 4 of this 5 6 act. After receipt of the notice, the person responsible for payment 7 of such amounts may discharge its obligation by paying the lien claimant and may not discharge the obligation by paying the employer. 8 9 If requested by the person responsible for payment of such amounts, the lien claimant must, within a reasonable time, furnish reasonable 10 11 proof that the wage lien continues to exist, and unless such proof is furnished, that person has no obligation to pay the lien claimant and 12 may discharge its obligation by paying the employer. A written, 13 14 signed statement from the employee that the wages that form the basis for the wage lien have not been paid in the time after filing the 15 16 wage lien constitutes "reasonable proof" for this purpose. Failure to 17 furnish any notice as provided in this section does not affect the status of the wage lien established under this chapter in regard to 18 the relationship with other creditors. 19

(5) This chapter does not affect the title of the state or other public ownership, nor does any lien attach to the fee simple title of the state or other public ownership.

23 <u>NEW SECTION.</u> **Sec. 4.** (1) To establish a wage lien on real 24 property, the lien claimant must:

(a) File for recording a notice of claim of wage lien in thecounty where the property is located that includes:

(i) The name, telephone number, and address of the lien claimant and, if the wage lien has been assigned, the name of the person who assigned the lien;

(ii) The name of the employer;

(iii) The street address, legal description, or other description reasonably calculated to identify, for a person familiar with the area, the location of the real property to be charged with the wage lien;

35 (iv) The amount for which the wage lien is claimed;

36 (v) The signature of the lien claimant or of a person authorized 37 to act on his or her behalf; and

38 (vi) An acknowledgment and certification as set forth in 39 subsection (3) of this section; 1

(b) Pay a filing fee established by the county auditor; and

2 (c) Mail a copy of the notice filed under this subsection (1) to the employer's registered agent, the employer's registered business 3 address, or the address where the employer resides, and to the 4 property owner if the employer is not the property owner, by 5 6 certified mail with return receipt requested.

7 (2) To establish a wage lien on personal property, the lien 8 claimant must:

(a) File for recording a notice of claim of wage lien with the 9 department of licensing that includes: 10

11 (i) The name, telephone number, and address of the lien claimant and, if the wage lien has been assigned, the name of the person who 12 13 assigned the lien;

14 (ii) The name of the employer;

(iii) A description of the personal property subject to the wage 15 lien or a statement that the wage lien covers all personal property; 16 17

(iv) The principal amount for which the wage lien is claimed;

(v) The signature of the lien claimant or of a person authorized 18 to act on his or her behalf; and 19

(vi) An acknowledgment and certification as set forth in 20 21 subsection (3) of this section;

(b) Pay a filing fee established by the department of licensing; 22 23 and

24 (c) Mail a copy of the notice filed under this subsection (2) to the employer's registered agent, the employer's registered business 25 26 address, or the address where the employer resides, by certified mail 27 with return receipt requested.

(3) A notice of claim of wage lien, acknowledgment, and 28 29 certificate that is substantially in the following form is sufficient to satisfy subsections (1)(a) and (2)(a) of this section: 30

4 (4)(a) For a notice of claim of wage lien on real property filed 5 under this section, the county auditor shall record the notice in the 6 same manner as deeds and other instruments of title are recorded 7 under chapter 65.08 RCW. Notices of claim of wage lien for registered 8 land need not be recorded in the Torrens register.

9 (b) For a notice of claim of wage lien on personal property filed 10 under this section, the department of licensing shall record the 11 notice.

12 (5) The notice of claim of wage lien may be filed at any time 13 prior to the expiration of the statute of limitations for an action 14 to recover the wages that are the subject of the wage lien.

15 (6) Mistakes or errors in the claimed amount owed do not 16 invalidate the wage lien unless made with the intent to defraud.

(7) A wage lien under this chapter continues in all identifiableproceeds of the property subject to the wage lien.

19 <u>NEW SECTION.</u> Sec. 5. Any wage lien or right of wage lien 20 created by this chapter and the right of action to recover the wage 21 lien is assignable so as to vest in the assignee all rights and 22 remedies of the assignor, subject to all defenses thereto that might 23 be made.

24 <u>NEW SECTION.</u> Sec. 6. (1) An action to foreclose the wage lien 25 must be filed within one year of the date the wage lien was recorded.

(2) A wage lien may be foreclosed by an action in:

26

(a) The superior court in the county in which the real propertyis located;

(b) The district court in the county in which the personal property is located if the value of the claim does not exceed the jurisdictional limit of the court provided in RCW 3.66.020; or

32 (c) The superior court in the county in which the personal 33 property is located if the value of the claim exceeds the 34 jurisdictional limit of the district court provided in RCW 3.66.020. 1 (3) A foreclosure action or an action for a wage claim may be 2 brought by the employee individually, the department, the United 3 States department of labor, the office of the attorney general, or a 4 representative of the employee, including a collective bargaining 5 representative or class representative. Multiple wage claims against 6 the same employer may be joined in a single proceeding, but the court 7 may order separate trials or hearings.

employee pursues 8 (4)(a) Ιf the the wage claim in an administrative proceeding before the department, a final and binding 9 citation issued by the department establishes the amount owed for the 10 11 purpose of foreclosure under this chapter only if the department 12 brings the foreclosure action on behalf of the employee.

(b) If the employee obtains a judgment from a federal court, the judgment establishes the amount owed for the purposes of foreclosure under this chapter.

16 (5) In the judgment resulting from an action to foreclose on the 17 wage lien, the court may order the sale at sheriff's auction or the transfer to the lien claimant of title or possession of any property 18 subject to the wage lien. Whether or not the court makes such an 19 order as part of the judgment, a writ of sale may be issued for any 20 21 property subject to the wage lien for ten years after a judgment for a wage claim is issued. A wage lien based on an underlying judgment 22 continues in force for an additional ten-year period if the period of 23 execution for the underlying judgment is extended under RCW 6.17.020. 24

(6) A lien claimant who prevails in a foreclosure action isentitled to costs and reasonable attorneys' fees.

27 <u>NEW SECTION.</u> Sec. 7. (1) A wage lien is extinguished:

(a) If an action for the underlying wage claim is not broughtwithin one year of the filing of the wage lien;

30 (b) If the action for the underlying wage claim is dismissed with 31 prejudice and no appeal is filed within the applicable appeals 32 period. If an appeal is filed, the wage lien continues in force until 33 final judgment is rendered; or

34 (c) Upon payment and acceptance of payment for the employee's35 wage claim.

36 (2)(a) When the wage lien has been extinguished, the lien 37 claimant shall, within fifteen days, file a release of the wage lien 38 at the place where the wage lien was recorded and pay a filing fee 39 established by the agency where the notice is filed. If a lien

1 claimant fails to file a release of the wage lien, upon demand and fifteen days' notice by the employer or any affected party, mailed to 2 the lien claimant's address as indicated on the notice of the wage 3 lien by certified mail with return receipt requested, the employer or 4 affected party may petition the court for an order releasing the wage 5 6 lien. If the lien claimant acted unreasonably and in bad faith in 7 refusing to file a release of the wage lien, the employer or affected party shall be entitled to recover its attorneys' fees and costs 8 incurred in the action, and the court in its discretion may also 9 issue a fine not to exceed one thousand dollars. 10

(b) The release must include:

(i) the name, telephone number, address, and relationship to the wage lien of the person filing the notice;

14 (ii) The name, telephone number, and address of the lien 15 claimant;

16 (iii) The name of the employer;

17 (iv) A description of the property subject to the wage lien;

18 (v) The amount for which the wage lien was claimed;

19 (vi) The signature of the lien claimant, the lien claimant's 20 assignor, or a person authorized to act on the lien claimant's 21 behalf; and

(vii) A certified acknowledgment as set forth in subsection (4)of this section.

(3) The person filing the notice must mail a copy of the notice
to the person against whom the lien claim was made by first-class
mail within ten days of filing the notice.

(4) A release of wage lien substantially in the following form issufficient:

21	NEW SECTION. Sec. 8. (1) Except as provided in subsections (2)
22	and (3) of this section, a wage lien recorded under this chapter has
23	priority over all other debts, judgments, decrees, liens, or security
24	interests against the property subject to the wage lien, regardless
25	as to whether these debts, judgments, decrees, liens, or security
26	interests originated before or after the wage lien, and regardless of
27	whether these debts, judgments, decrees, liens, or mortgages were

27 whether these debts, judgments, decrees, liens, or mortgages were 28 perfected prior to the wage lien. A wage lien recorded under this 29 chapter has priority over a lien or security interest of a financial institution only as to the first ten thousand dollars of a wage claim
 covered under the wage lien.

3 (2) A statutory lien for wages owed, including but not limited to
4 liens under chapters 60.04, 60.11, 60.16, 60.24, 60.28, 60.34, and
5 60.76 RCW, ranks according to priority in time of filing.

6 (3)(a) A wage lien recorded under this chapter as to real 7 property does not have priority over a mortgage or deed of trust that 8 was recorded prior to the recording of the wage lien.

9 (b) A wage lien recorded under this chapter does not have 10 priority over a lien for taxes that the department of revenue is 11 authorized or required to collect and that originates before a lien 12 recorded under this chapter.

13 (c) A wage lien recorded under this chapter does not have 14 priority over liens or income withholding for child support 15 obligations.

16

(4) A wage lien is effective against the estate of the employer.

17 <u>NEW SECTION.</u> Sec. 9. A contract between an employer and 18 employee may not waive or require an employee to waive the right to a 19 wage lien under this chapter. A provision of a contract made in 20 violation of this section is void as against the public policy of 21 this state.

22 <u>NEW SECTION.</u> Sec. 10. The claim of wage lien, when filed as 23 required by this chapter, constitutes notice to the spouse or the 24 domestic partner of the person who appears on record to be the owner 25 of the property sought to be charged with the wage lien, and subjects 26 all the community interest of both spouses or both domestic partners 27 to the wage lien.

28 <u>NEW SECTION.</u> **Sec. 11.** This chapter is to be liberally construed 29 to provide security for all persons intended to be protected by its 30 provisions.

31 <u>NEW SECTION.</u> **Sec. 12.** Sections 1 through 11 of this act 32 constitute a new chapter in Title 60 RCW.
