1 AN ACT Relating to the definition of work activity for the
2 purposes of the WorkFirst program; amending RCW 74.08A.250 and
3 74.08A.341; and creating new sections.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 74.08A.250 and 2013 c 39 s 27 are each amended to
6 read as follows:

7 Unless the context clearly requires otherwise, as used in this
8 chapter, "work activity" means:

9 (1) Unsubsidized paid employment in the private or public sector;

10 (2) Subsidized paid employment in the private or public sector,
11 including employment through the state or federal work-study program
12 for a period not to exceed twenty-four months;

13 (3) Work experience, including:

14 (a) An internship or practicum, that is paid or unpaid and is
15 required to complete a course of vocational training or to obtain a
16 license or certificate in a high-demand occupation, as determined by
17 the employment security department. No internship or practicum shall
18 exceed twelve months; or

19 (b) Work associated with the refurbishing of publicly assisted
20 housing, if sufficient paid employment is not available;

21 (4) On-the-job training;

- 1 (5) Job search and job readiness assistance;
- 2 (6) Community service programs, including a recipient's voluntary
3 service at a child care or preschool facility licensed under chapter
4 43.215 RCW or an elementary school in which his or her child is
5 enrolled;
- 6 (7) Vocational educational training, not to exceed (~~twelve~~)
7 twenty-four months with respect to any individual;
- 8 (8) Job skills training directly related to employment;
- 9 (9) Education directly related to employment, in the case of a
10 recipient who has not received a high school diploma or a high school
11 equivalency certificate as provided in RCW 28B.50.536;
- 12 (10) Satisfactory attendance at secondary school or in a course
13 of study leading to a high school equivalency certificate as provided
14 in RCW 28B.50.536, in the case of a recipient who has not completed
15 secondary school or received such a certificate;
- 16 (11) The provision of child care services to an individual who is
17 participating in a community service program;
- 18 (12) Internships, that shall be paid or unpaid work experience
19 performed by an intern in a business, industry, or government or
20 nongovernmental agency setting;
- 21 (13) Practicums, which include any educational program in which a
22 student is working under the close supervision of a professional in
23 an agency, clinic, or other professional practice setting for
24 purposes of advancing their skills and knowledge;
- 25 (14) Services required by the recipient under RCW 74.08.025(3)
26 and 74.08A.010(4) to become employable;
- 27 (15) Financial literacy activities designed to be effective in
28 assisting a recipient in becoming self-sufficient and financially
29 stable; and
- 30 (16) Parent education services or programs that support
31 development of appropriate parenting skills, life skills, and
32 employment-related competencies.

33 **Sec. 2.** RCW 74.08A.341 and 2012 c 217 s 1 are each amended to
34 read as follows:

35 The department of social and health services shall operate the
36 Washington WorkFirst program authorized under RCW 74.08A.210 through
37 74.08A.330, 43.330.145, 43.215.545, and 74.25.040, and chapter 74.12
38 RCW within the following constraints:

1 (1) The program shall be operated within amounts appropriated by
2 the legislature and consistent with policy established by the
3 legislature to achieve self-sufficiency through work and the
4 following additional outcomes:

5 (a) Recipients' economic status is improving through wage
6 progression, job retention, and educational advancement;

7 (b) Recipients' status regarding housing stability, medical and
8 behavioral health, and job readiness is improving;

9 (c) The well-being of children whose caretaker is receiving
10 benefits on their behalf is improving with respect to child welfare
11 and educational achievement.

12 (2)(a) The department shall create a budget structure that allows
13 for more transparent tracking of program spending. The budget
14 structure shall outline spending for the following: Temporary
15 assistance for needy family grants, working connections child care,
16 WorkFirst activities and administration of the program.

17 (b) Each biennium, the department shall establish a biennial
18 spending plan, using the budget structure created in (a) of this
19 subsection, for this program and submit the plan to the legislative
20 fiscal committees and the legislative-executive WorkFirst oversight
21 task force no later than July 1st of every odd-numbered year,
22 beginning on July 1, 2013. The department shall update the
23 legislative fiscal committees and the task force on the spending plan
24 if modifications are made to the plan previously submitted to the
25 legislature and the task force for that biennium.

26 (c) The department also shall provide expenditure reports to the
27 fiscal committees of the legislature and the legislative-executive
28 WorkFirst oversight task force beginning September 1, 2012, and on a
29 quarterly basis thereafter. If the department determines, based upon
30 quarterly expenditure reports, that expenditures will exceed funding
31 at the end of the fiscal year, the department shall take those
32 actions necessary to ensure that services provided under this chapter
33 are available only to the extent of and consistent with
34 appropriations in the operating budget and policy established by the
35 legislature following notification provided in (b) of this
36 subsection.

37 (3) No more than fifteen percent of the temporary assistance for
38 needy families block grant, the federal child care funds, and
39 qualifying state expenditures may be spent for administrative
40 purposes. For purposes of this subsection, "administrative purposes"

1 does not include expenditures for information technology and
2 computerization needed for tracking and monitoring required by P.L.
3 104-193.

4 (4) The department shall expend funds appropriated for work
5 activities, as defined in RCW 74.08A.250, or for other services
6 provided to WorkFirst recipients, as authorized under RCW 74.08A.290.
7 The vocational education training work activity, as defined in RCW
8 74.08A.250, is subject to the availability of amounts appropriated
9 for this purpose.

10 NEW SECTION. **Sec. 3.** The definition of "work activity" related
11 to the length of vocational educational training a WorkFirst
12 participant may receive as established under section 1 of this act
13 shall be terminated on August 1, 2019, as provided in section 4 of
14 this act.

15 NEW SECTION. **Sec. 4.** The following acts or parts of acts, as
16 now existing or hereafter amended, are each repealed, effective
17 August 1, 2020:
