## HOUSE BILL 2006

State of Washington 64th Legislature 2015 Regular Session

- 1 AN ACT Relating to a model policy and procedures for language 2 access by limited-English proficient parents of students; amending
- 3 RCW 28A.300.580; adding a new section to chapter 28A.320 RCW; and
- 4 repealing RCW 28A.345.032.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. A new section is added to chapter 28A.320 RCW to read as follows:
- 8 (1) By July 1, 2016, the Washington state school directors'
- 9 association, with the assistance of the office of the superintendent
- 10 of public instruction, shall develop a model policy and procedures
- 11 for language access by limited-English proficient parents. In
- 12 developing the model policy and procedures, the school directors'
- 13 association shall consider any guidance materials created by the
- 14 United States department of justice regarding how school districts
- 15 can effectively assess their language access needs and how to develop
- 16 appropriately tailored language access plans. The model policy and
- 17 procedures must at a minimum address:
- 18 (a) Guidance and procedures for timely and accurate
- 19 identification of limited-English proficient parents and guardians
- 20 and their language access needs;

1 (b) A recommended process and procedures for when and how to access an interpreter;

- (c) A prohibition on the use of students or children as interpreters for school-related communications;
- (d) Procedures to ensure appropriate staff are aware of parents' or guardians' need for language assistance, including guidance for all school administrators, teachers, and other appropriate staff regarding when and how to access an interpreter or translation services in a timely manner;
- (e) A process for communicating with parents and guardians about their rights under federal and state law to be provided with accessible information that allows them to make informed choices regarding their child's education and how to access the resources and services available to them.
- (2) Beginning July 1, 2016, the office of the superintendent of public instruction shall convene an advisory committee with representatives of parents, school administrators, school principals, classified and certificated staff, and other appropriate parties with interest in language access for limited-English parents to develop sample materials for school districts to disseminate to both school employees and parents regarding parents' rights under the model policy developed by the Washington state school directors' association and the resources available to assist parents and guardians in accessing the services available to them.
- (3) The school directors' association shall post the model policy and procedures developed under subsection (1) of this section and a link to the sample materials developed by the advisory committee under subsection (2) of this section on its web site.
- (4) Each school district board of directors shall establish its own language access policy and procedures by January 1, 2017, and shall make the policy and procedures available on the district's web site. The language access policy and procedures adopted by each school district shall at a minimum include the five minimum requirements found in subsection (1) of this section.
- (a) Each school district that does not adopt the model policy, procedures, and sample materials posted by the Washington state school directors' association shall provide to the office of the superintendent of public instruction a brief summary of its policies, procedures, and materials developed under subsections (1) and (2) of this section including a summary of the differences as compared to

the model policy, procedures, and sample materials and must also document that the minimum requirements established in subsection (1) of this section have been met. Each school district shall also provide the superintendent with a link to the school district's web site for further information.

- (b) Each school district that has adopted the model policy, procedures, and sample materials posted by the Washington state school directors' association shall notify the office of the superintendent of public instruction of such adoption and the link to the school district's web site where the policy is posted.
- 11 (c) The office of the superintendent of public instruction shall 12 maintain and have available upon request a list of school districts 13 that have adopted the Washington state school directors' 14 association's model policy and those that have not.
- 15 (5) The office of the superintendent of public instruction shall 16 adopt rules regarding school districts' communication of the language 17 access policy and procedure to parents, students, employees, and 18 volunteers.
- 19 **Sec. 2.** RCW 28A.300.580 and 2014 c 150 s 4 are each amended to 20 read as follows:
  - (1) The office of the superintendent of public instruction and the office of the education ombuds shall <u>develop a list of and</u> post information on the agency's web site regarding:
- 24 <u>(a) Language access services providers available to school</u>
  25 <u>districts, including but not limited to,</u> the phone interpretation
  26 vendors on contract with the state of Washington, including contact
  27 information; and
- 28 <u>(b) Training programs that are available to support school</u>
  29 <u>districts in preparing employees for how to access and effectively</u>
  30 <u>use an interpreter</u>.
- 31 (2) The list created under subsection (1) of this section shall
  32 be updated and sent to all school districts annually. School
  33 districts shall make this list available to school personnel on an
  34 annual basis.
- 35 <u>(3)</u> School districts are encouraged to use the phone 36 interpretation services addressed in subsection (1) of this section 37 to communicate with student's parents, legal guardians, and family 38 members who have limited English proficiency.
