1 AN ACT Relating to the crime of indecent exposure; amending RCW 2 9A.88.010 and 9.94A.515; and prescribing penalties.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 9A.88.010 and 2003 c 53 s 92 are each amended to 5 read as follows:

6 (1) A person is guilty of indecent exposure if he or she 7 intentionally makes any open and obscene exposure of his or her 8 person or the person of another knowing that such conduct is likely 9 to cause reasonable affront or alarm. The act of breastfeeding or 10 expressing breast milk is not indecent exposure.

11 (2)(a) Except as provided in (b) ((and)), (c), and (d) of this 12 subsection, indecent exposure is a misdemeanor.

(b) Indecent exposure is a gross misdemeanor on the first offense if the person exposes himself or herself to a person under the age of fourteen years.

16 (c) Indecent exposure is a class C felony if the person <u>exposes</u> 17 <u>himself or herself to a person under the age of fourteen years and</u> 18 has previously been convicted under this section, <u>an equivalent</u> 19 <u>municipal ordinance</u>, or of a sex offense as defined in RCW 9.94A.030.
