- AN ACT Relating to making expenditures from the budget stabilization account to make critical investments; adding a new section to chapter 43.79 RCW; making appropriations; and declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. FOR THE LOCAL EFFORT ASSISTANCE TRANSITION 7 ACCOUNT. The sum of \$90,557,000 is appropriated from the budget stabilization account for the fiscal biennium ending June 30, 2017, 8 is provided solely for expenditure into the local effort 9 10 assistance transition account created in chapter . . ., Laws of 2016 11 (Engrossed House Bill No. 2698) for purposes of appropriations for local effort assistance in the 2017-2019 fiscal biennium. It is the 12 13 intent of the legislature that any amounts in the local effort 14 assistance transition account that attributable to are this appropriation and that are not expended for purposes of that account 15 16 be transferred back into the budget stabilization account by June 30, 17 2019.
- NEW SECTION. Sec. 2. FOR THE DEPARTMENT OF NATURAL RESOURCES—
  FIRES. The sum of \$154,966,000 is appropriated from the budget
  stabilization account for the fiscal biennium ending June 30, 2017,

- 1 and is provided solely for fire suppression costs incurred by the
- 2 department of natural resources during the 2015 fire season. Amounts
- 3 provided in this section may not be used to pay for the department's
- 4 indirect and administrative expenses.
- 5 NEW SECTION. Sec. 3. FOR THE DEPARTMENT OF FISH AND WILDLIFE—
- 6 FIRES. The sum of \$344,000 is appropriated from the budget
- 7 stabilization account for the fiscal biennium ending June 30, 2017,
- 8 and is provided solely for the fire suppression costs incurred by the
- 9 department of fish and wildlife during the 2015 fire suppression
- 10 season. Amounts provided in this section may not be used to pay for
- 11 the department's indirect and administrative expenses.
- 12 NEW SECTION. Sec. 4. FOR THE WASHINGTON STATE PATROL—FIRES. The
- 13 sum of \$34,365,000 is appropriated from the budget stabilization
- 14 account for the fiscal biennium ending June 30, 2017, and is provided
- 15 solely for Washington state fire service resource mobilization costs
- 16 incurred in response to an emergency or disaster authorized under RCW
- 17 43.43.960 through 43.43.964.
- 18 NEW SECTION. Sec. 5. FOR THE HOMELESS ASSISTANCE ACCOUNT. The
- 19 sum of \$37,229,000 is appropriated from the budget stabilization
- 20 account for the fiscal biennium ending June 30, 2017, and is provided
- 21 solely for expenditure into the homeless assistance account created
- 22 in section 6 of this act.
- NEW SECTION. Sec. 6. A new section is added to chapter 43.79
- 24 RCW to read as follows:
- 25 HOMELESS ASSISTANCE ACCOUNT CREATED. The homeless assistance
- 26 account is created in the state treasury. Moneys in the account may
- 27 be spent only after appropriation. Moneys in the account may be
- 28 expended only for housing assistance, support services, and other
- 29 purposes to address the state's homeless population.
- 30 NEW SECTION. Sec. 7. This act is necessary for the immediate
- 31 preservation of the public peace, health, or safety, or support of
- 32 the state government and its existing public institutions, and takes
- 33 effect immediately.
