1 AN ACT Relating to the manufacture, sale, distribution, and
2 installation of motor vehicle air bags; amending RCW 46.37.640,
3 46.37.650, 46.37.660, 46.63.020, and 9.94A.515; creating a new
4 section; and prescribing penalties.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 46.37.640 and 2003 c 33 s 1 are each amended to read
7 as follows:

8 (1) "Air bag" means an inflatable restraint system or portion of
9 an inflatable restraint system (~~((installed in a motor vehicle))~~)
10 including, but not limited to, the cushion material, cover, sensors,
11 controllers, inflators, and wiring that (a) operates in the event of
12 a crash and (b) is designed in accordance with federal motor vehicle
13 safety standards for the specific make, model, and year of the motor
14 vehicle in which it is or will be installed.

15 (2) "Previously deployed air bag" means an inflatable restraint
16 system or portion of the system that has been activated or inflated
17 as a result of a collision or other incident involving the vehicle.

18 (3) "Nondeployed salvage air bag" means an inflatable restraint
19 system that has not been previously activated or inflated as a result
20 of a collision or other incident involving the vehicle.

1 (4) "Counterfeit air bag" means a replacement motor vehicle
2 inflatable occupant restraint system, including all component parts
3 including, but not limited to, the cushion material, cover, sensors,
4 controllers, inflators, and wiring, displaying a mark identical or
5 similar to the genuine mark of a motor vehicle manufacturer without
6 authorization from the manufacturer.

7 (5) "Nonfunctional air bag" means a replacement motor vehicle
8 inflatable occupant restraint system, including all component parts
9 including, but not limited to, the cushion material, cover, sensors,
10 controllers, inflators, and wiring, which: (a) Was previously
11 deployed or damaged; (b) has an electric fault that is detected by
12 the vehicle air bag diagnostic system after the installation
13 procedure is completed; or (c) includes any part or object including,
14 but not limited to, a counterfeit or repaired air bag cover,
15 installed in a motor vehicle to mislead the owner or operator of the
16 motor vehicle into believing that a functional air bag has been
17 installed.

18 **Sec. 2.** RCW 46.37.650 and 2011 c 96 s 33 are each amended to
19 read as follows:

20 (1) It is unlawful for a person ((is guilty of a gross
21 misdemeanor if he or she knew or reasonably should have known that an
22 air bag he or she)), with criminal negligence, to manufacture,
23 import, sell, offer for sale, install((s)), or reinstall((s)) a
24 device in a vehicle for compensation, or distribute((s)) as an auto
25 part, or replace a motor vehicle air bag, that: (a) Is a counterfeit
26 air bag, (b) is a nonfunctional air bag, (c) is a previously deployed
27 or damaged air bag that is part of an inflatable restraint system, or
28 (d) otherwise does not meet all applicable federal safety standards
29 for an air bag. This section does not apply to nondeployed salvage
30 air bags that meet the requirements of RCW 46.37.660(1).

31 (2) A person ((found guilty under subsection (1) of this section
32 shall be punished by a fine of not more than five thousand dollars or
33 by confinement in the county jail for up to three hundred sixty-four
34 days, or both)) in violation of this section is guilty of a class C
35 felony if the criminal negligence caused bodily injury as defined in
36 RCW 9A.04.110 or death to another person.

37 (3) A person in violation of this section is guilty of a class C
38 felony, regardless if the criminal negligence caused harm to another.

1 **Sec. 3.** RCW 46.37.660 and 2003 c 33 s 3 are each amended to read
2 as follows:

3 (1)(a) Whenever an air bag that is part of a previously deployed
4 inflatable restraint system is replaced by either a new air bag that
5 is part of an inflatable restraint system or a nondeployed salvage
6 air bag that is part of an inflatable restraint system, the air bag
7 must conform to the original equipment manufacturer requirements and
8 the installer must verify that the self-diagnostic system for the
9 inflatable restraint system indicates that the entire inflatable
10 restraint system is operating properly.

11 (b) A person in violation of this subsection (1) is guilty of a
12 class C felony if the violation caused bodily injury as defined in
13 RCW 9A.04.110 or death to another person.

14 (c) A person in violation of this subsection (1) is guilty of a
15 class C felony, regardless if the violation caused harm to another.

16 (2)(a) No person may sell, install, or reinstall in any motor
17 vehicle any device that causes the vehicle's diagnostic system to
18 inaccurately indicate that the vehicle is equipped with a functional
19 air bag when a counterfeit air bag, a nonfunctional air bag, or no
20 air bag is installed. This subsection does not apply to nondeployed
21 salvage air bags that meet the requirements of subsection (1) of this
22 section.

23 (b) A person in violation of this subsection (2) is guilty of a
24 class C felony if the violation caused bodily injury as defined in
25 RCW 9A.04.110 or death to another person.

26 (c) A person in violation of this subsection (2) is guilty of a
27 class C felony, regardless if the violation caused harm to another.

28 **Sec. 4.** RCW 46.63.020 and 2014 c 124 s 9 are each amended to
29 read as follows:

30 Failure to perform any act required or the performance of any act
31 prohibited by this title or an equivalent administrative regulation
32 or local law, ordinance, regulation, or resolution relating to
