1 AN ACT Relating to short-barreled rifles; and amending RCW 2 9.41.190.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 9.41.190 and 2014 c 201 s 1 are each amended to read 5 as follows:

6 (1) Except as otherwise provided in this section, it is unlawful 7 for any person to:

8 <u>(a) Manufacture</u>, own, buy, sell, loan, furnish, transport, or 9 have in possession or under control, any machine gun, short-barreled 10 shotgun, or short-barreled rifle; ((or))

11 (b) Manufacture, own, buy, sell, loan, furnish, transport, 12 repair, or have in possession or under control, any part designed and 13 intended solely and exclusively for use in a machine gun, short-14 barreled shotgun, or short-barreled rifle, or in converting a weapon 15 into a machine gun, short-barreled shotgun, or short-barreled rifle; 16 or ((to))

<u>(c) A</u>ssemble or repair any machine gun, short-barreled shotgun,
or short-barreled rifle.

19 (2) It is not unlawful for a person to ((possess, transport, 20 acquire, or transfer a short-barreled rifle that is legally 21 registered and possessed, transported, acquired, or transferred in

1 accordance)) manufacture, own, buy, sell, loan, furnish, transport, 2 repair, or have in possession or under control, a short-barreled 3 rifle, or any part designed or intended solely and exclusively for 4 use in a short-barreled rifle or in converting a weapon into a short-5 barreled rifle, if the person is in compliance with applicable 6 federal law.

(3) Subsection (1) of this section shall not apply to:

8 (a) Any peace officer in the discharge of official duty or 9 traveling to or from official duty, or to any officer or member of 10 the armed forces of the United States or the state of Washington in 11 the discharge of official duty or traveling to or from official duty; 12 or

(b) A person, including an employee of such person if the employee has undergone fingerprinting and a background check, who or which is exempt from or licensed under federal law, and engaged in the production, manufacture, repair, or testing of machine guns, short-barreled shotguns, or short-barreled rifles:

18 (i) To be used or purchased by the armed forces of the United19 States;

20 (ii) To be used or purchased by federal, state, county, or 21 municipal law enforcement agencies; or

(iii) For exportation <u>and sale in state</u> in compliance with all
applicable federal laws and regulations.

(4) It shall be an affirmative defense to a prosecution brought under this section that the machine gun or short-barreled shotgun was acquired prior to July 1, 1994, and is possessed in compliance with federal law.

28 (5) Any person violating this section is guilty of a class C 29 felony.
