1 AN ACT Relating to including Everett Community College as an
2 aerospace training or educational program; and amending RCW
3 28B.122.010.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 28B.122.010 and 2012 c 50 s 4 are each amended to
6 read as follows:

7 The definitions in this section apply throughout this chapter
8 unless the context clearly requires otherwise.

9 (1) "Aerospace training or educational program" means a course in
10 the aerospace industry offered by the Washington aerospace training
11 and research center, the Spokane aerospace technology center, ((~~or~~))
12 Renton technical college, or Everett Community College.

13 (2) "Eligible student" means a student who is registered for an
14 aerospace training or educational program, is making satisfactory
15 progress as defined by the program, and has a declared intention to
16 work in the aerospace industry in the state of Washington.

17 (3) "Office" means the office of student financial assistance.

18 (4) "Participant" means an eligible student who has received an
19 aerospace training student loan.

20 (5) "Student loan" means a loan that is approved by the office
21 and awarded to an eligible student.
