AN ACT Relating to extending the expiration date of the habitat and recreation lands coordinating group; amending RCW 79A.25.260; and providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 79A.25.260 and 2012 c 128 s 1 are each amended to 6 read as follows:

7 The habitat and recreation lands coordinating group (1)is established. The group must include representatives from the office, 8 9 the state parks and recreation commission, the department of natural resources, and the department of fish and wildlife. The members of 10 11 the group must have subject matter expertise with the issues 12 presented in this section. Representatives from appropriate 13 stakeholder organizations and local government must also be 14 considered for participation on the group, but may only be appointed or invited by the director. 15

16 (2) To ensure timely completion of the duties assigned to the 17 group, the director shall submit yearly progress reports to the 18 office of financial management.

19 (3) The group must:

1 (a) Review agency land acquisition and disposal plans and 2 policies to help ensure statewide coordination of habitat and 3 recreation land acquisitions and disposals;

4 (b) Produce an interagency, statewide biennial forecast of
5 habitat and recreation land acquisition and disposal plans;

6 (c) Establish procedures for publishing the biennial forecast of
7 acquisition and disposal plans on web sites or other centralized,
8 easily accessible formats;

9 (d) Develop and convene an annual forum for agencies to 10 coordinate their near-term acquisition and disposal plans;

11 (e) Develop a recommended method for interagency geographic 12 information system-based documentation of habitat and recreation 13 lands in cooperation with other state agencies using geographic 14 information systems;

(f) Develop recommendations for standardization of acquisition and disposal recordkeeping, including identifying a preferred process for centralizing acquisition data;

18 (g) Develop an approach for monitoring the success of 19 acquisitions;

(h) Identify and commence a dialogue with key state and federal
 partners to develop an inventory of potential public lands for
 transfer into habitat and recreation land management status; and

(i) Review existing and proposed habitat conservation plans on aregular basis to foster statewide coordination and save costs.

(4) If prioritization among the various requirements of subsection (3) of this section is necessary due to the availability of resources, the group shall prioritize implementation of subsection (3)(a) through (d) and (g) of this section.

(5) The group shall revisit the planning requirements of relevant grant programs administered by the office to determine whether coordination of state agency habitat and recreation land acquisition and disposal could be improved by modifying those requirements.

33 (6) The group must develop options for centralizing coordination 34 of habitat and recreation land acquisition made with funds from 35 federal grants. The advantages and drawbacks of the following 36 options, at a minimum, must be developed:

37 (a) Requiring that agencies provide early communication on the
 38 status of federal grant applications to the office, the office of
 39 financial management, or directly to the legislature;

(b) Establishing a centralized pass-through agency for federal
 funds, where individual agencies would be the primary applicants.

3 (7) This section expires July 31, ((2017)) 2027. Prior to January 4 1, ((2017)) 2027, the group shall make a formal recommendation to the 5 board and the appropriate committees of the legislature as to whether 6 the existence of the habitat and recreation lands coordinating group 7 should be continued beyond July 31, ((2017)) 2027, and if so, whether 8 any modifications to its enabling statute should be pursued.
