- 1 AN ACT Relating to the capitol furnishings preservation 2 committee; and amending RCW 27.48.040.
- Z Committee, and amending RCW 27.46.040
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 27.48.040 and 1999 c 343 s 2 are each amended to read as follows:
- 6 (1) Unless the context clearly requires otherwise, the 7 definitions in this ((section))subsection apply throughout this 8 section.
- 9 (a) "State capitol group" includes the legislative building, the 10 insurance building, the Cherberg building, the John L. O'Brien 11 building, the Newhouse building, ((and))the Pritchard building, and 12 the temple of justice building. "State capitol group" also includes 13 the general administration building if the building is repurposed to
- 14 serve a different function or substantially remodeled.
- 15 (b) "Historic furnishings" means furniture, fixtures, and artwork 16 fifty years of age or older.
- 17 (2) The capitol furnishings preservation committee is established to:
- 19 (a) Promote and encourage the recovery and preservation of the 20 original and historic furnishings of the state capitol group( $(\tau)$ );
- 21 (b) Prevent future loss of historic furnishings( $(\tau)$ ); and

- (c) Review and advise future remodeling and restoration projects as they pertain to historic furnishings. The committee's authority does not extend to the placement of any historic furnishings within the state capitol group.
- (3) The capitol furnishings preservation committee account is created in the custody of the state treasurer. All receipts designated for the account from appropriations and from other sources must be deposited into the account. Expenditures from the account may be used only to finance the activities of the capitol furnishings preservation committee. Only the director of the Washington state historical society or the director's designee may authorize expenditures from the account when authorized to do so by the committee. The account is subject to allotment procedures under chapter 43.88 RCW, but an appropriation is not required for expenditures.
  - (4) The committee may:

- (a) Authorize the director of the Washington state historical society or the director's designee to expend funds from the capitol furnishings preservation committee account for limited purposes of purchasing and preserving historic furnishings of the state capitol group;
- (b) Accept monetary donations, grants, and donations of historic furnishings from, but not limited to, (i) current and former legislators, state officials, and lobbyists; (ii) the families of former legislators, state officials, and lobbyists; and (iii) the general public. Moneys received under this section must be deposited in the capitol furnishings preservation committee account; ((and))
- (c) Engage in or encourage fund-raising activities including ((the solicitation of))soliciting charitable gifts, grants, or donations specifically for the limited purpose of the recovery of the original and historic furnishings; and
- (d) Engage in interpretive and educational activities, including
   displaying historic furnishings.
  - (5) The membership of the committee shall include:
- 35 <u>(a)</u> Two members of the house of representatives, one from each 36 major caucus, appointed by the speaker of the house of 37 representatives;
- 38 <u>(b) T</u>wo members of the senate, one from each major caucus, 39 appointed by the president of the senate;

- 1 <u>(c)</u> The chief clerk of the house of representatives <u>or the chief</u> 2 <u>clerk's designee</u>;
  - (d) The secretary of the senate or the secretary's designee;
  - (e) The governor or the governor's designee;

- 5 <u>(f)</u> The lieutenant governor or the lieutenant governor's 6 designee;
- 7 (g) A representative from the office of the secretary of state, 8 the office of the state treasurer, the office of the state auditor, 9 and the office of the insurance commissioner;
  - (h) A representative from the supreme court;
- 11 <u>(i) A representative from the Washington state historical</u>
  12 society, the department of ((general administration))enterprise
  13 <u>services</u>, and the Thurston ((county))regional planning council, each
  14 appointed by the governor; and
  - ((three))(j) Six private citizens, appointed by the governor.
- 16 (6) Original or historic furnishings from the state capitol group 17 are not surplus property under chapter 43.19 RCW or other authority 18 unless designated as such by the committee.
